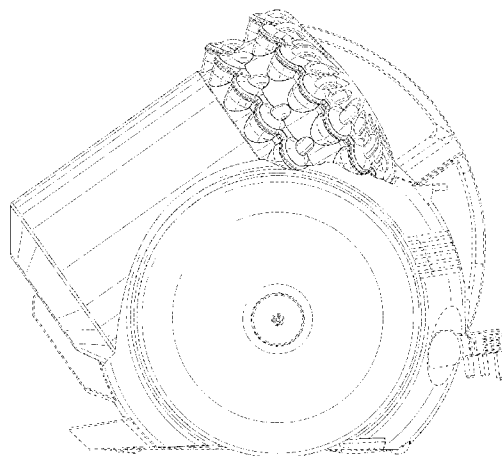
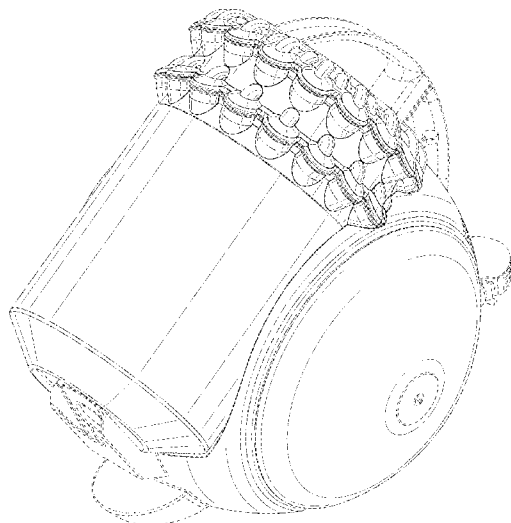
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a part of a vacuum cleaner showing our new design;

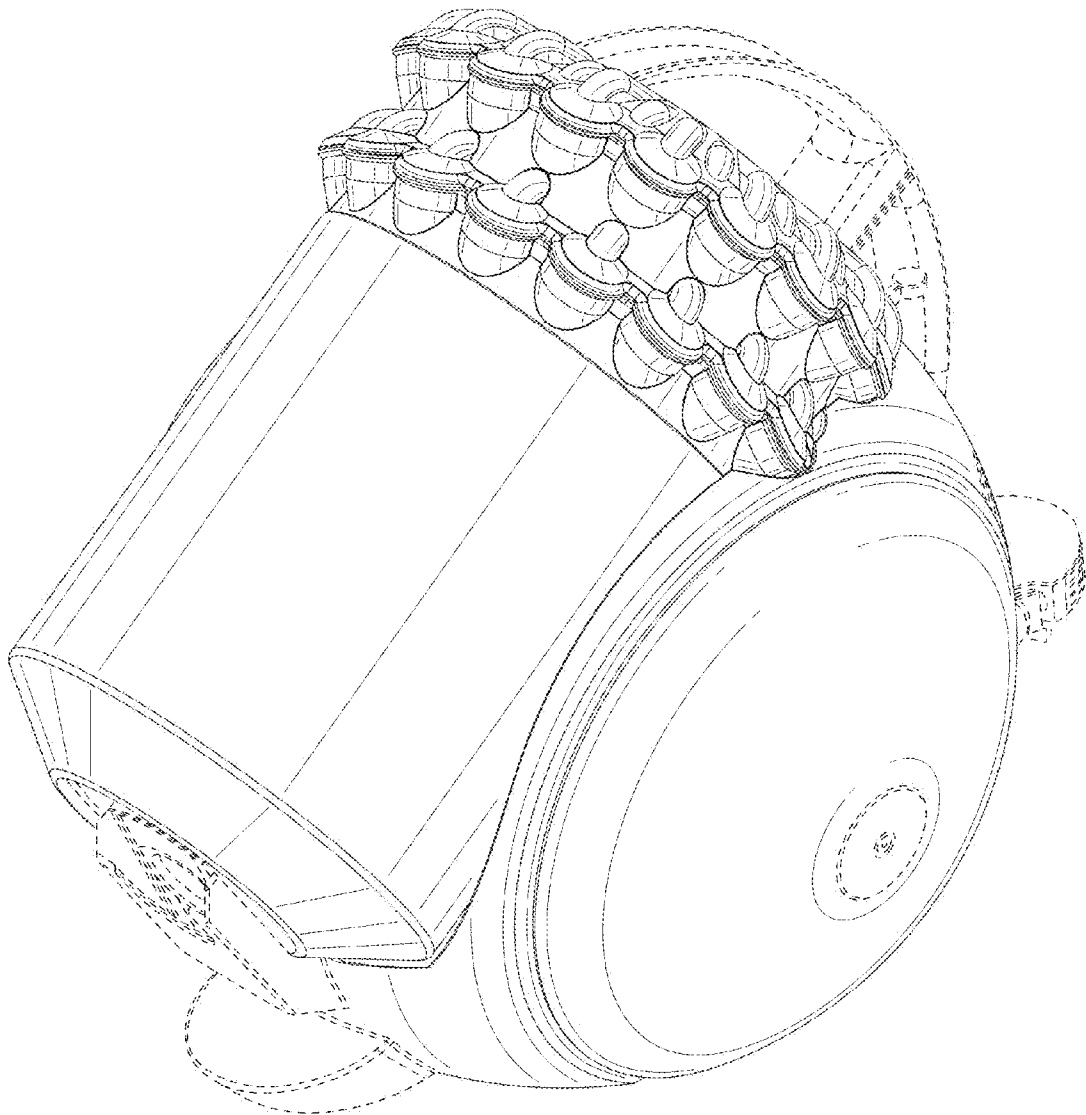

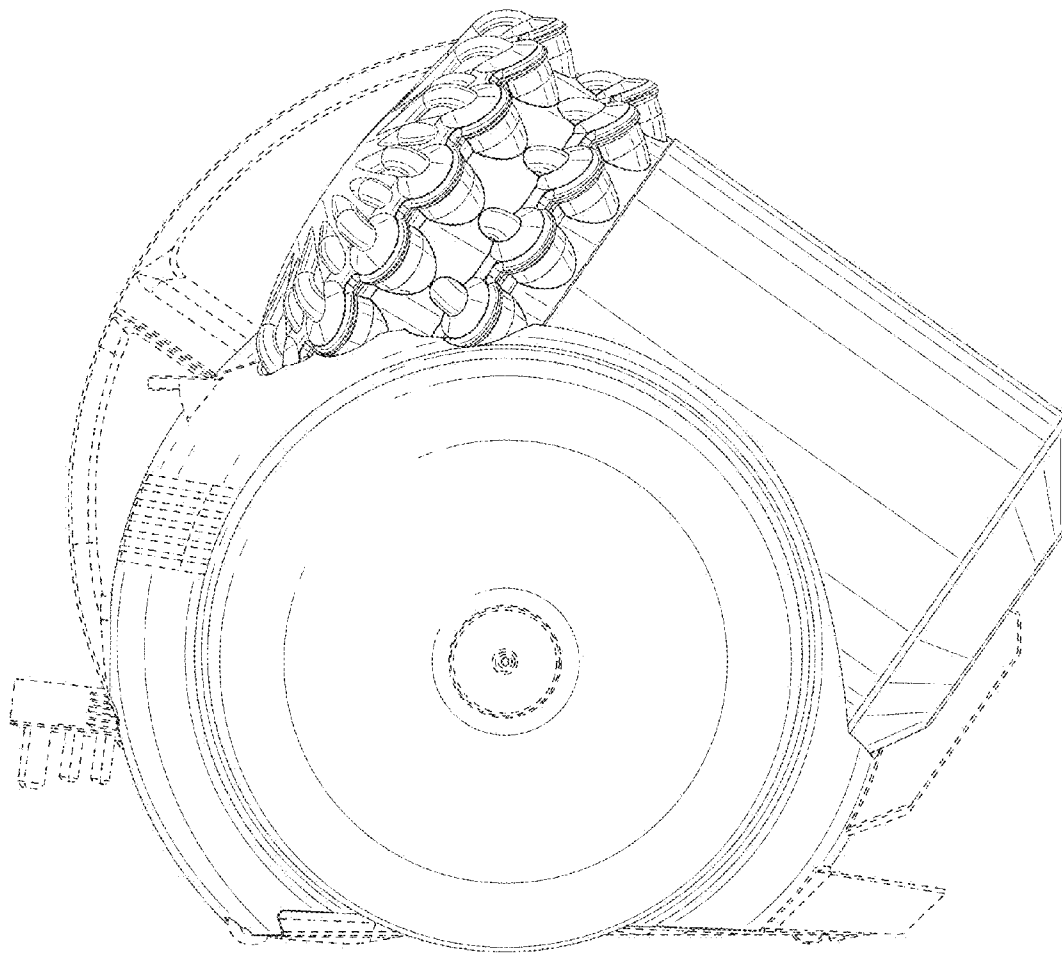

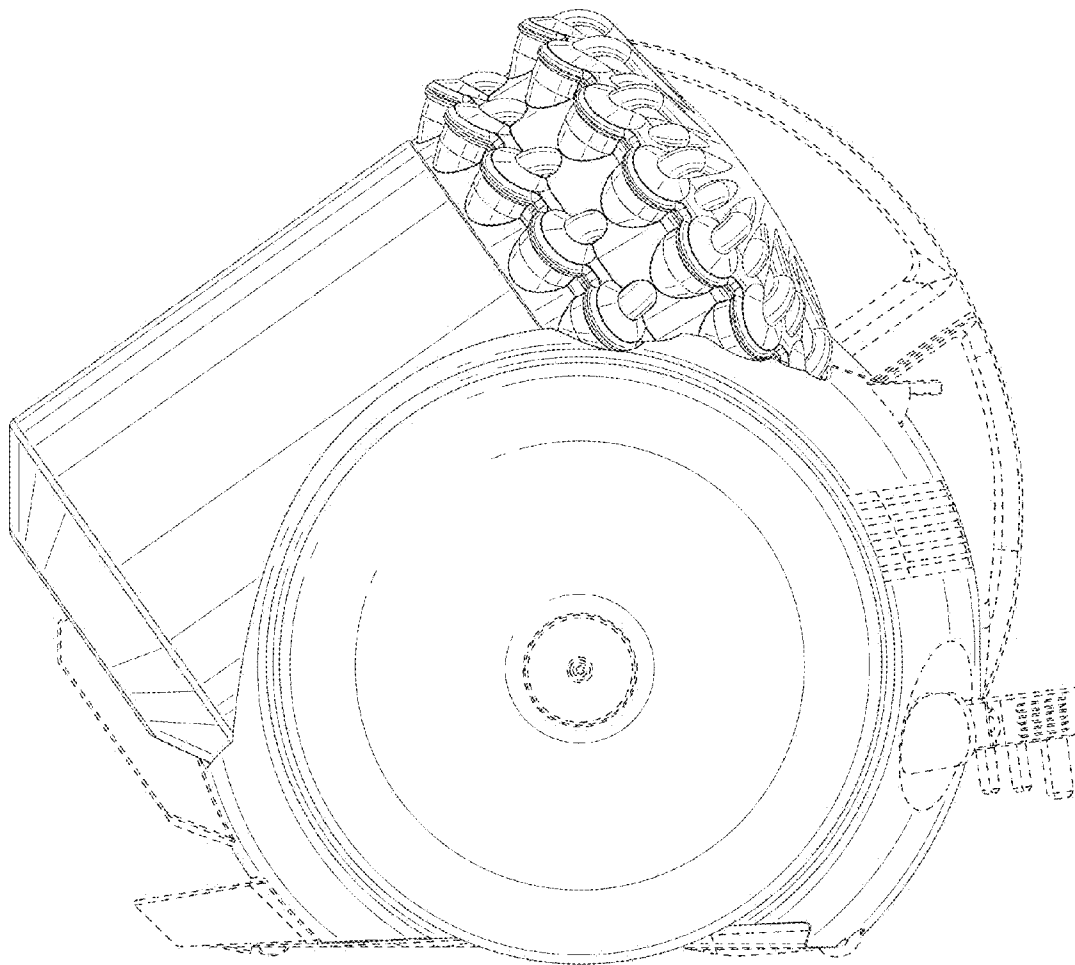

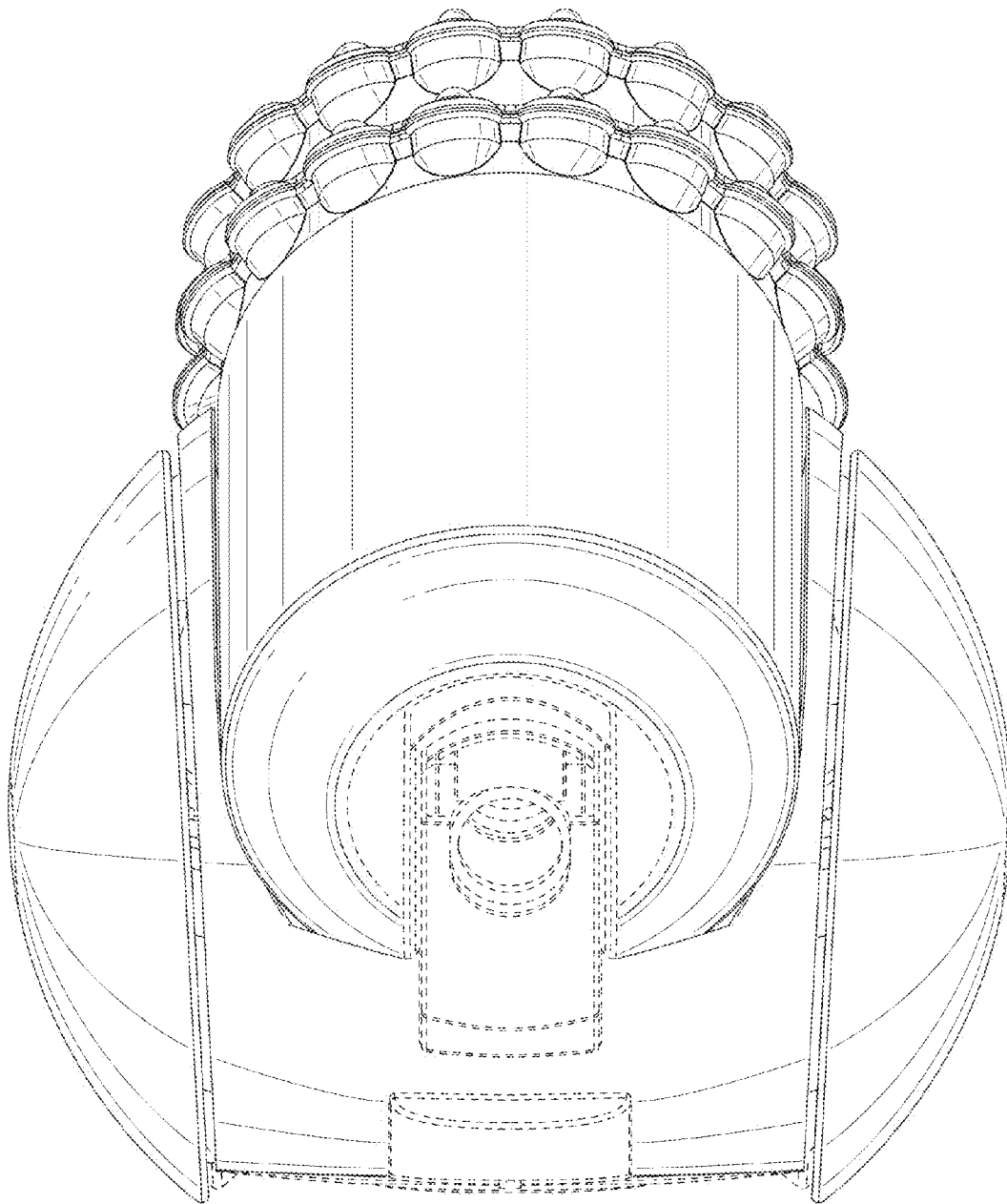

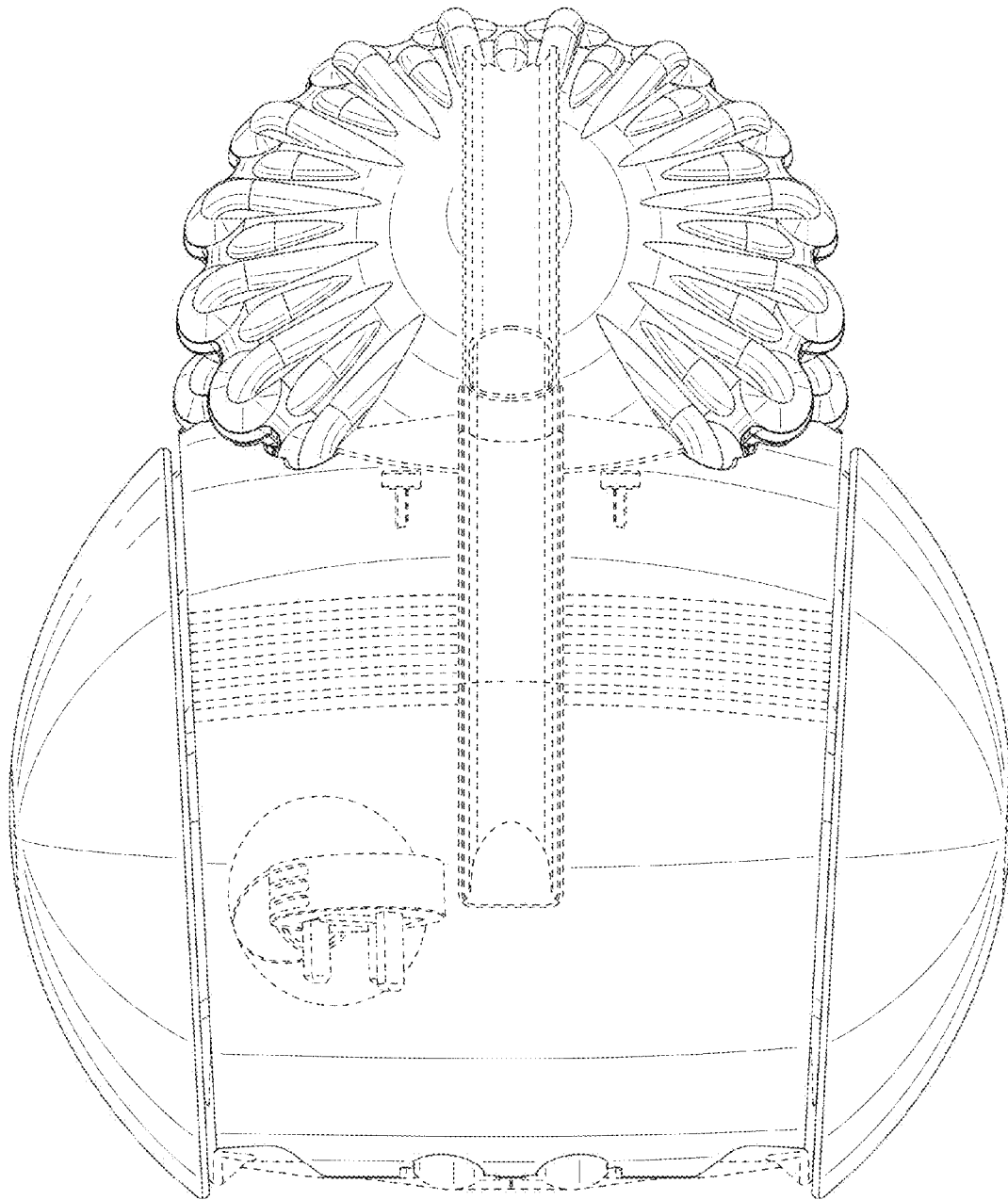

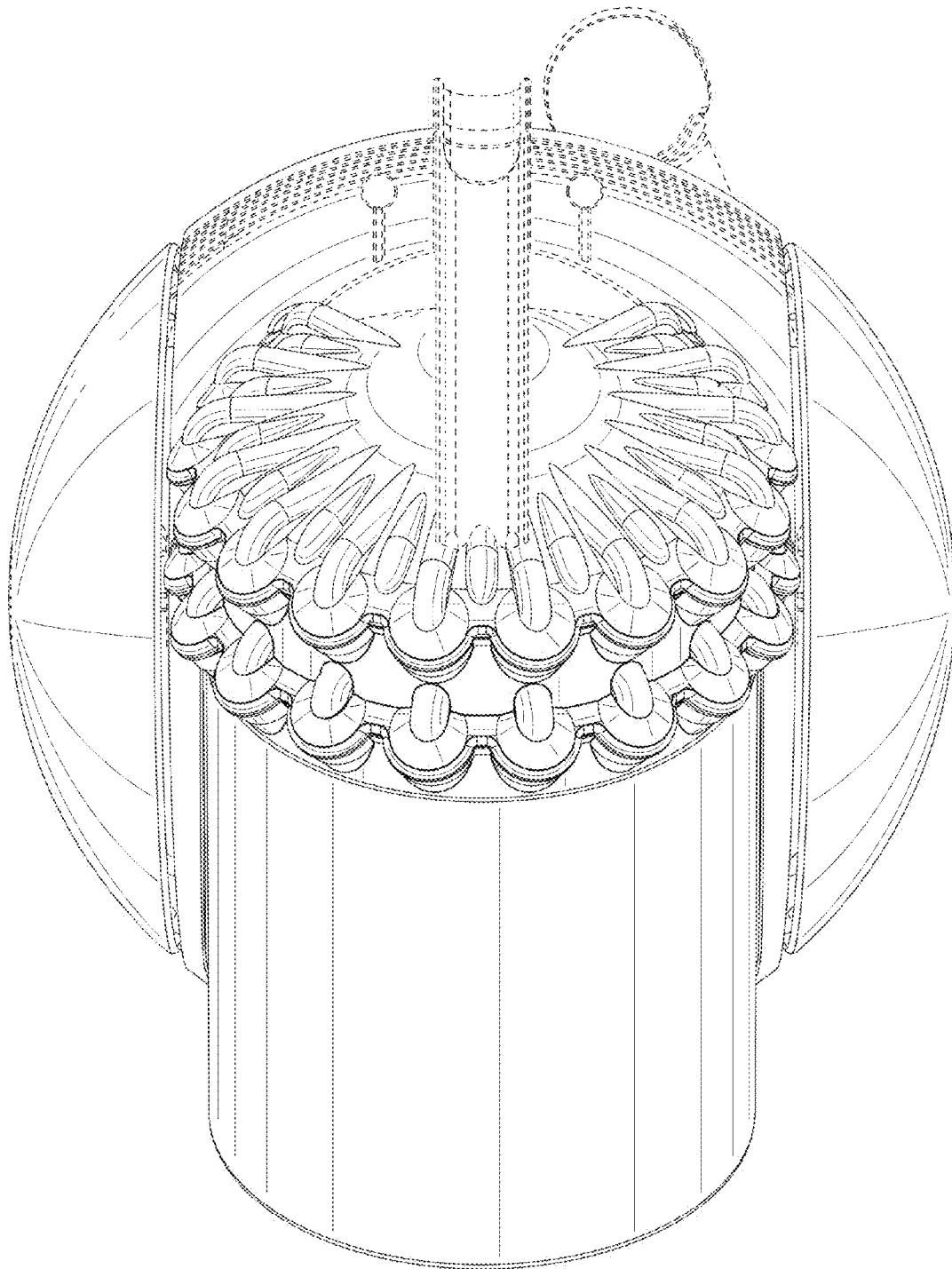

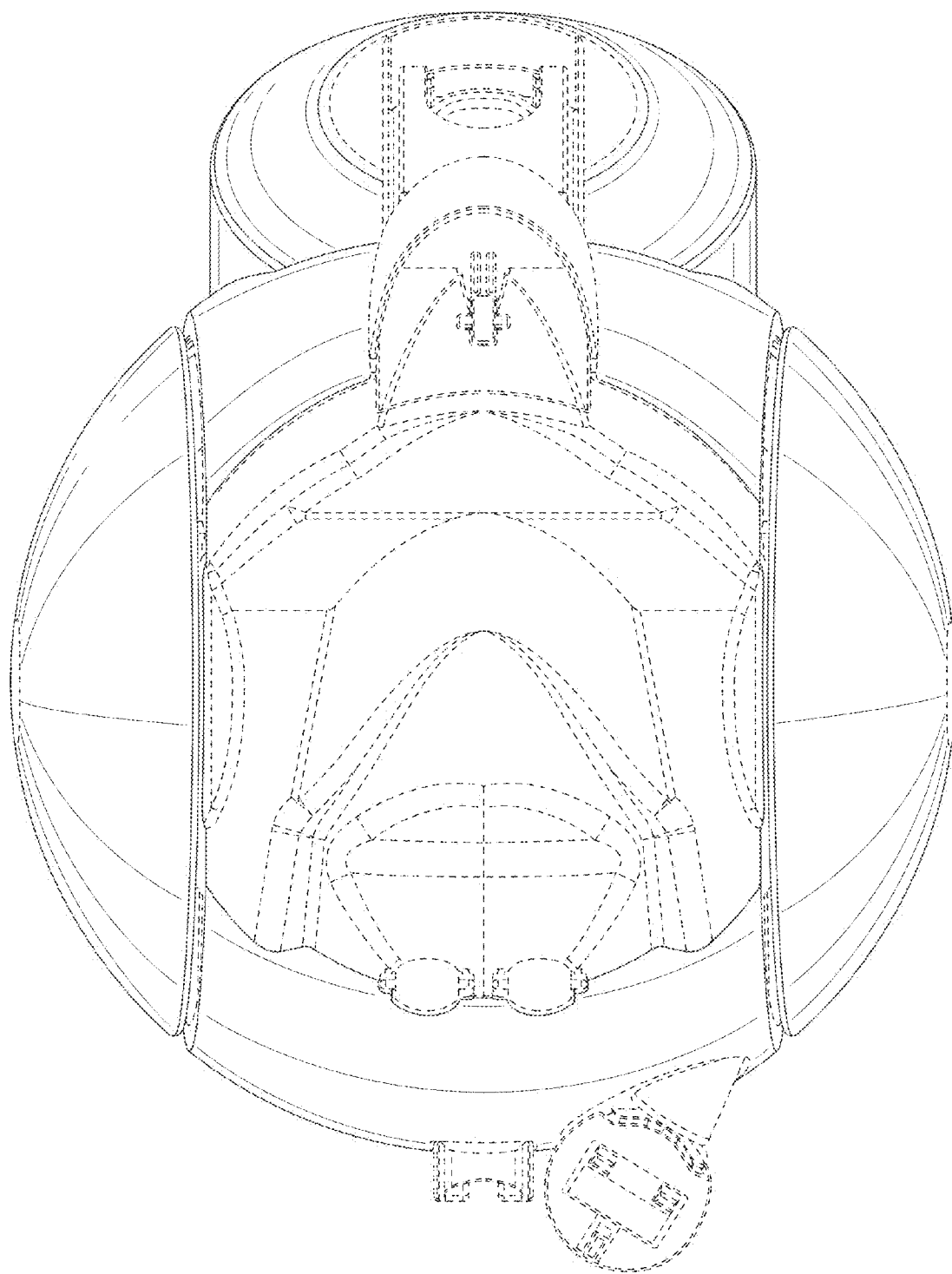
