CLAIM

The ornamental design for a horticulture grow light, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a horticulture grow light, as viewed from below, showing my new design;

FIG. 2 is a perspective view of the light shown in FIG. 1, as viewed from above;

FIG. 3 is a left side view of the light shown in FIG. 1;

FIG. 4 is a right side view of the light shown in FIG. 1;

FIG. 5 is a front elevation view of the light shown in FIG. 1;

FIG. 6 is a rear elevation view of the light shown in FIG. 1; FIG. 7 is a bottom plan view of the light shown in FIG. 1; FIG. 8 is a top plan view of the light shown in FIG. 1; FIG. 9 is a partial bottom plan view of the light as shown in FIGS. 1 and 7, showing a reflector portion of such light, with corner sections dash-lined for a smooth mirror reflective surface, and with central portions stippled for a non-smooth textured reflective surface;

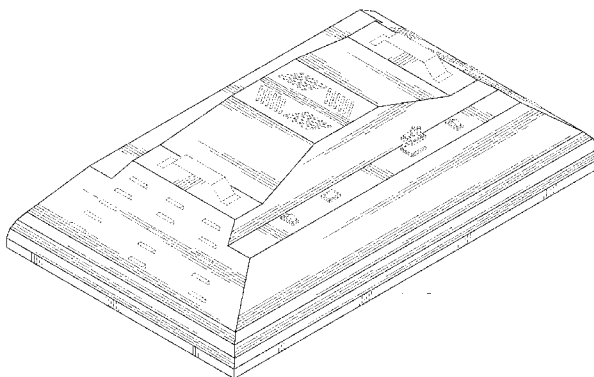
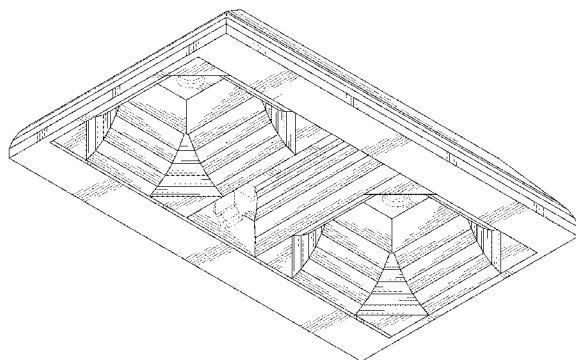
FIG. 10 is a partial bottom plan view of the light as shown in FIGS. 1 and 7, showing a reflector portion of such light, with corner sections stippled for a non-smooth textured reflective surface, and with central portions dash-lined for a smooth mirror reflective surface;

FIG. 11 is a partial bottom plan view of the light as shown in FIGS. 1 and 7, showing a reflector portion of such light, with corner sections single cross-hatched for a contrasted reflective surface, and with central portions double-triple cross-hatched for a reflective surface; and,

FIG. 12 is a partial bottom plan view of the light as shown in FIGS. 1 and 7, showing a reflector portion of such light, with dash-lined for a smooth mirror reflective surface.

The broken-line disclosure shown in the views is understood to represent portions of the article in which the claimed design is embodied, but which form no part of the claimed design.

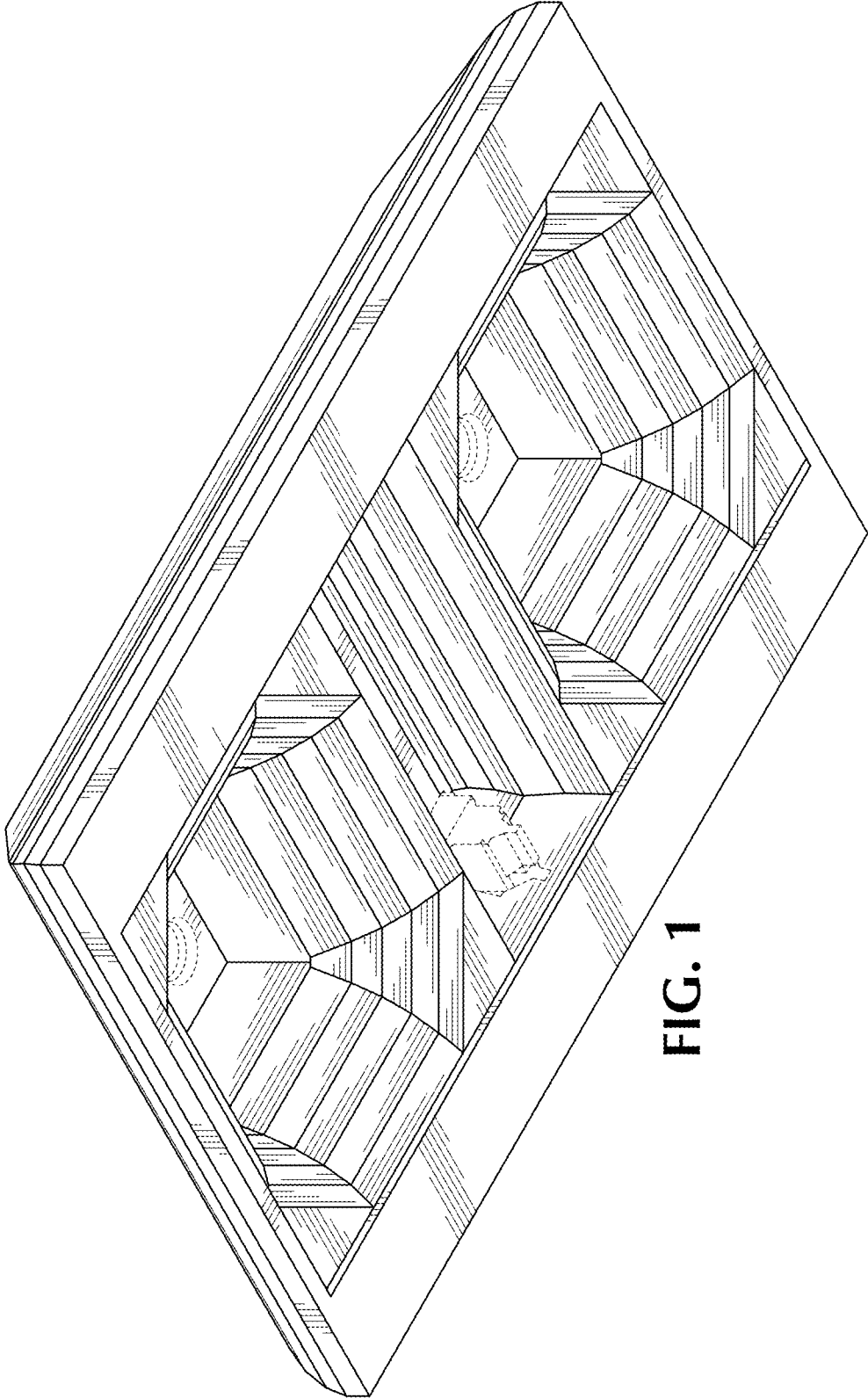

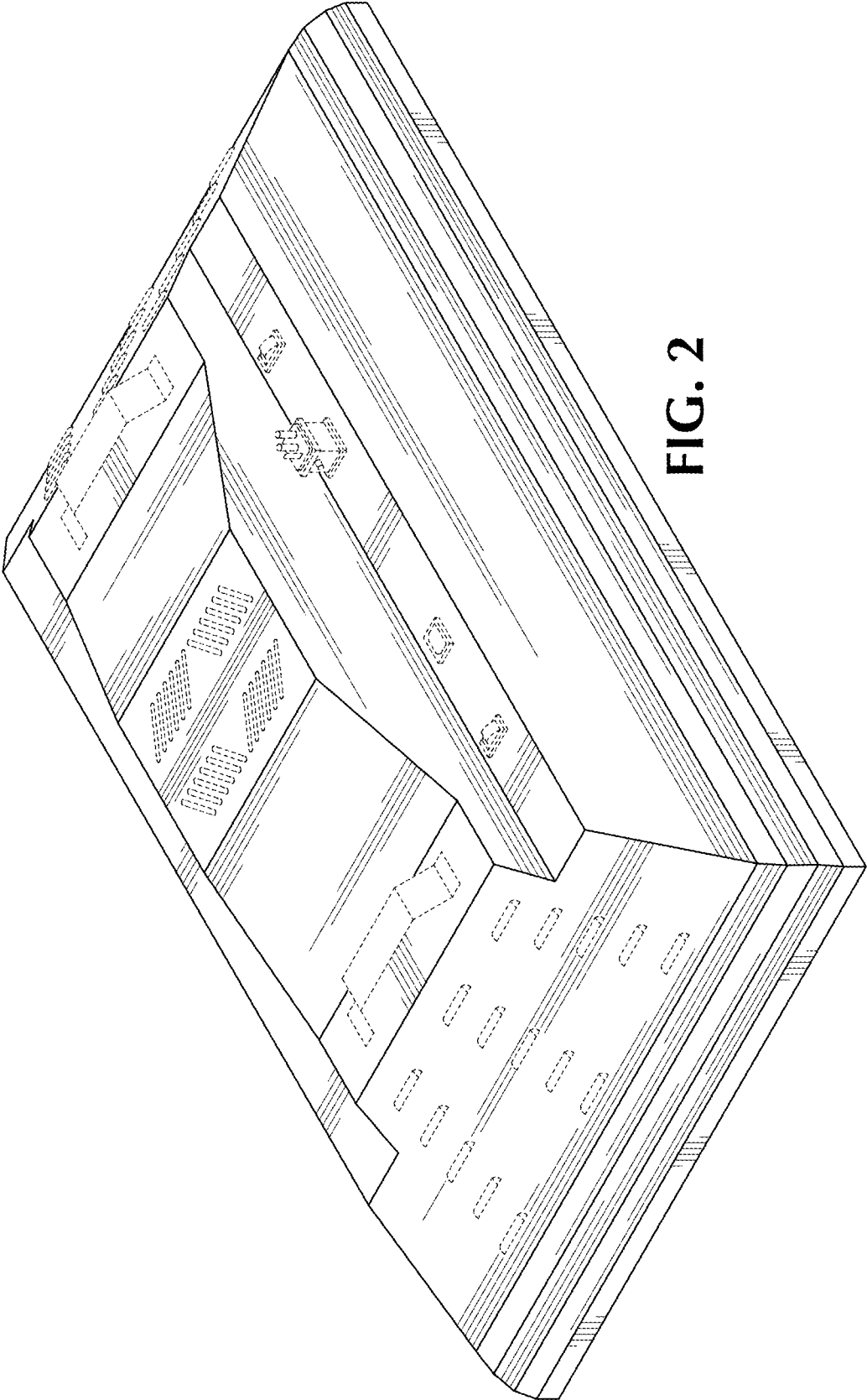

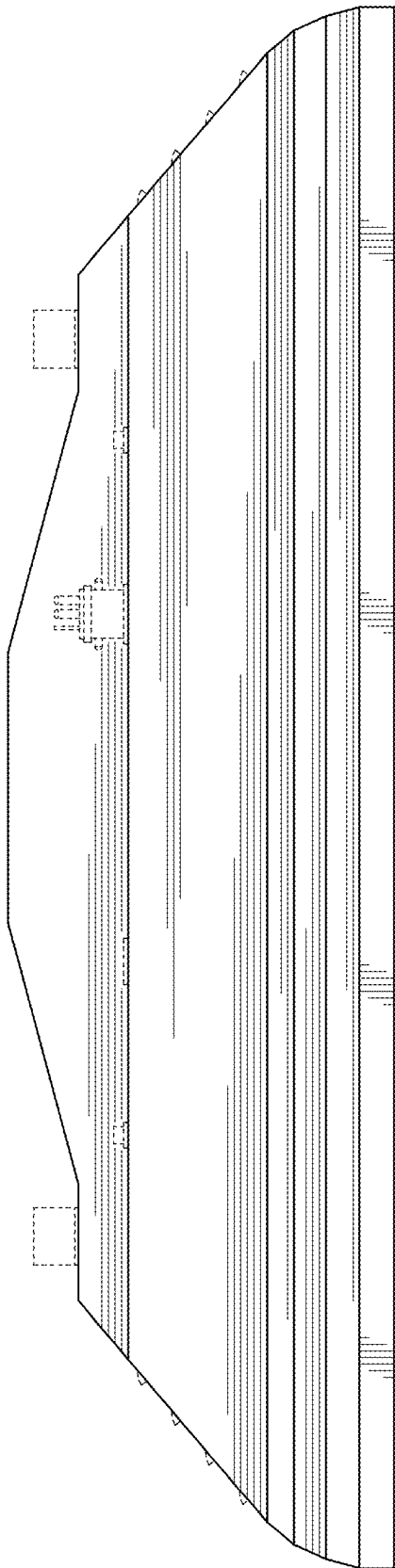

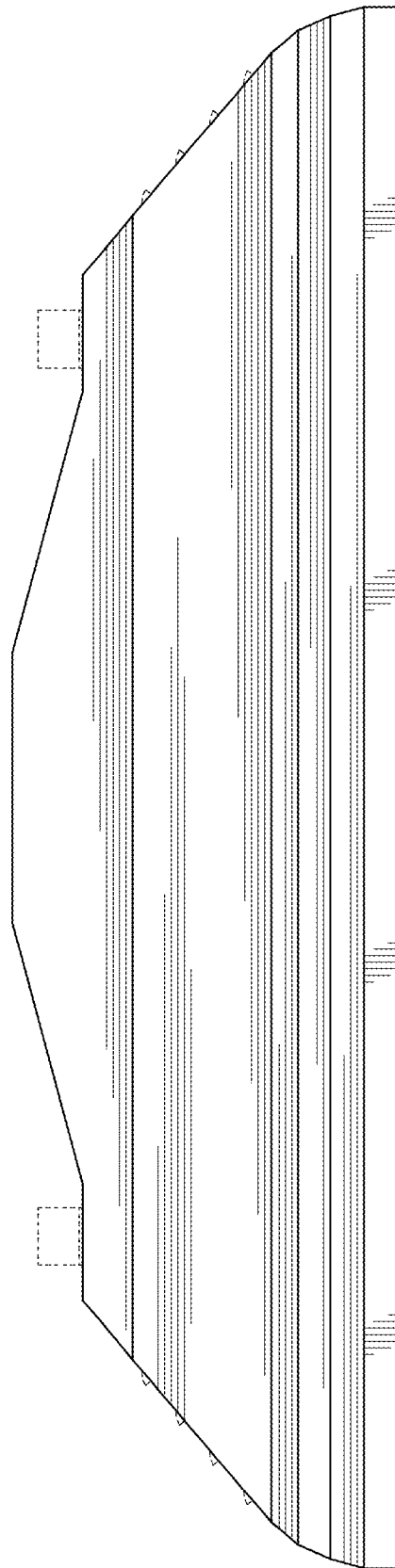

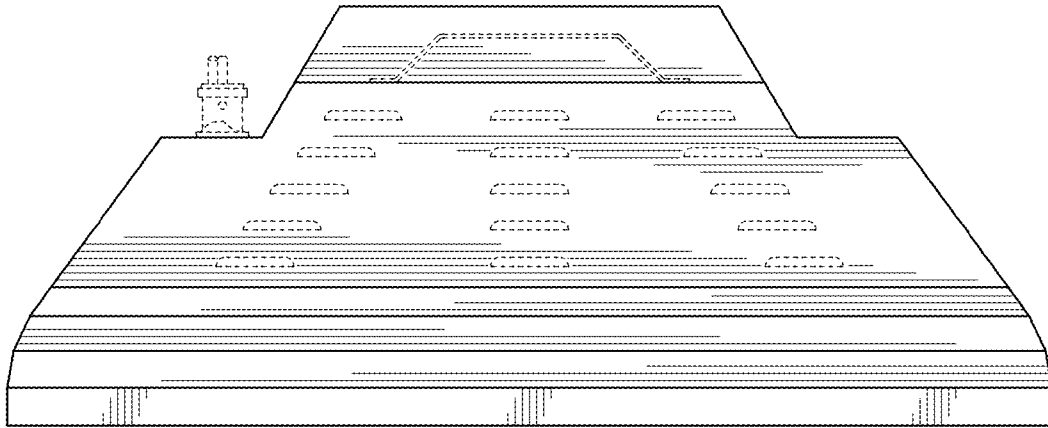

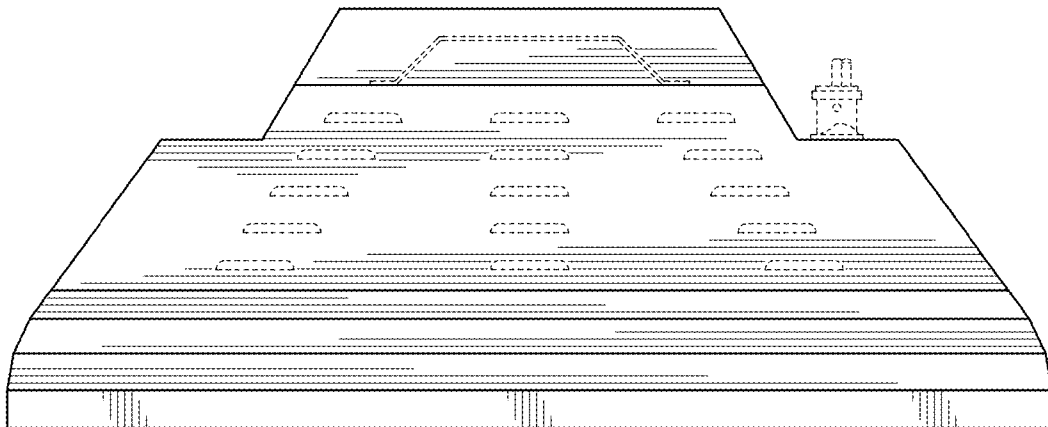

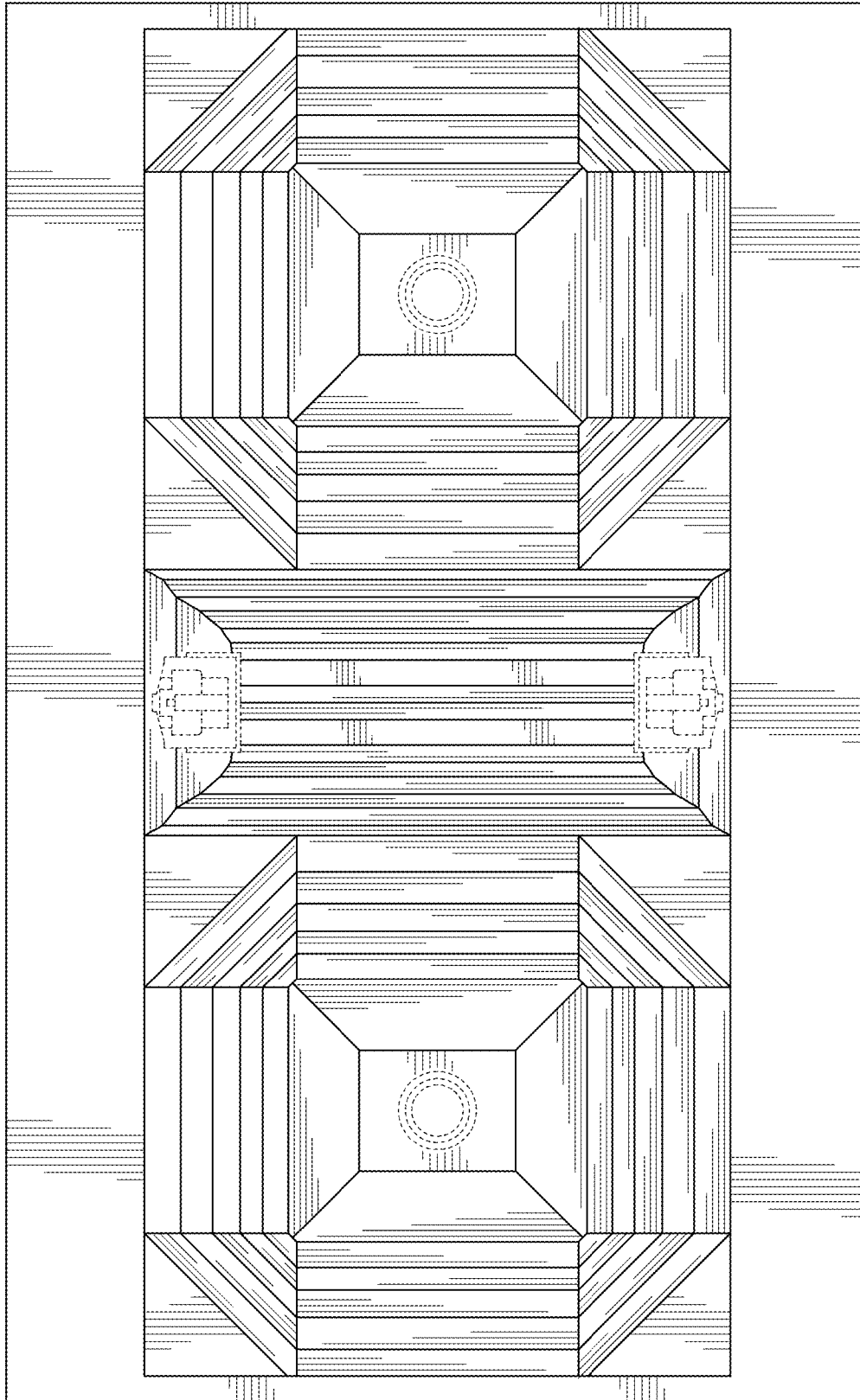

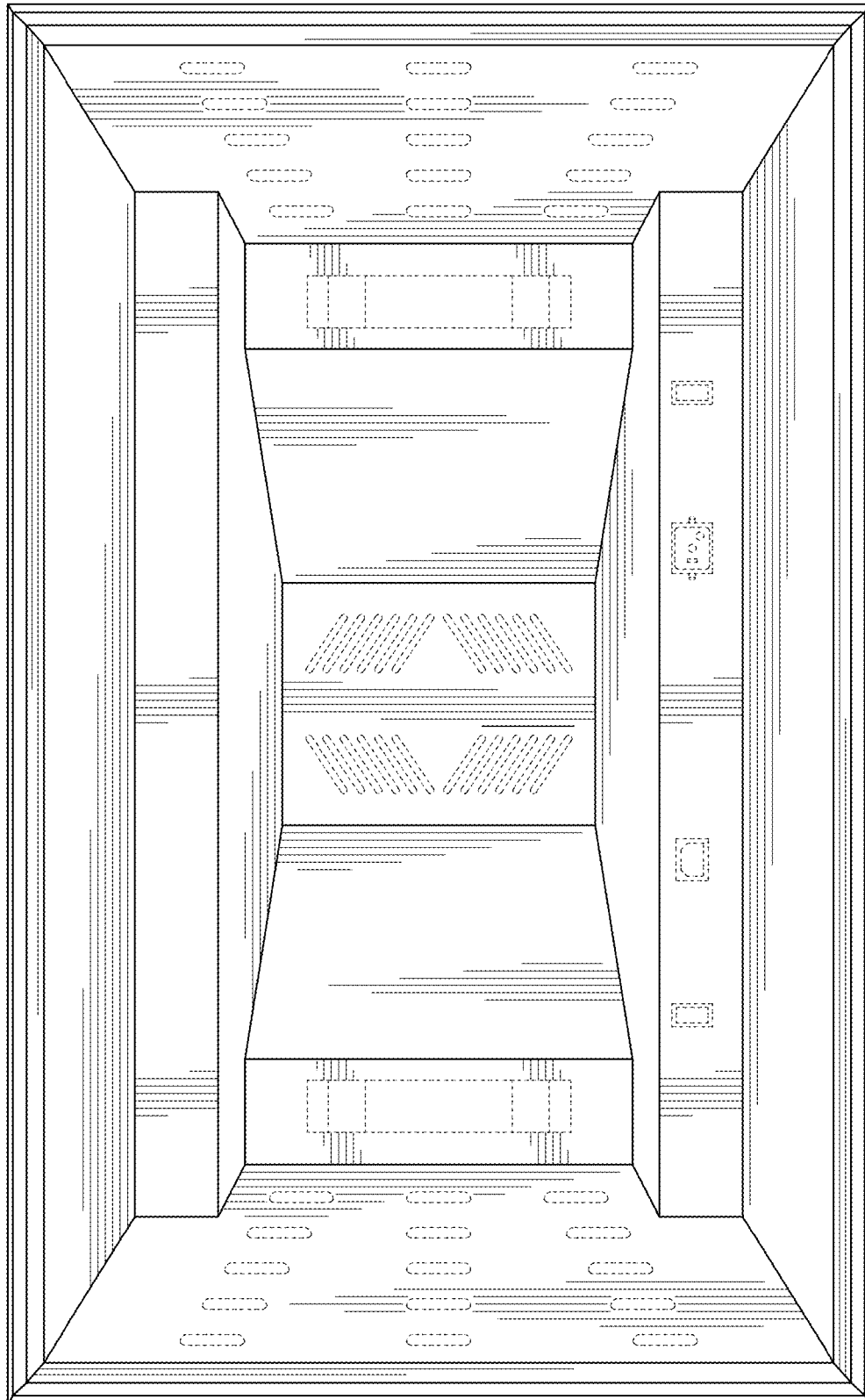

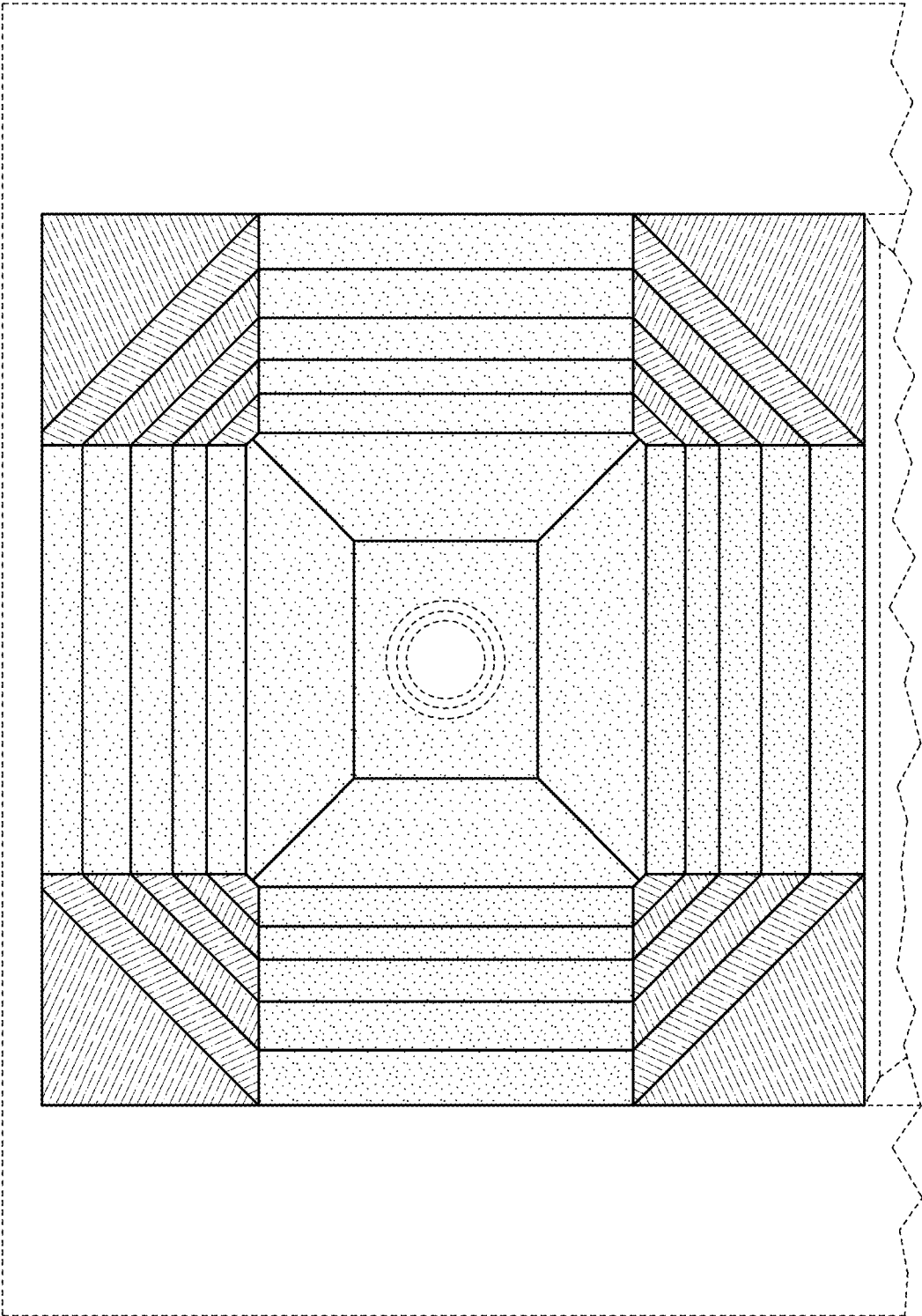

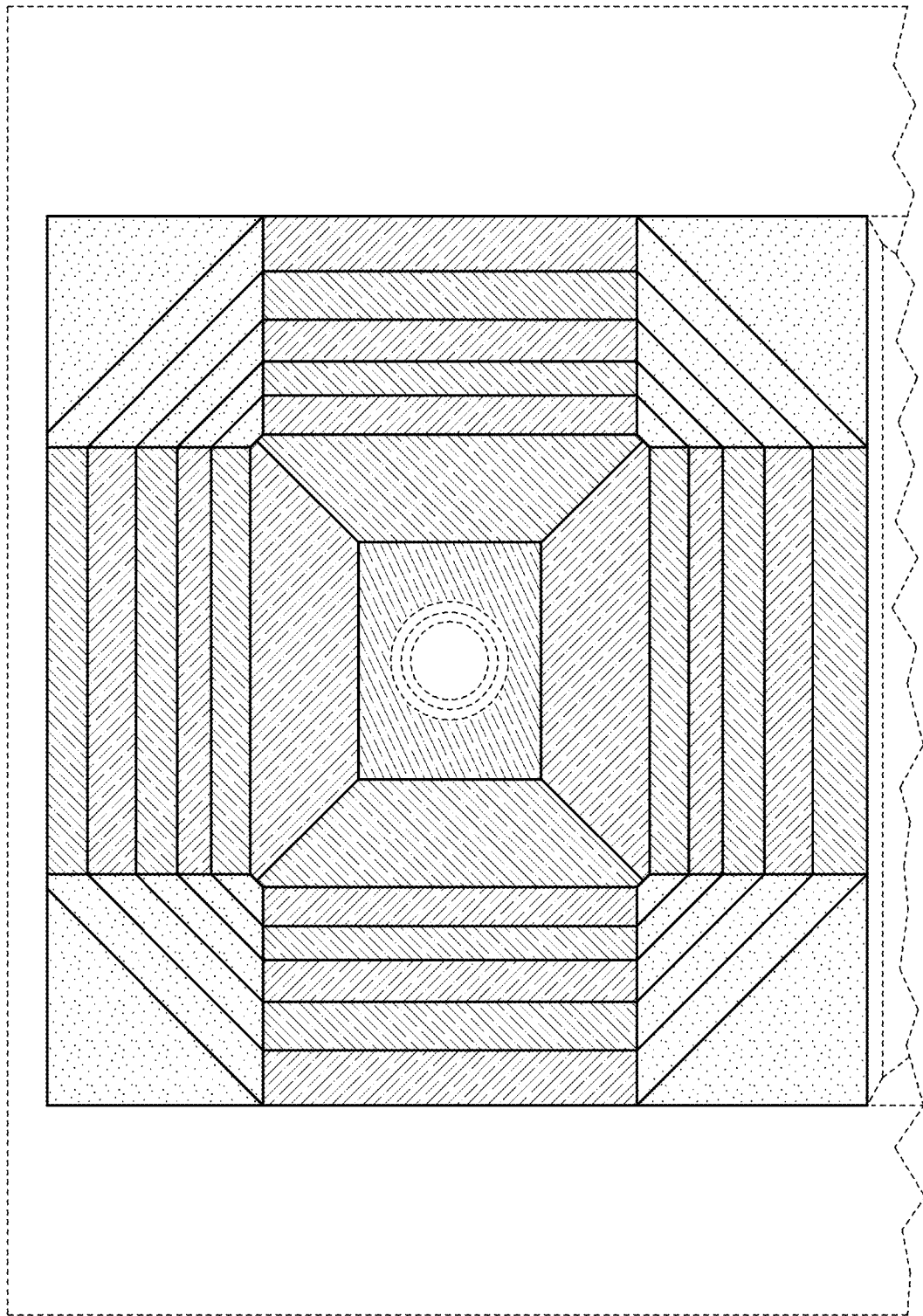

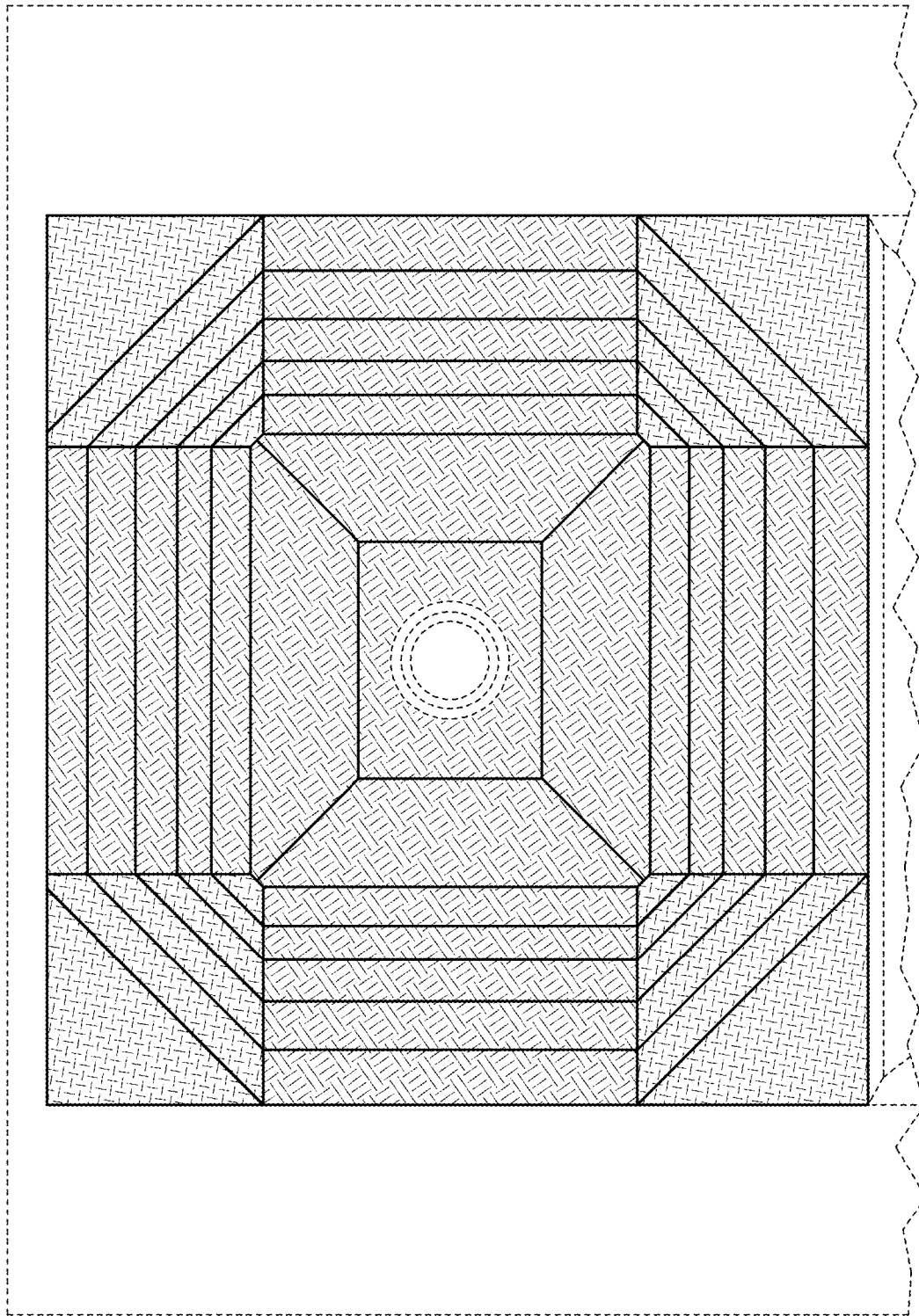

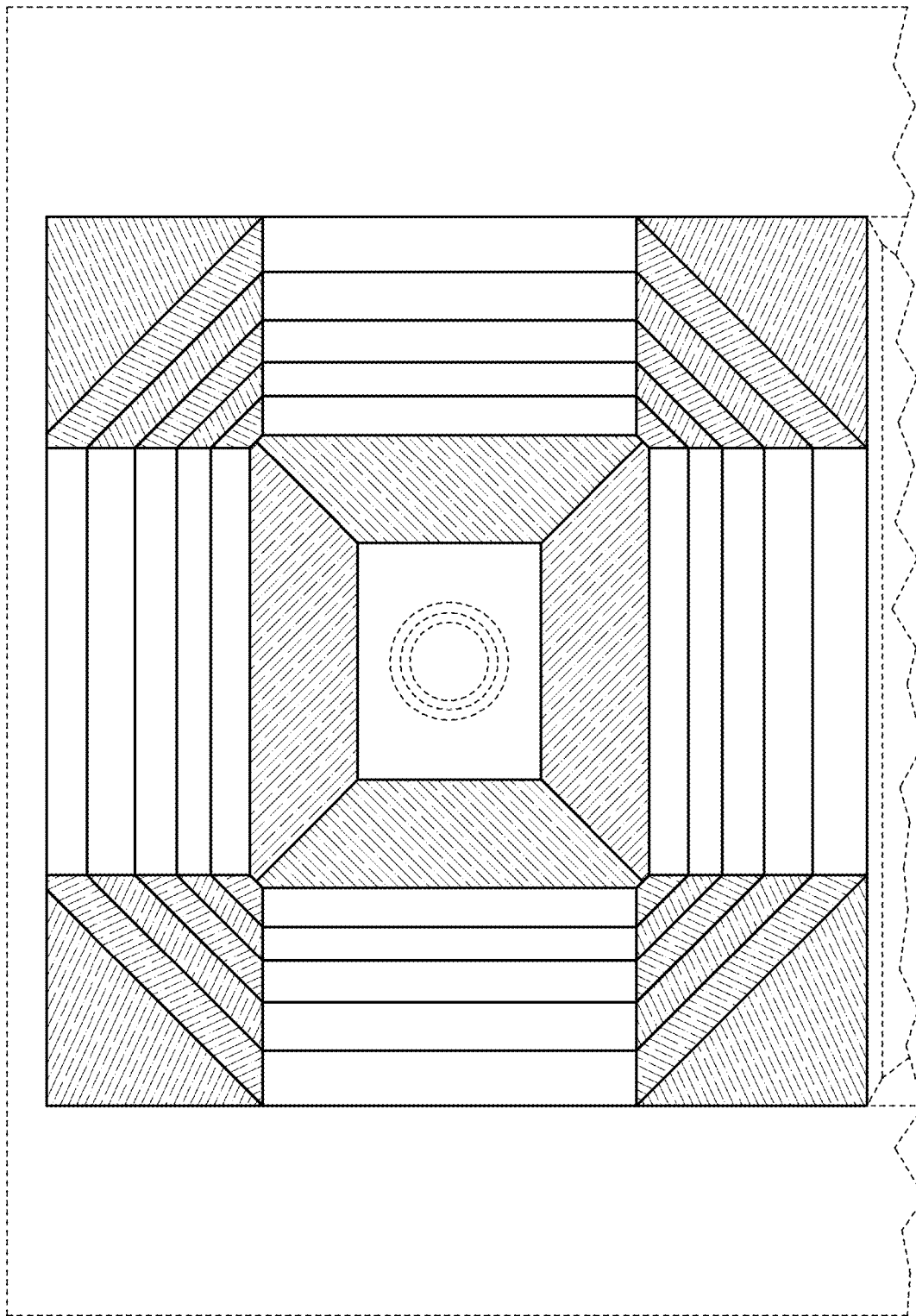
