The ornamental design for a caddy, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the new design for a caddy;

FIG. 2 is a top view thereof;

FIG. 3 is a bottom view thereof;


FIG. 4 is a front view thereof, a rear view being a mirror image thereof;

FIG. 5 is a cross-sectional view taken along line 5-5 of FIG. 2; and,

FIG. 6 is a perspective view thereof showing the caddy with a Cleaning Tool.












