(57) **CLAIM**

The ornamental design for a lighting fixture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a lighting fixture adapted to be mounted on a pole in accordance with a first embodiment of the present invention;

FIG. 2 is a side elevational view of the lighting fixture illustrated in FIG. 1;

FIG. 3 is a top plan view of the lighting fixture illustrated in FIGS. 1 and 2;

FIG. 4 is a bottom plan view of the lighting fixture illustrated in FIGS. 1-3;

FIG. 5 is a perspective view of a lighting fixture adapted to be mounted on an underhand wall bracket in accordance with a second embodiment of the present invention;

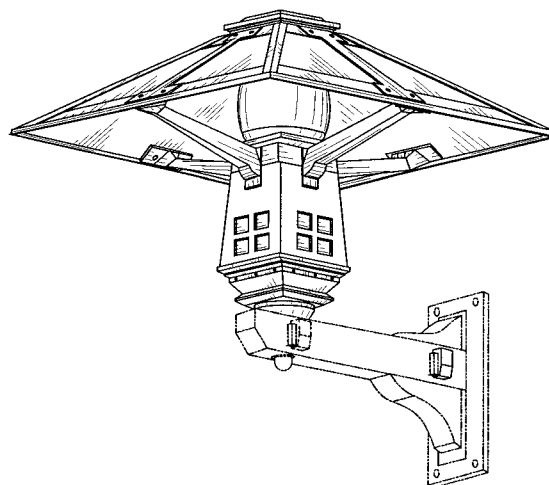
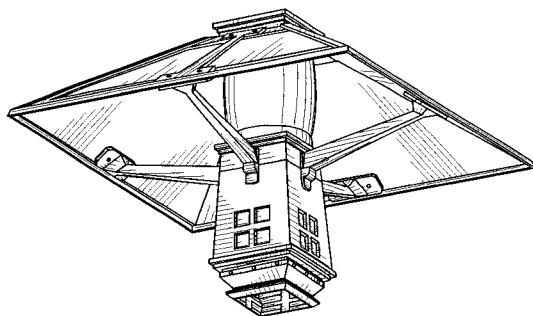
FIG. 6 is a side elevational view of the lighting fixture illustrated in FIG. 5;

FIG. 7 is a top plan view of the lighting fixture illustrated in FIGS. 5 and 6; and,

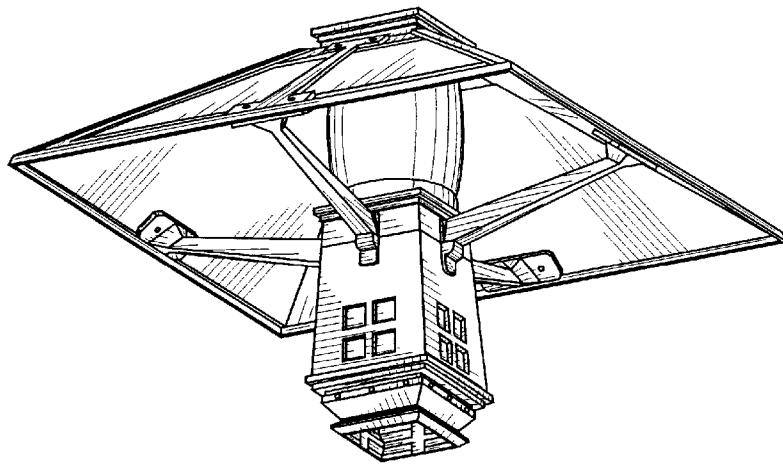

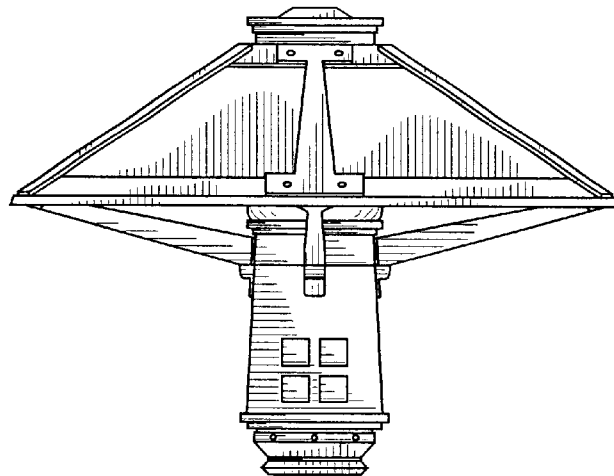

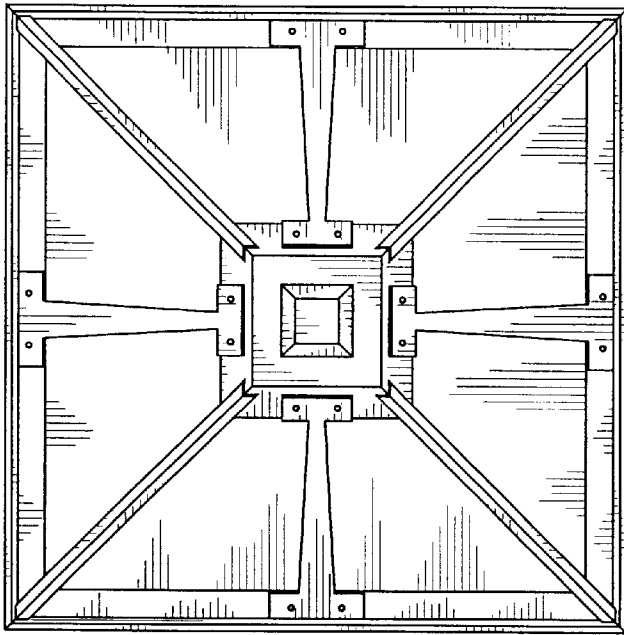
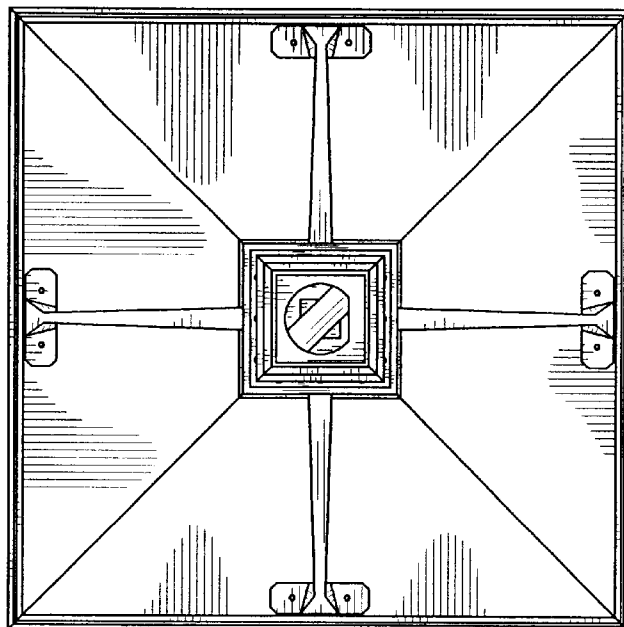

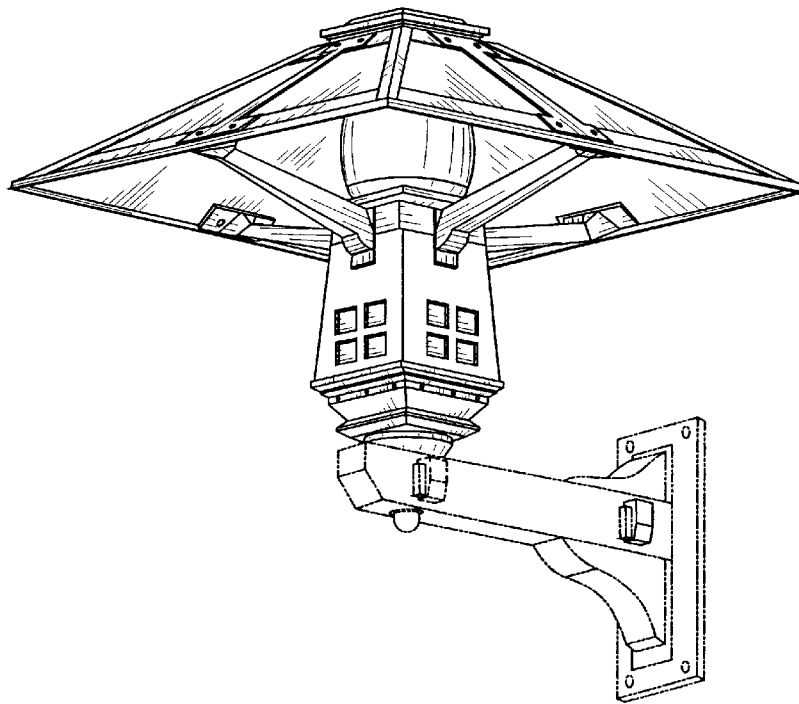

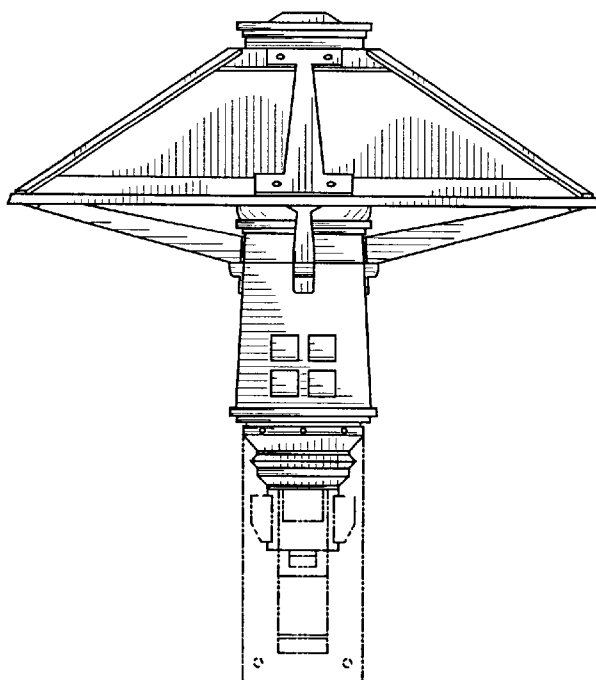

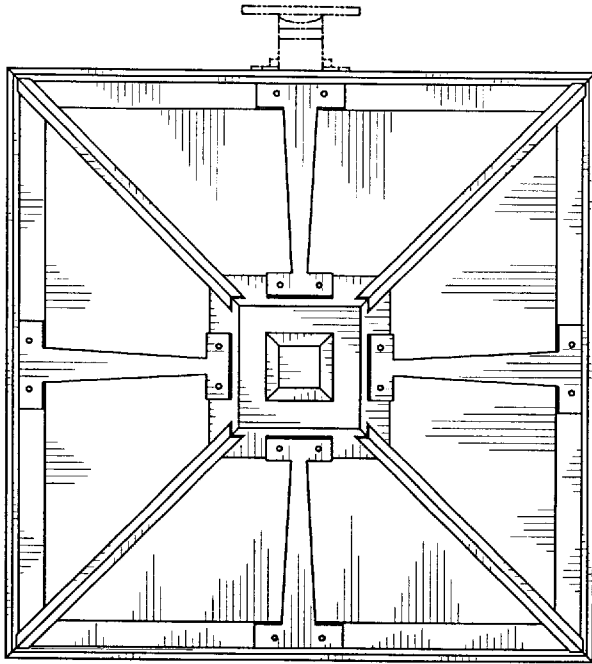
