The ornamental design for an expansion module, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and left side perspective view of an expansion module showing our new design according to a first embodiment;

FIG. 2 is a rear, bottom and right side perspective view thereof;

FIG. 3 is a rear, bottom and left side perspective view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a left side elevational view thereof;


FIG. 7 is a right side elevational view thereof;


















