FIG. 1 is an isometric assembled view of a rolled material dispenser lockout incorporating our new design, viewed from in front of, above, and from the right side thereof;

FIG. 2 is an exploded isometric view viewed from in front of, above, and from the right side thereof;

FIG. 3 is a front elevation view of our new design, by itself, for ease of illustration;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a right side elevation view thereof; and,

FIG. 8 is a left side elevation view thereof.


















