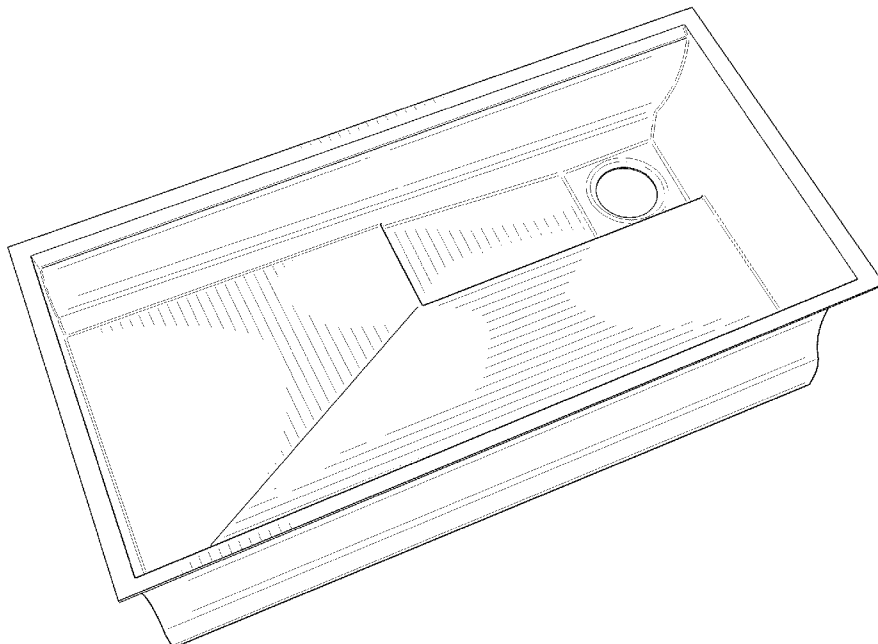

(57) **CLAIM**

We claim the ornamental design for a kitchen sink, as shown
and described.

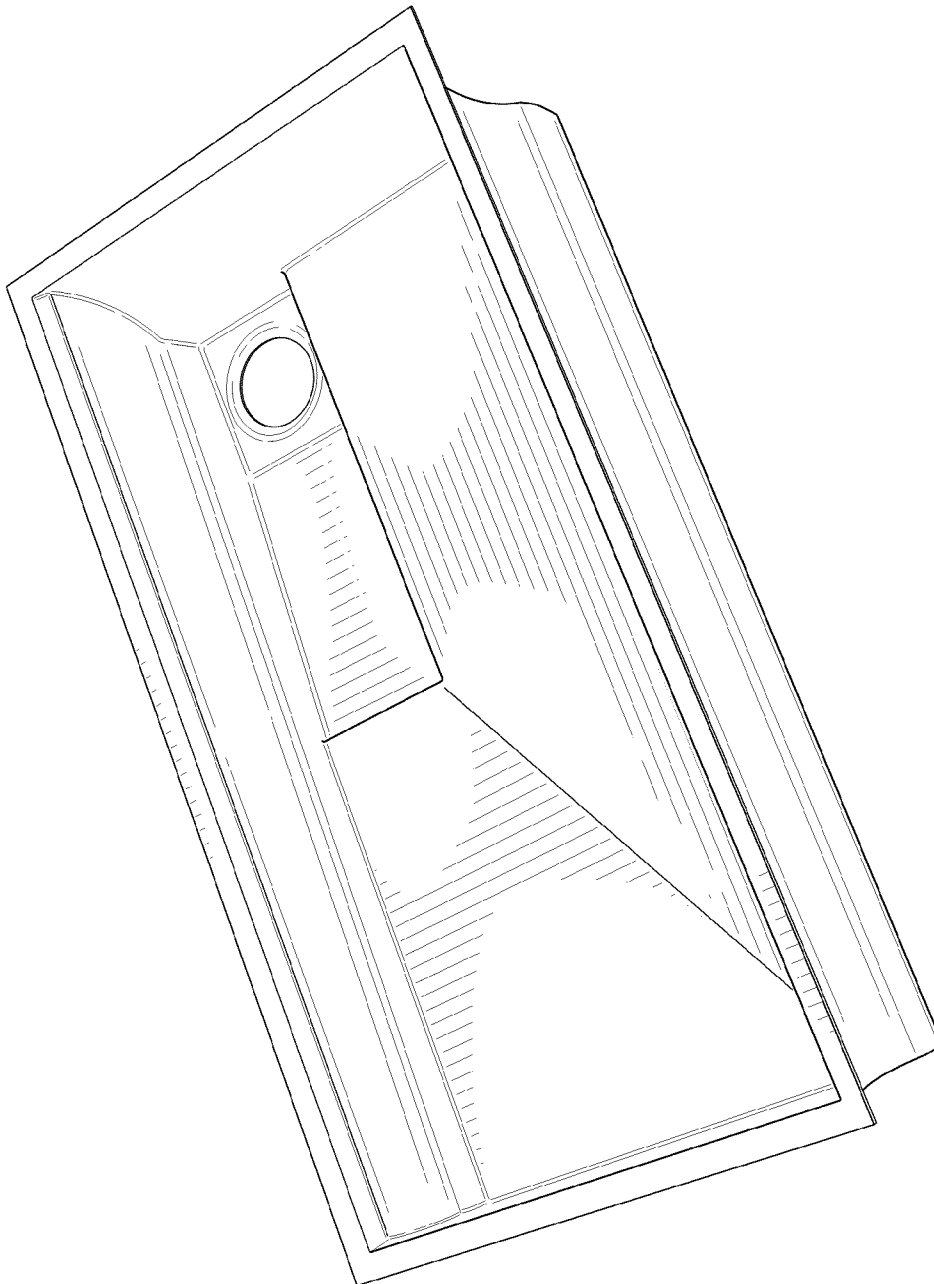

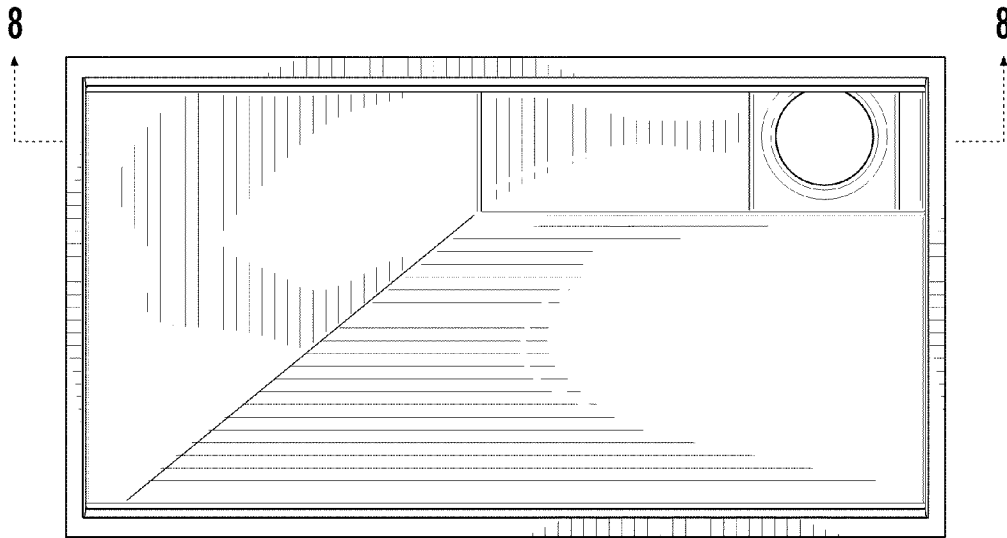

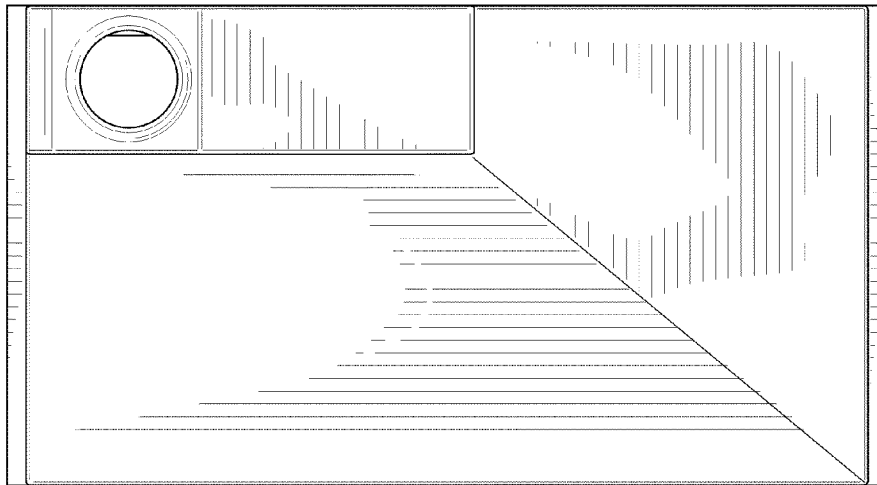

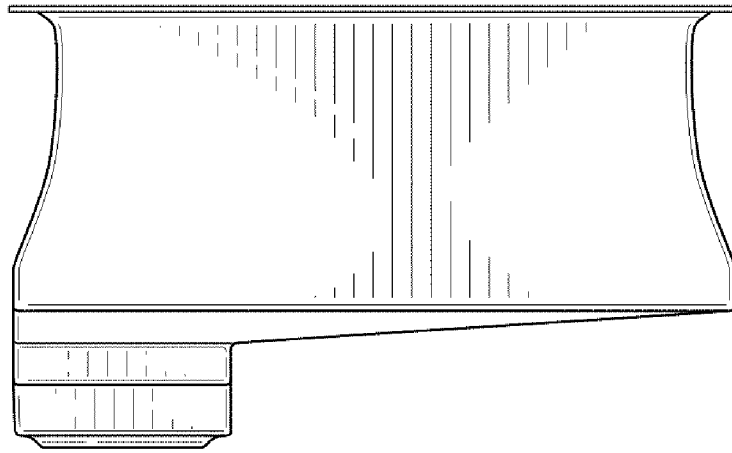

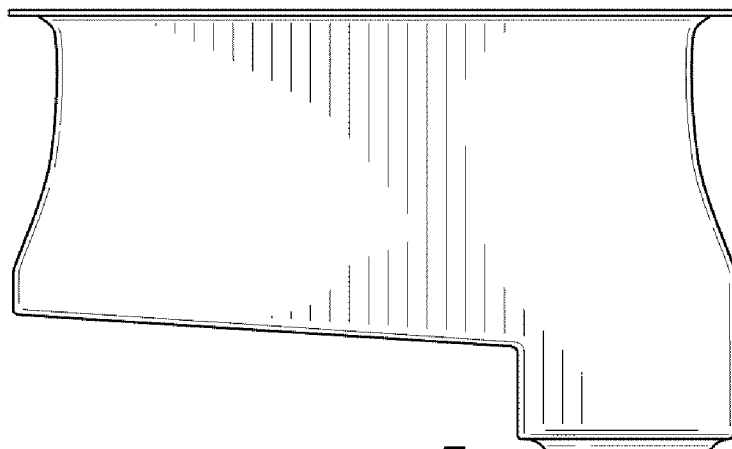

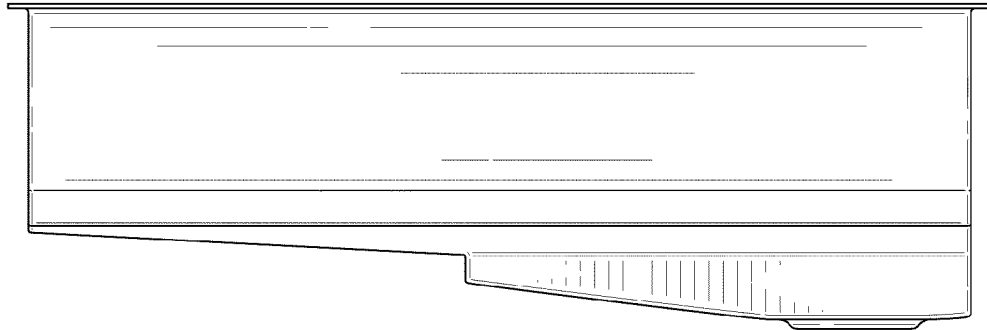

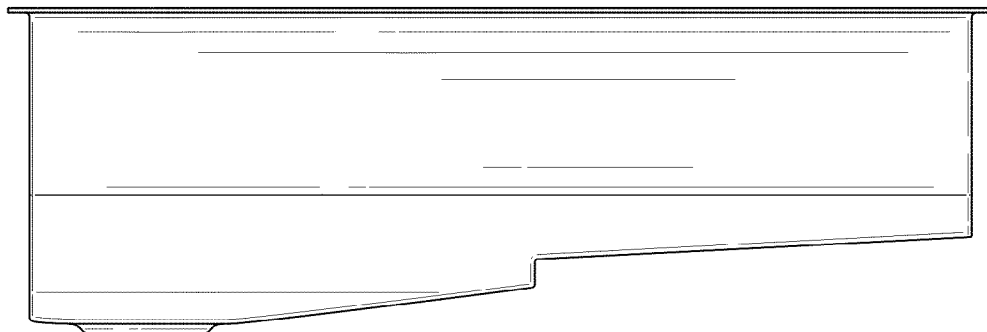

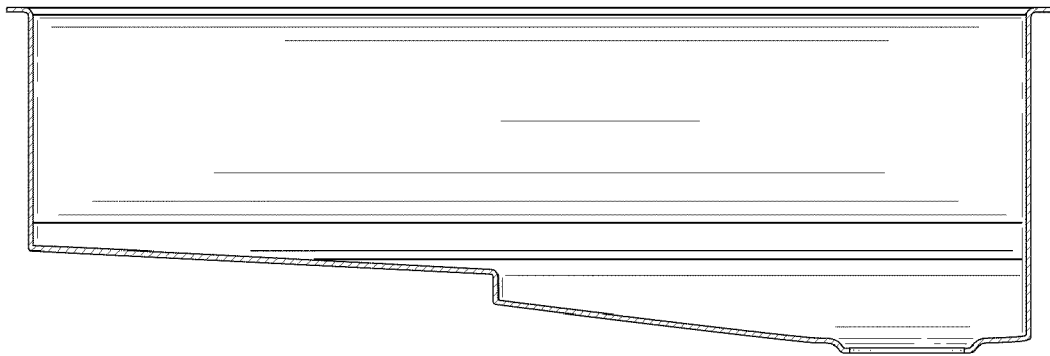

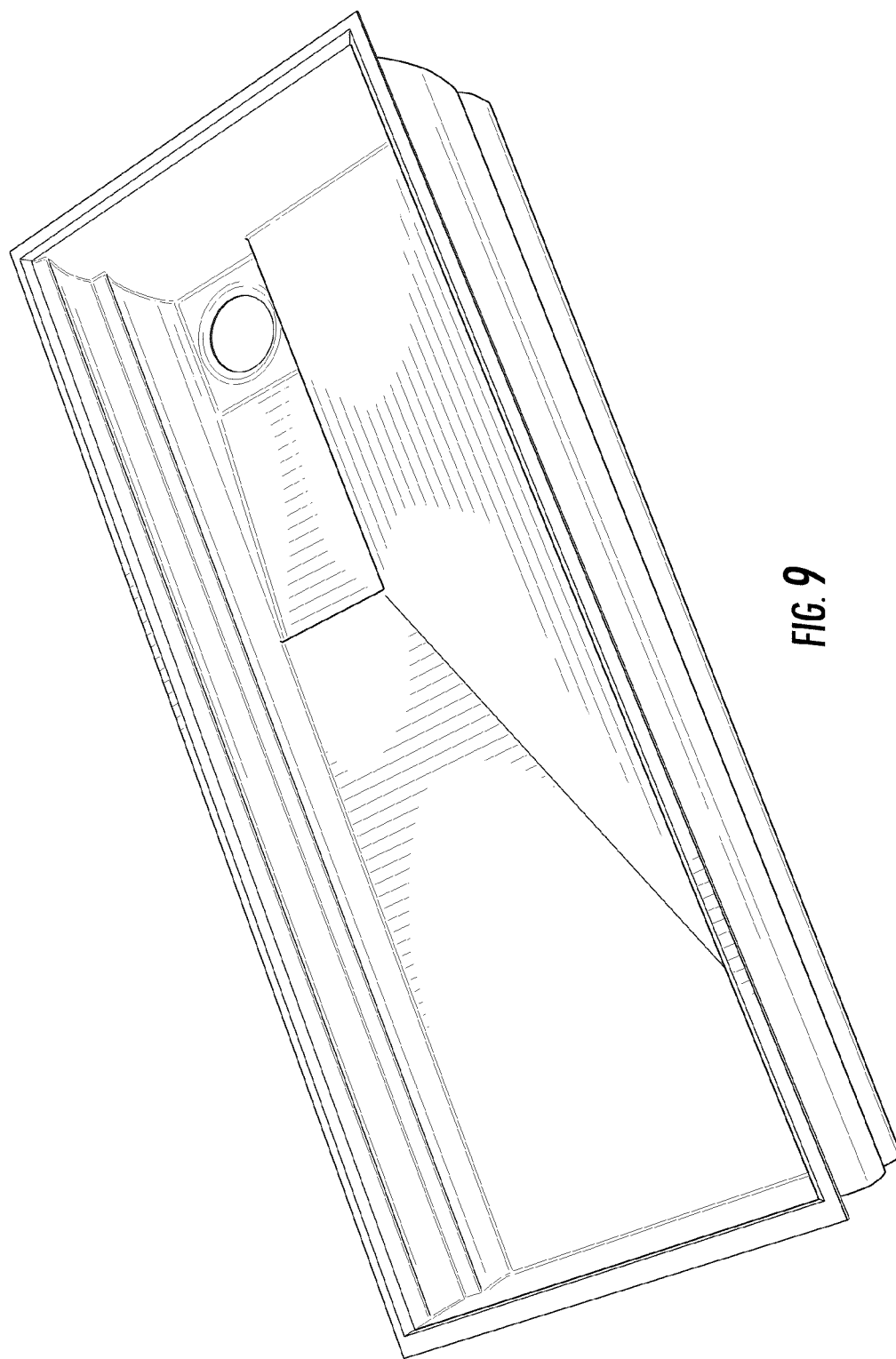

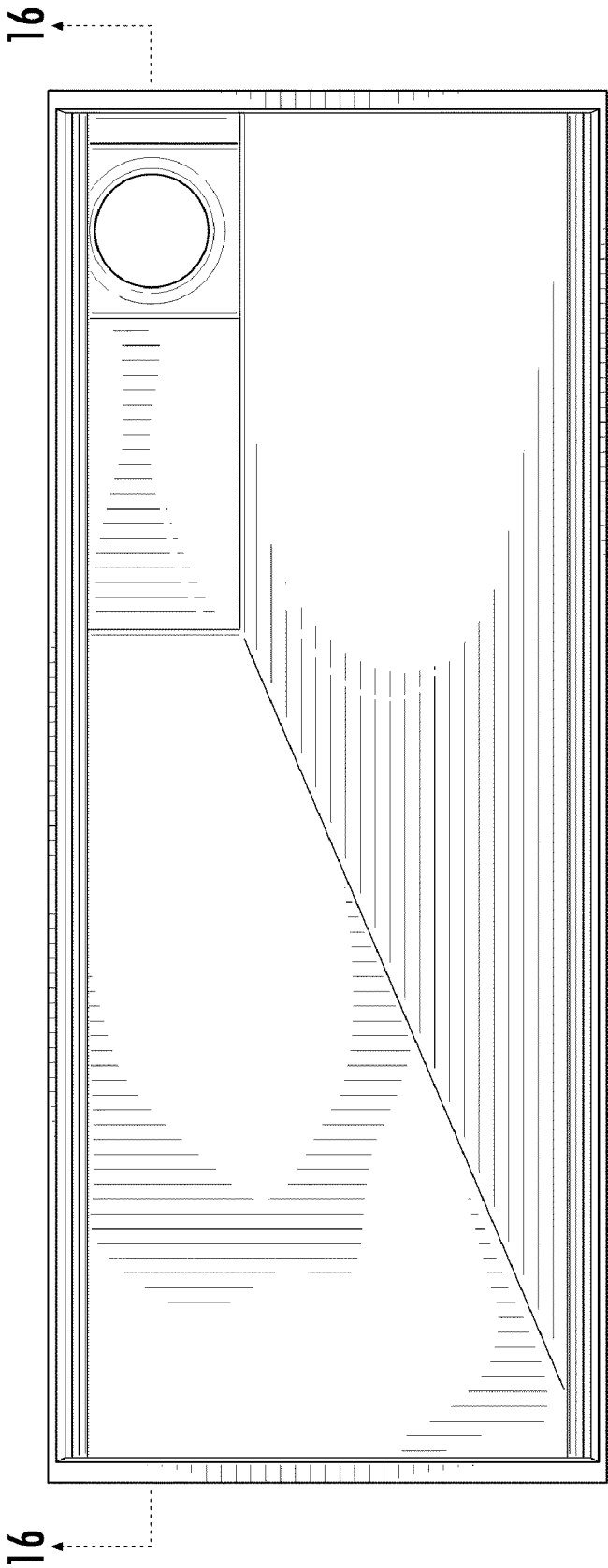

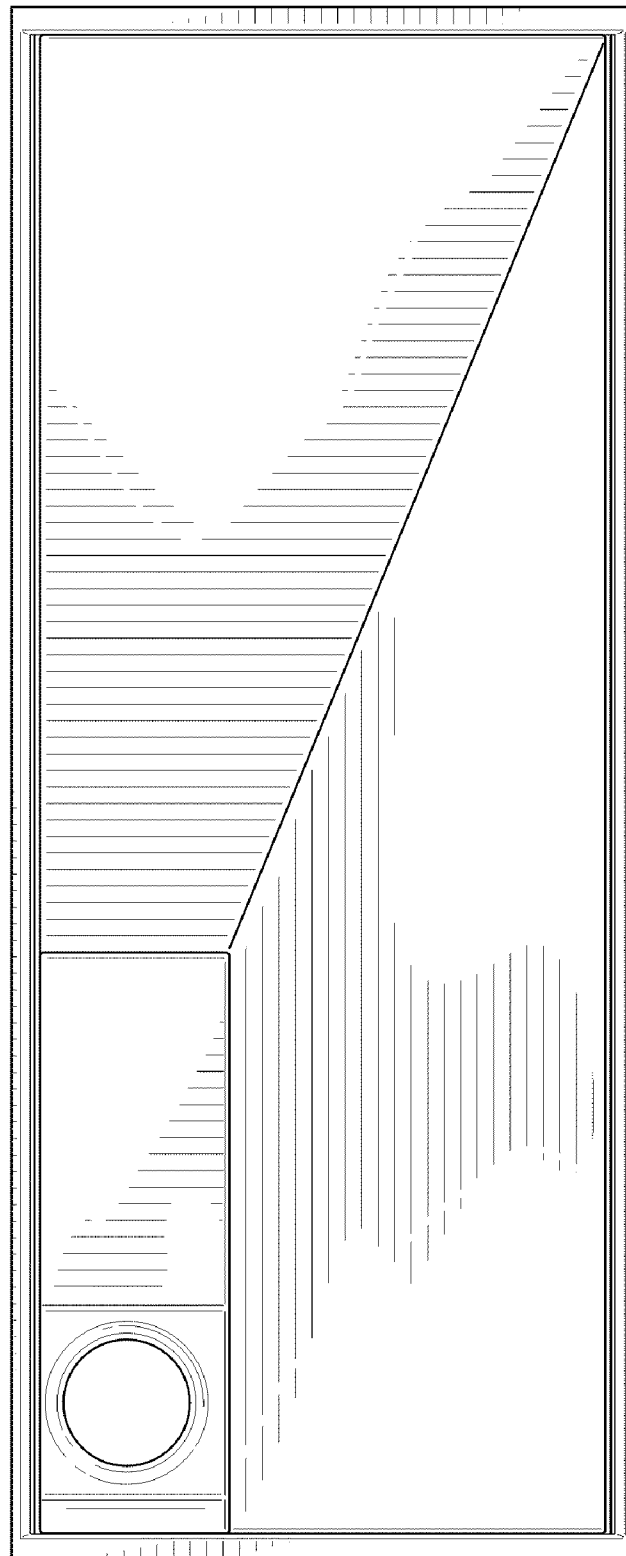

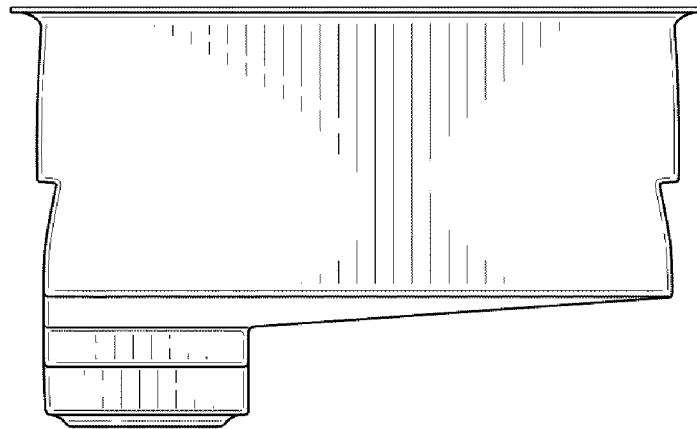

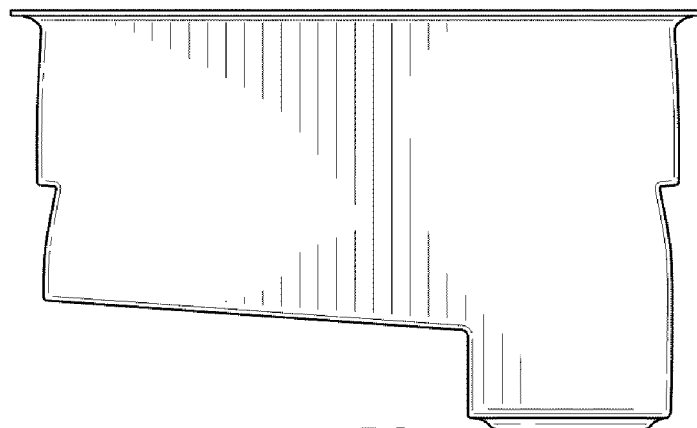

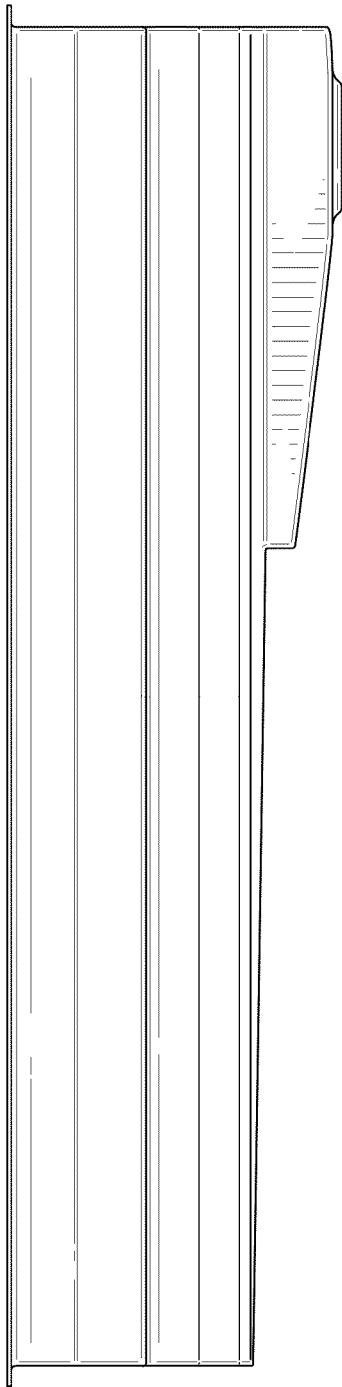

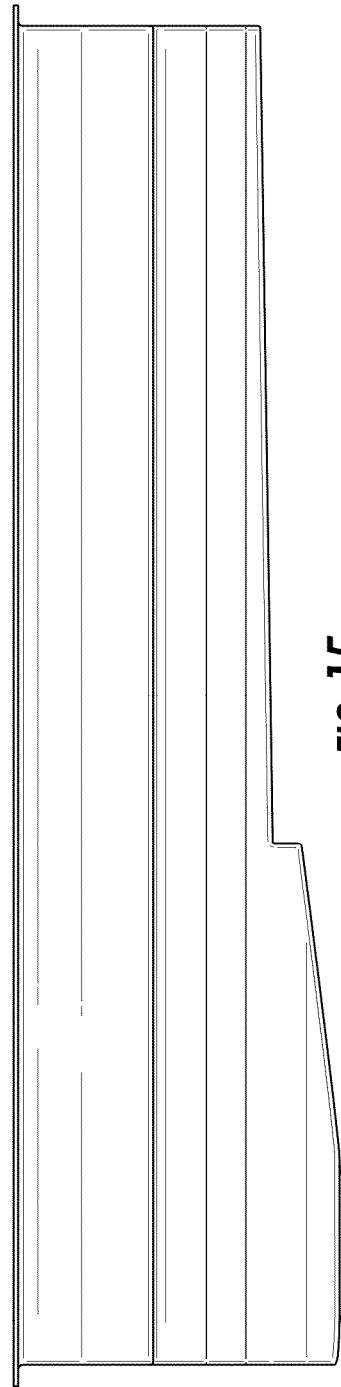

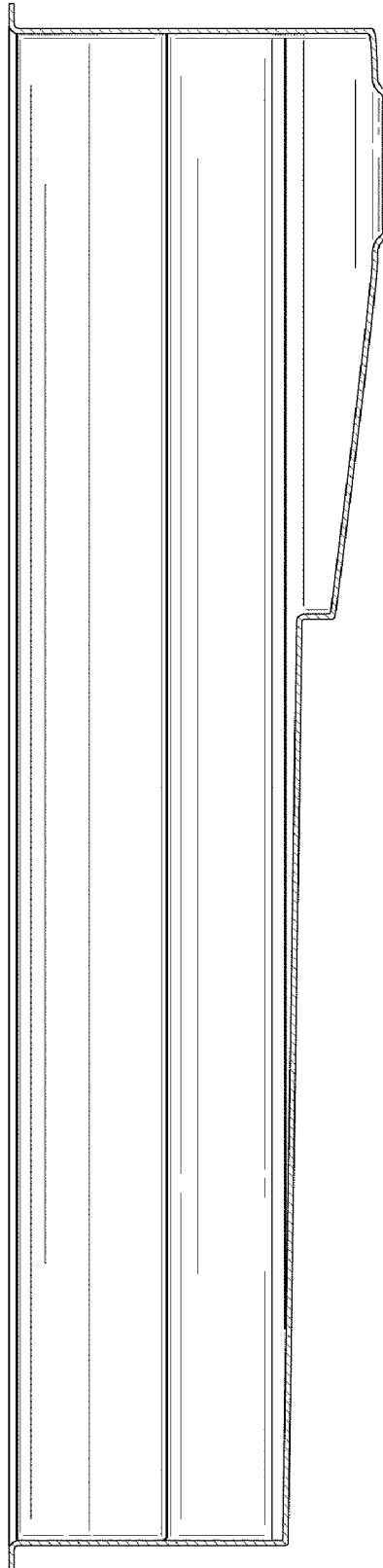
