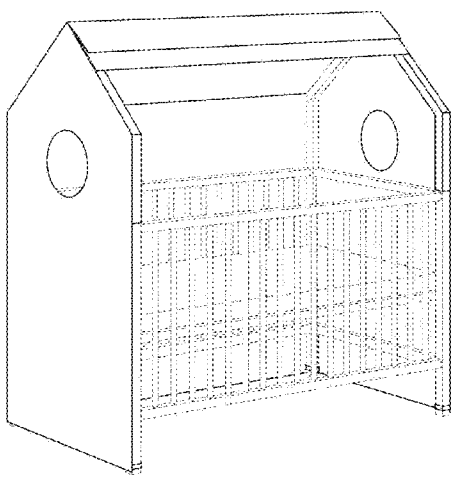
(57) **CLAIM**

The ornamental design for a crib covering, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a crib covering showing the new design, with a roof panel in a first configuration;
FIG. 2 is a front view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is a perspective view thereof, showing the roof panel in a second configuration.
The broken lines shown in the drawings illustrate the environment of the crib covering, and form no part of the claimed design.

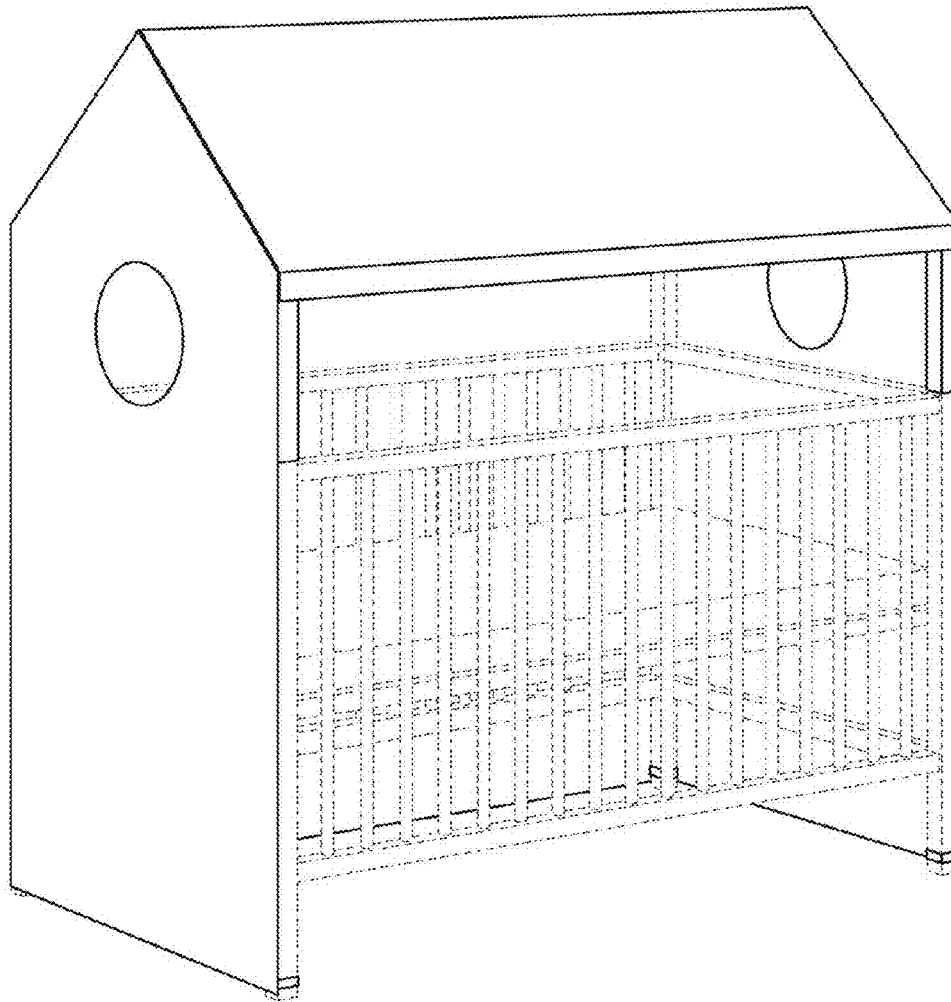

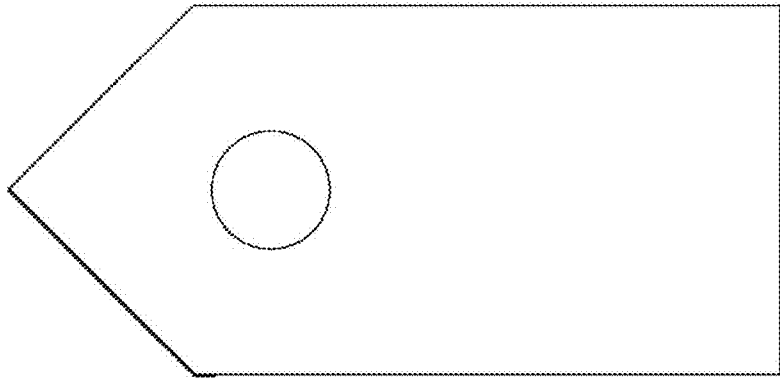

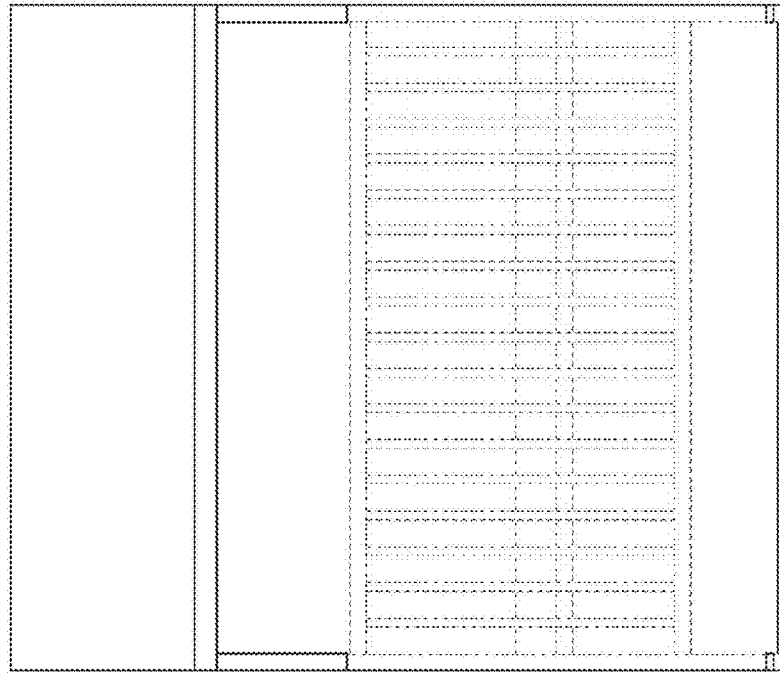

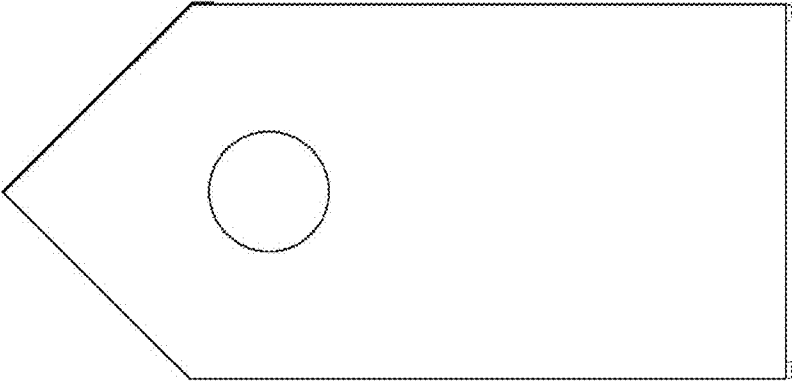
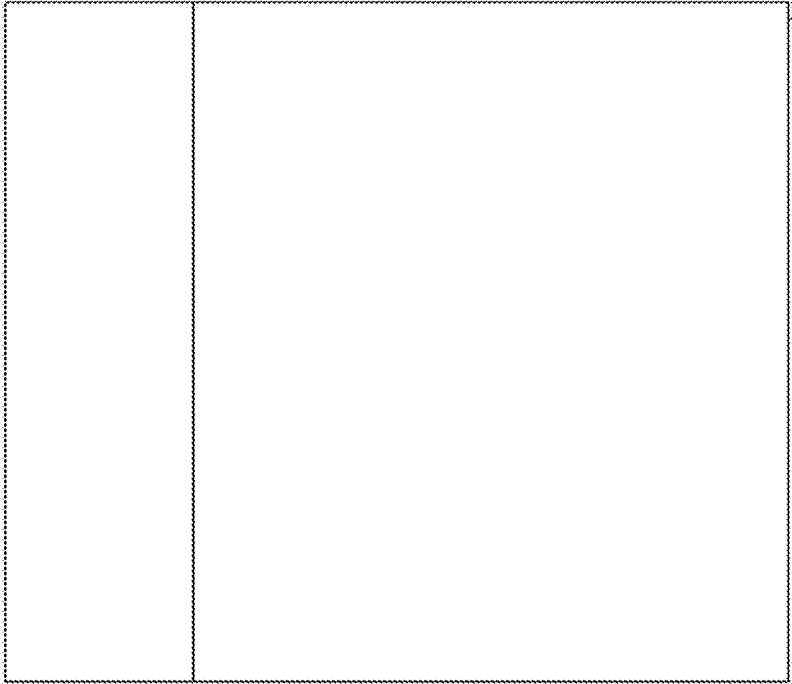

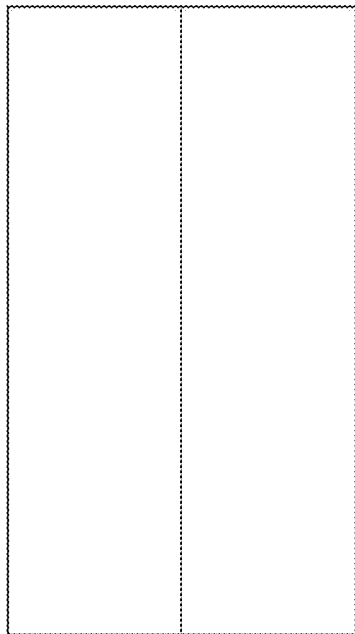

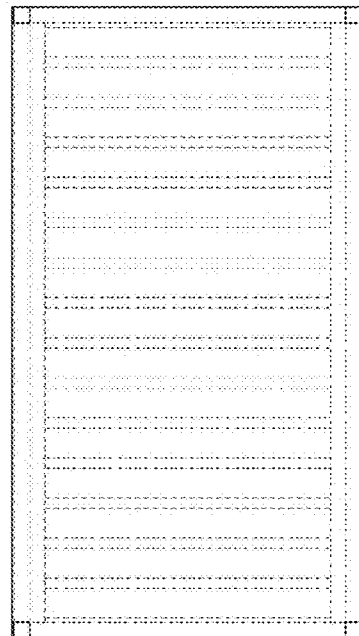
