The ornamental design for a graphic user interface for a portion of a display panel, as shown and described.

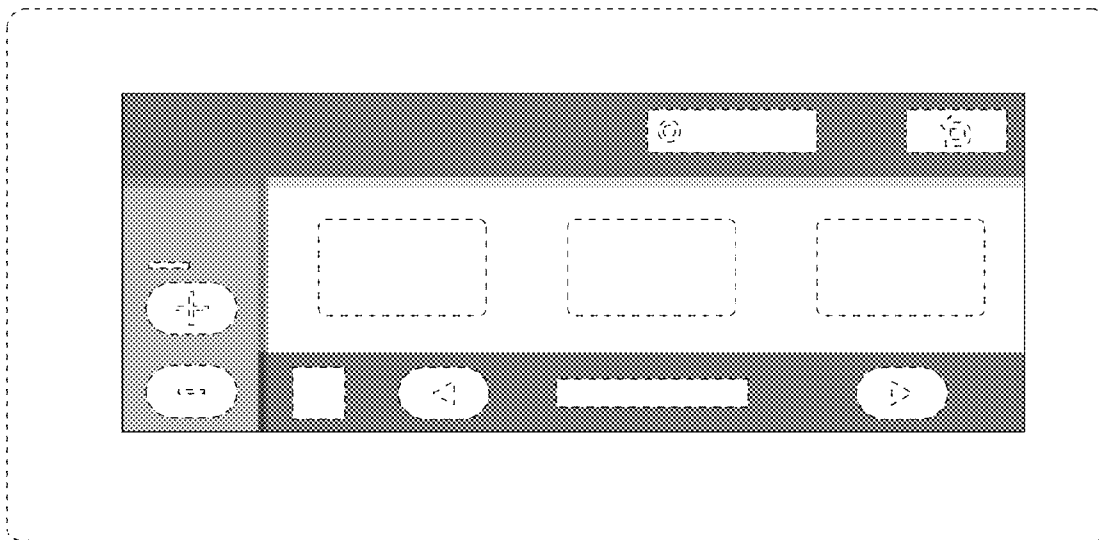
DESCRIPTION

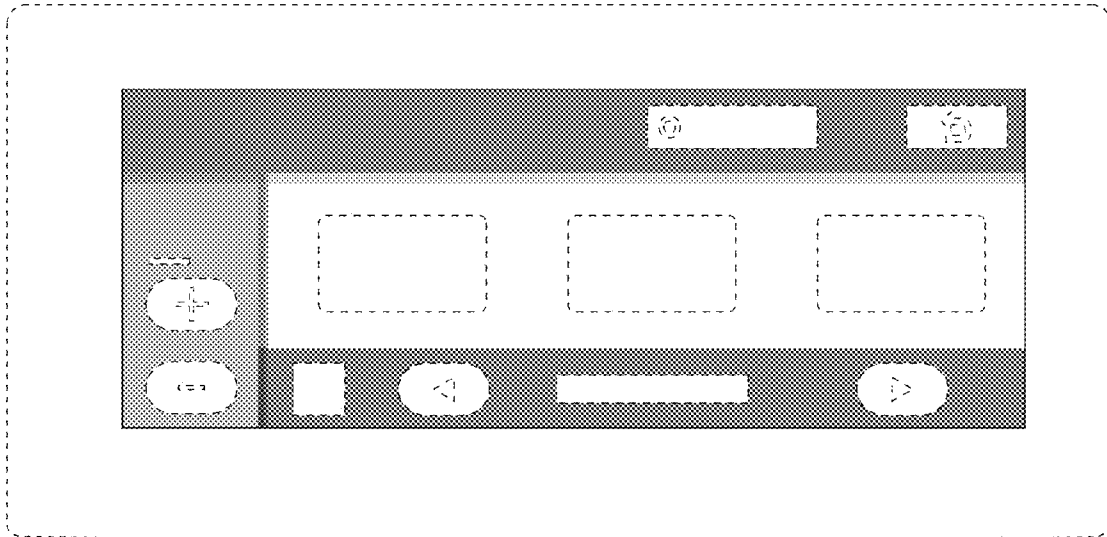
The FIGURE is a front view of a graphic user interface for a portion of a display panel.


