(57) **CLAIM**

The ornamental design for a mount for electronic devices, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, first side, and top perspective view of a mount for electronic devices embodying the new design; FIG. 2 is a back, second side, and bottom perspective view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a back view thereof;

FIG. 5 is a first side view thereof;

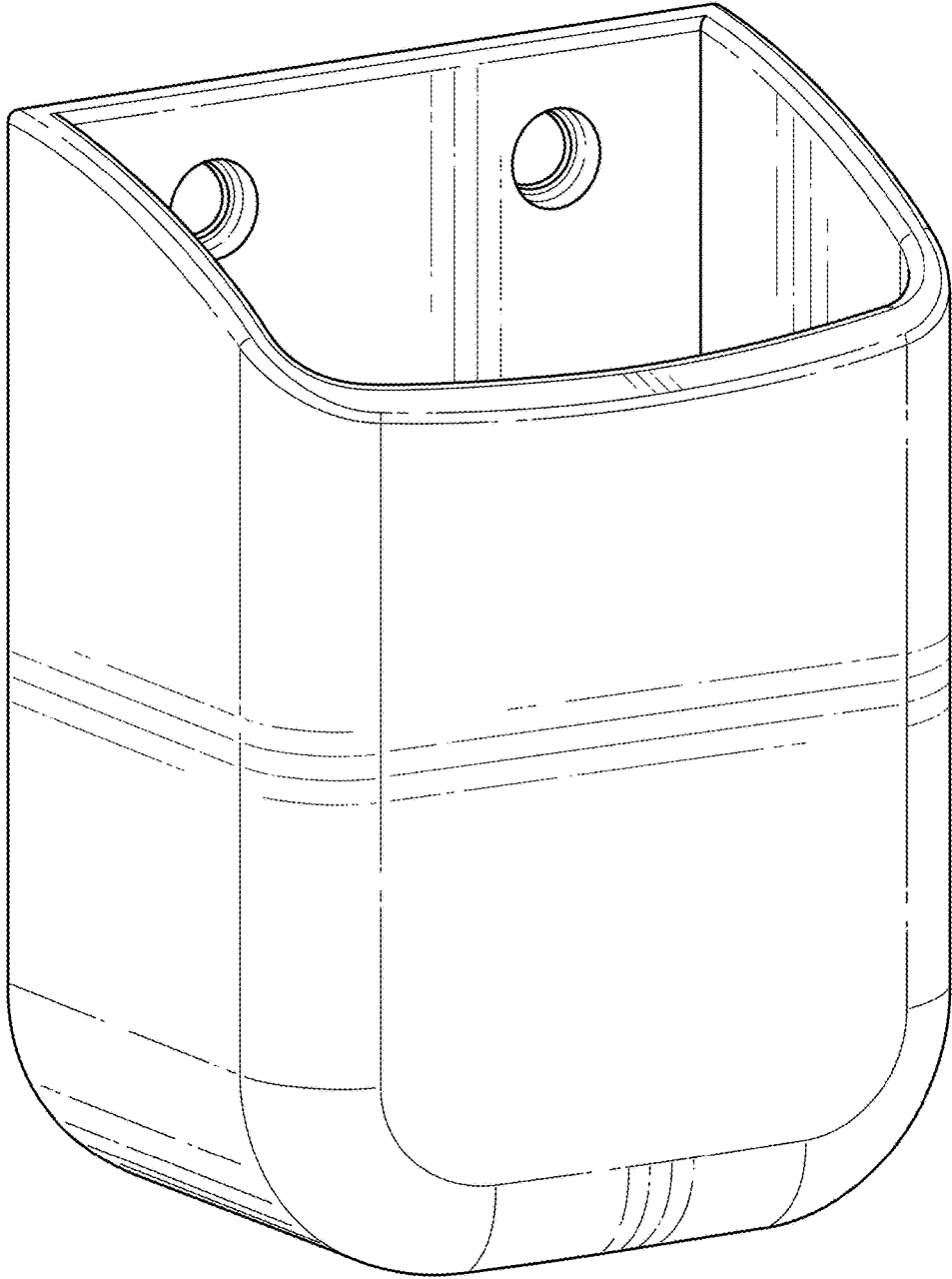

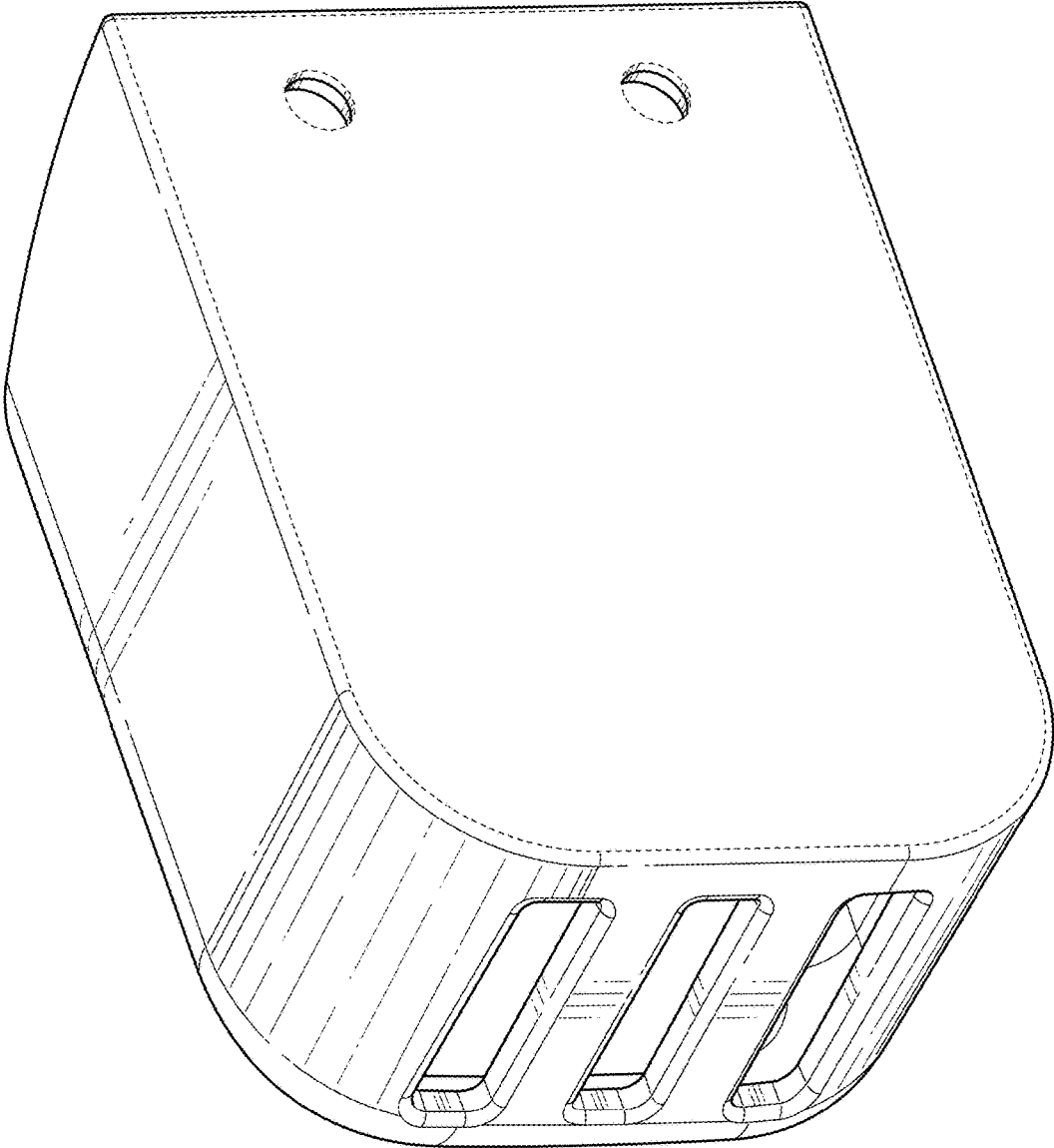

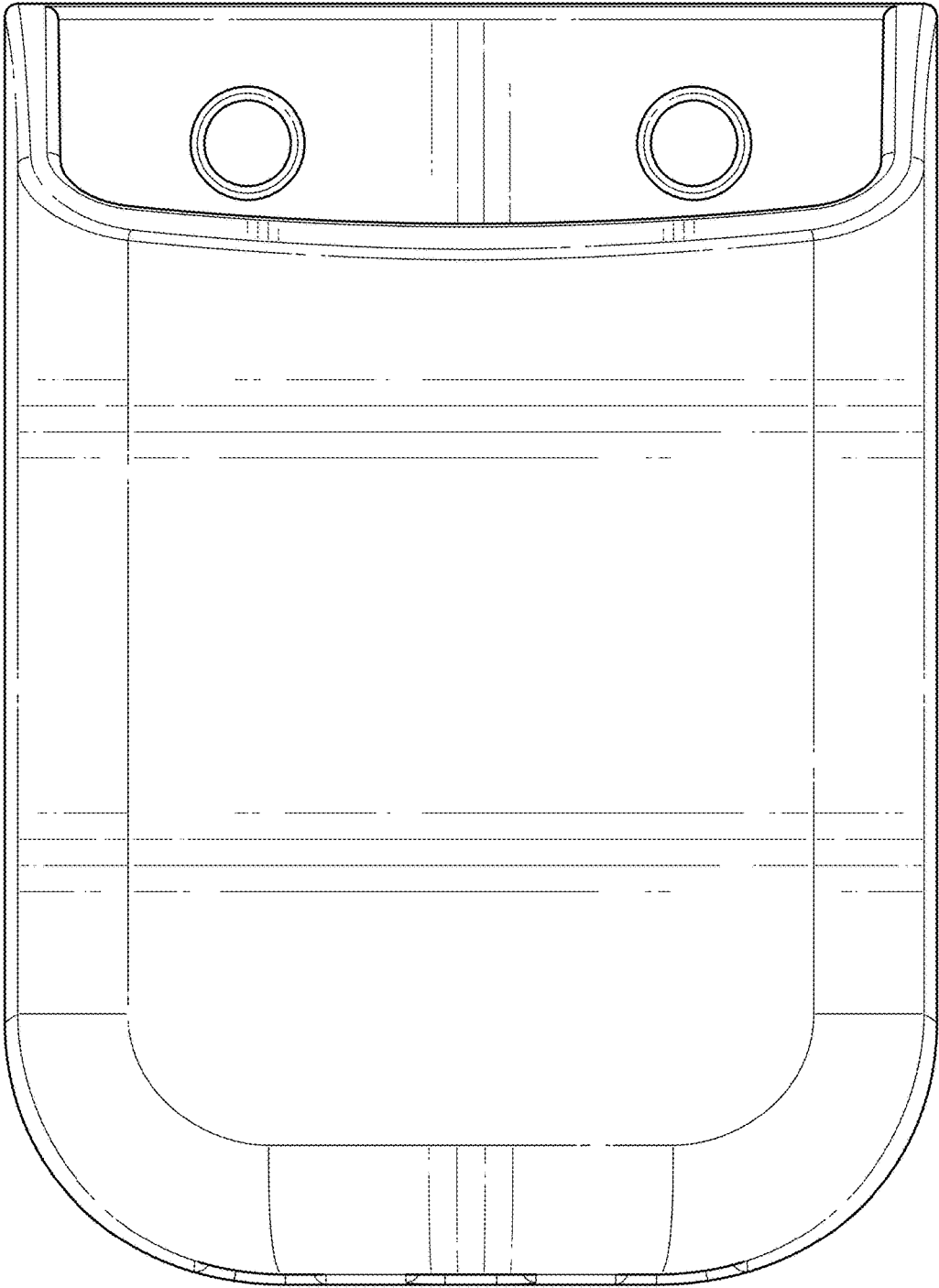

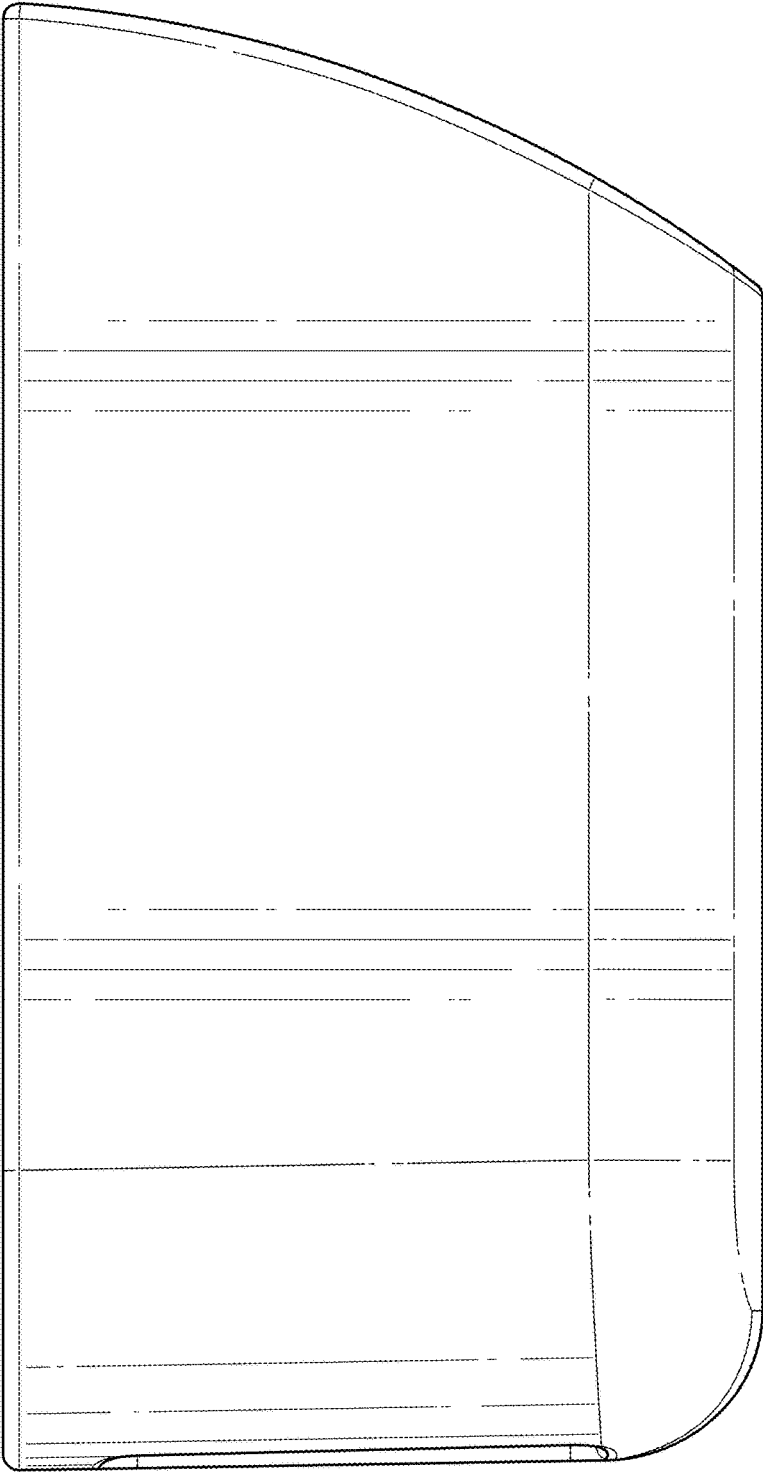

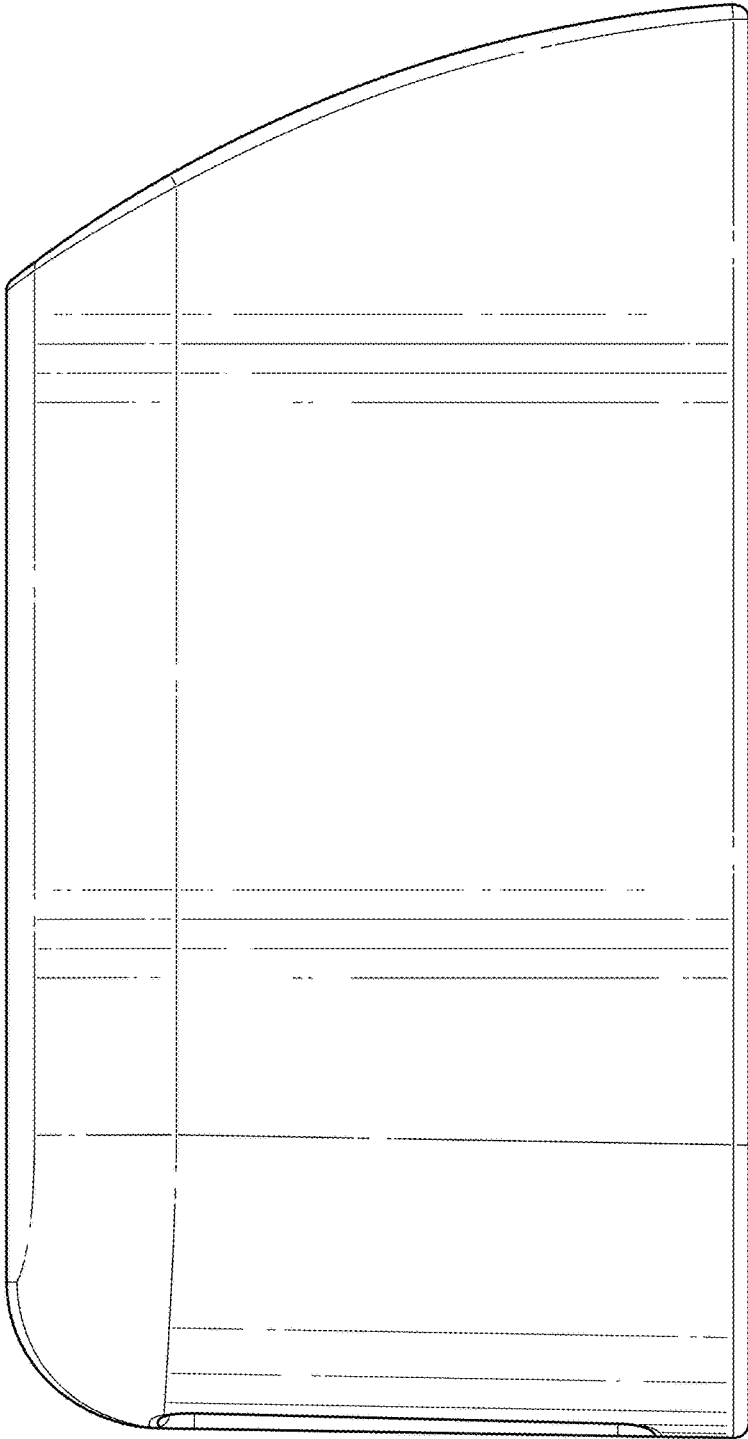

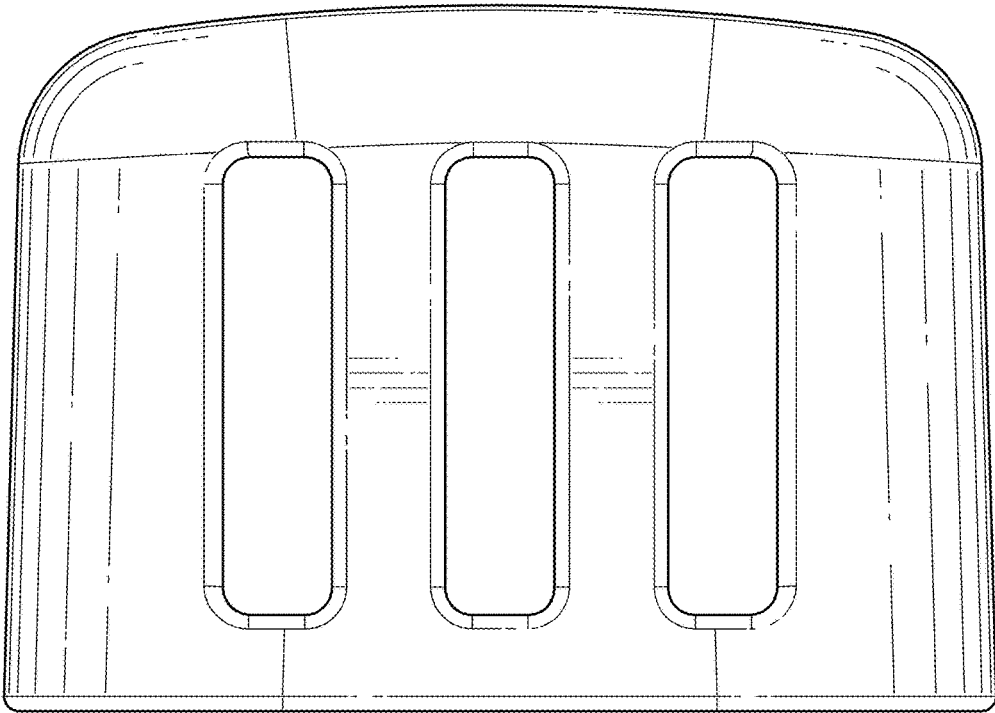

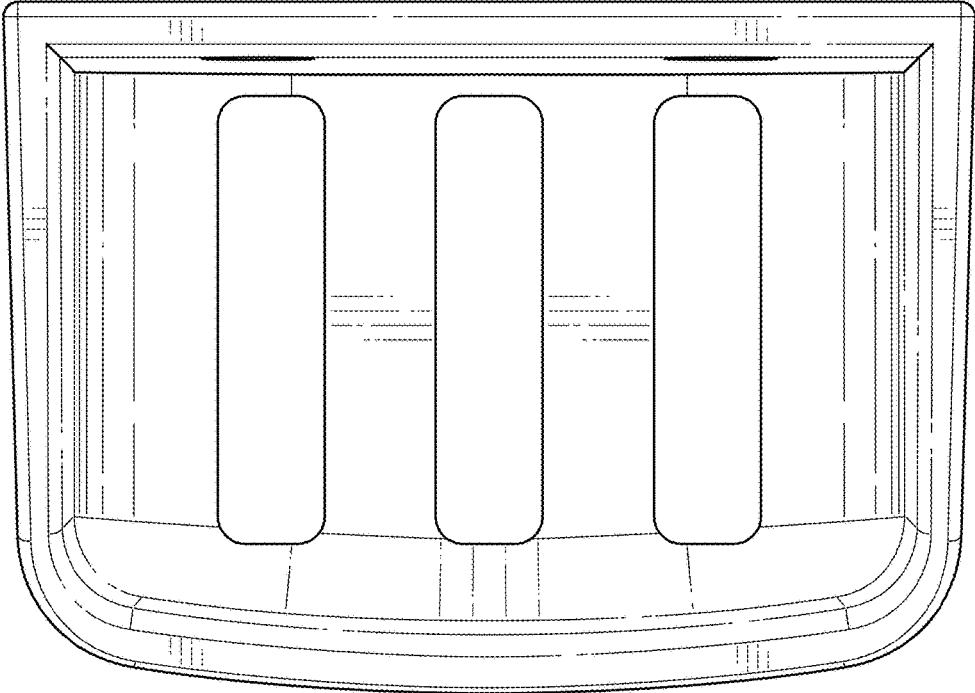
