[57] CLAIM

The ornamental design for a can opener, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the front, top, and right side of a can opener in its closed position showing our new design;

FIG. 2 is a front elevational view illustrating the can opener in its open position;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a front elevational view of the can opener in its closed position;

FIG. 9 is a rear elevational view thereof;

FIG. 10 is a top plan view thereof;

FIG. 11 is a bottom plan view thereof;

FIG. 12 is a left side elevational view thereof;

FIG. 13 is a right side elevational view thereof; and,

FIG. 14 is a perspective view of the can opener in its open position.





























