DESCRIPTION

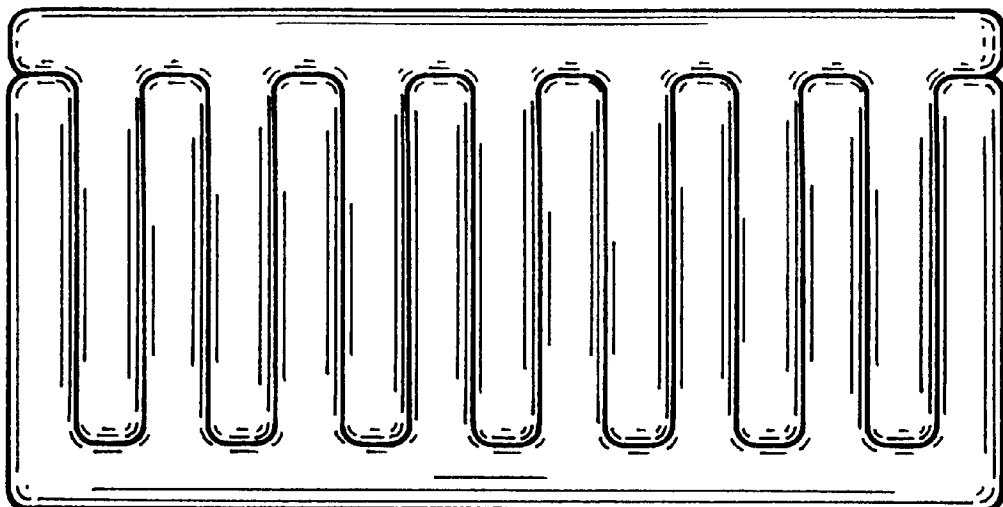
FIG. 1 is a top plan view of an air mattress showing our new design;

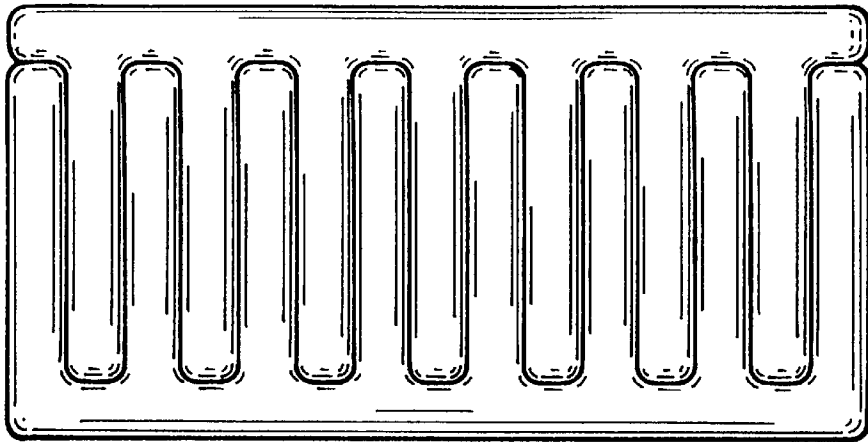
FIG. 2 is a front elevational view thereof, the rear being a mirror image of the front;

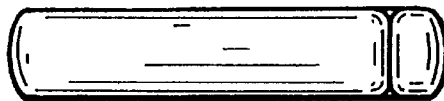




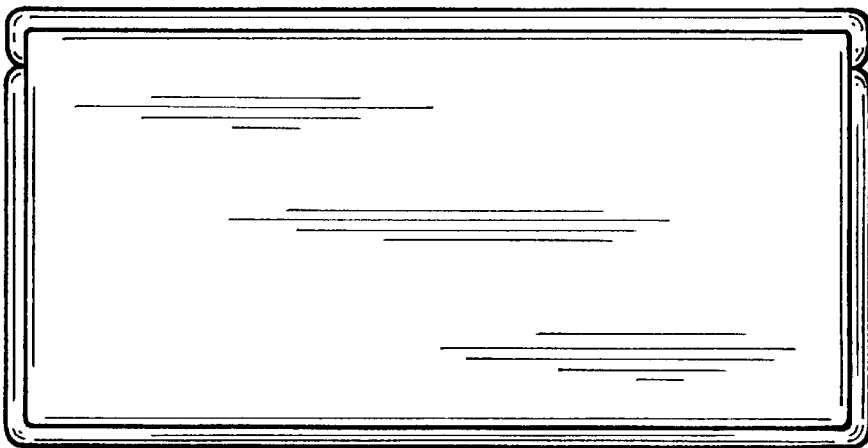
