
(57) **CLAIM**

We claim the ornamental design for a storage device bezel, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the storage device bezel comprising the present invention; FIG. 2 is a front view thereof; FIG. 3 is a back view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; and, FIG. 8 is a side perspective view thereof disposed in an arrangement of storage devices. Broken lines shown in the drawings illustrate portions of the storage device bezel, and form no part of the claimed design.
















