(57) **CLAIM**

The ornamental design for a compressor or a vacuum machine, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a compressor or a vacuum machine showing our new design; FIG. 2 is a perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom view thereof.

A left side view is symmetrical to a right side view and is omitted.

The broken line showing of elements is included for the purpose of illustrating environmental matter and forms no part of the claimed design.












