FIG. 1 is the front/right-side/top perspective view of an ice tray for refrigerator showing our new design; FIG. 2 is the front elevation view thereof; FIG. 3 is the rear elevation view thereof; FIG. 4 is the left-side elevation view thereof; FIG. 5 is the right-side elevation view thereof; FIG. 6 is the top-side plan view thereof; FIG. 7 is the bottom-side plan view thereof; FIG. 8 shows the ice tray for refrigerator in use; and, FIG. 9 is a perspective view thereof showing a tray portion removed during typical use. The shade lines in the Figures show the transparency and the flatness, and not surface ornamentation. The broken lines in the drawing show unclaimed environment only and form no part of the claimed design.


















