(57) **CLAIM**

The ornamental design for a speaker, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a speaker showing our new design;

FIG. 2 is a top view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a right side view thereof, the left side view being a mirror image;

FIG. 5 is a cross section thereof, taken along the line 5-5 in FIG. 2;

FIG. 6 is a cross section of a second embodiment thereof, the other views being the same as FIGS. 1-4; and,


FIG. 7 is a cross section of a third embodiment thereof, the other views being the same as FIGS. 1-4.

The dashed broken lines illustrate structure or features that form no part of the claimed design.

The drawings include line surface shading which represents contour, not surface decoration.












