FIG. 13 is a side elevational view thereof;

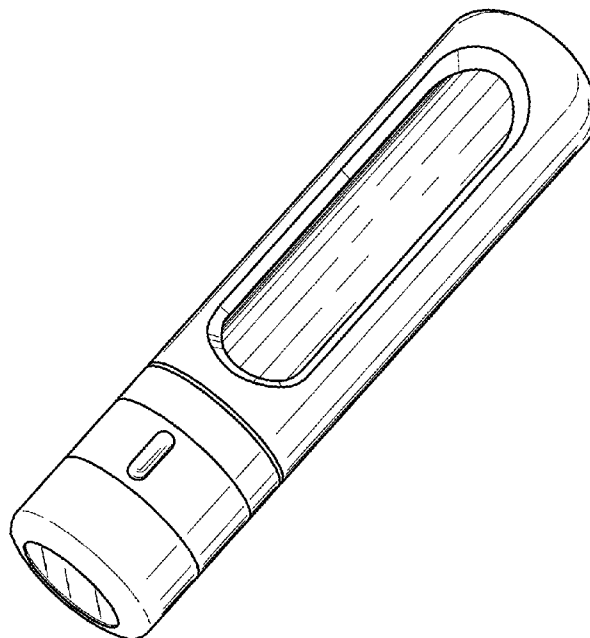
FIG. 14 is a side elevational view thereof;

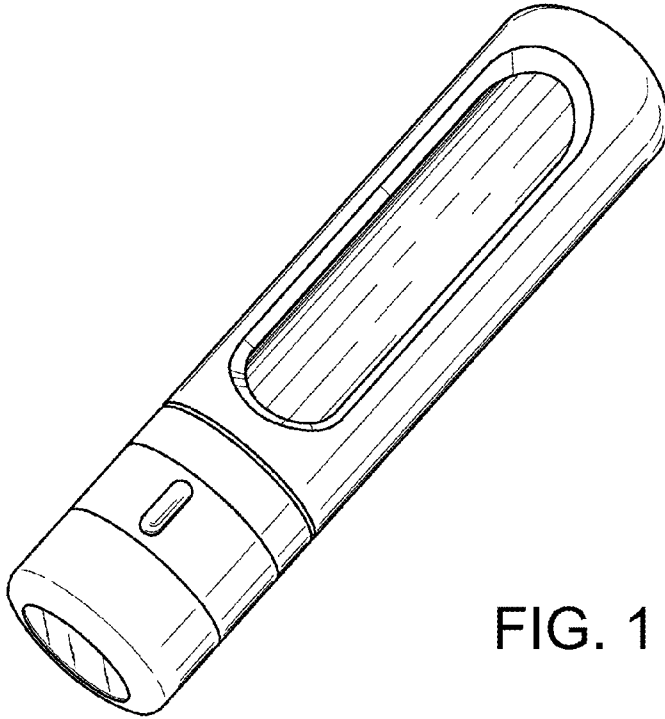

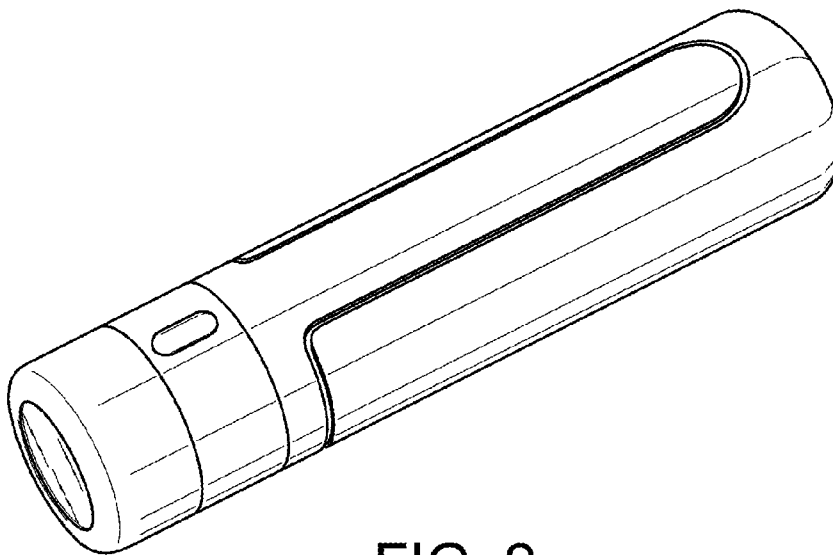

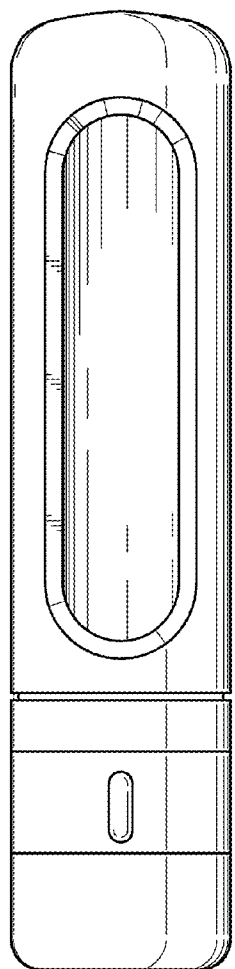

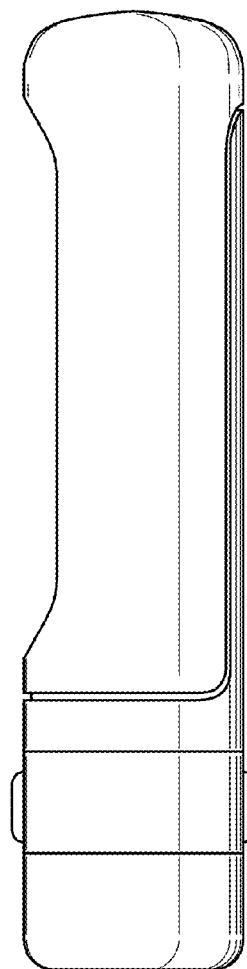

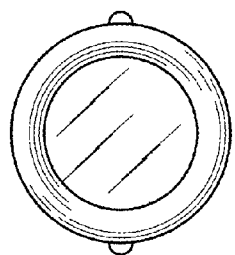

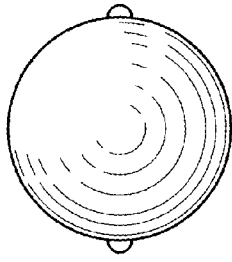

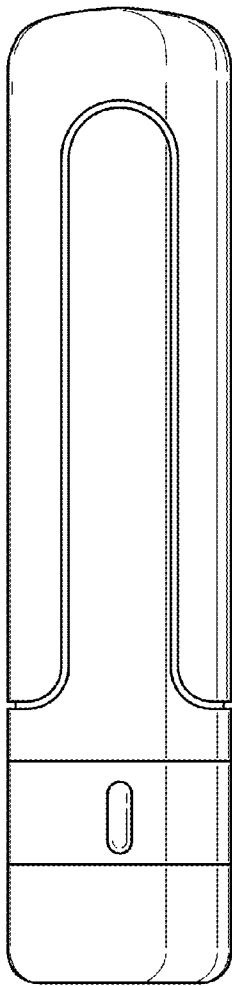

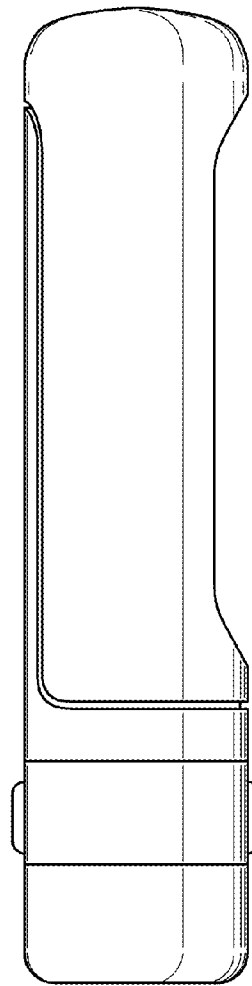

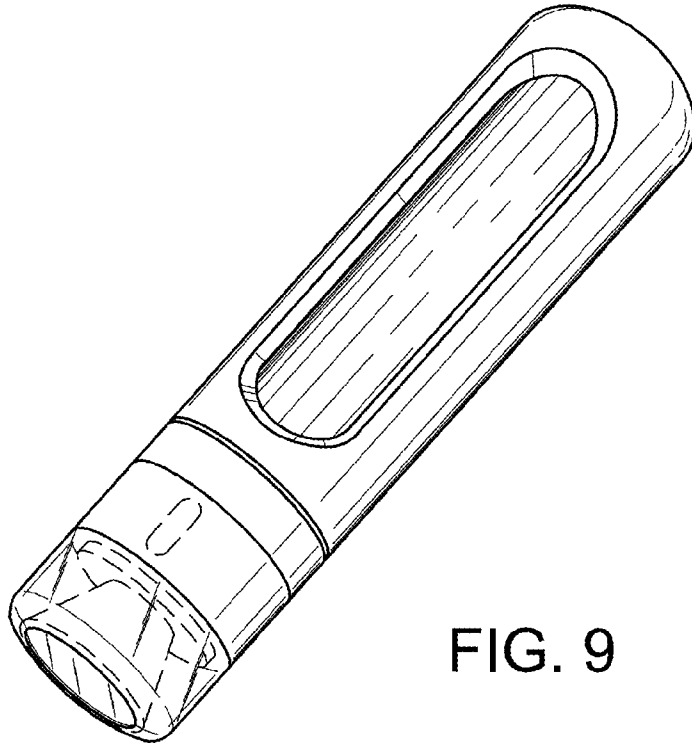

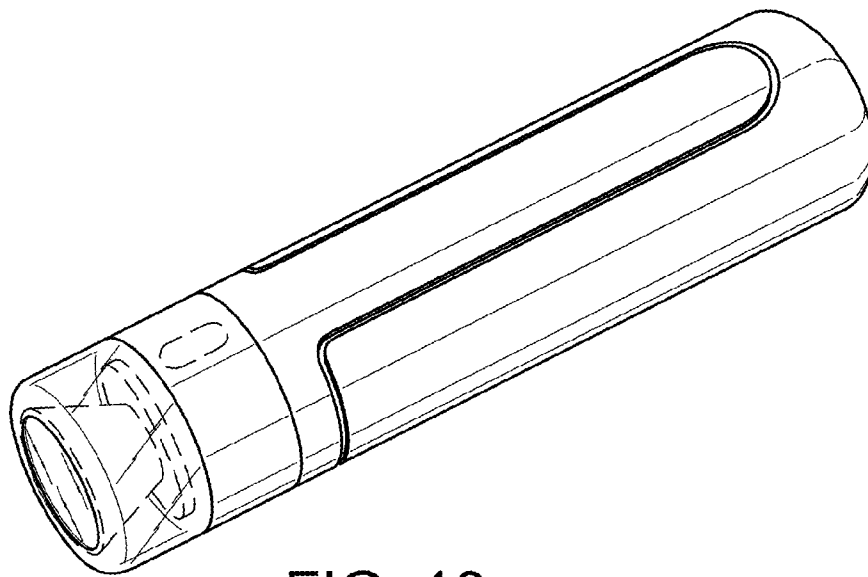

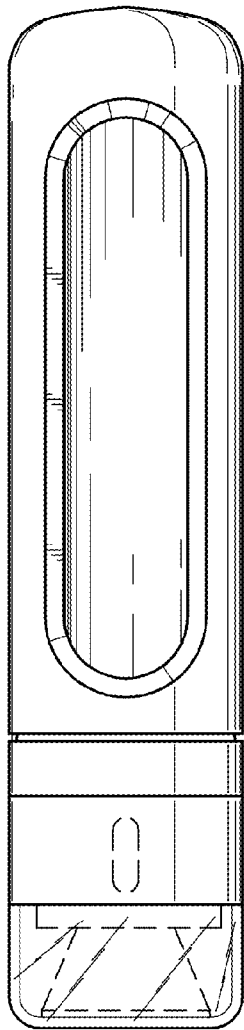

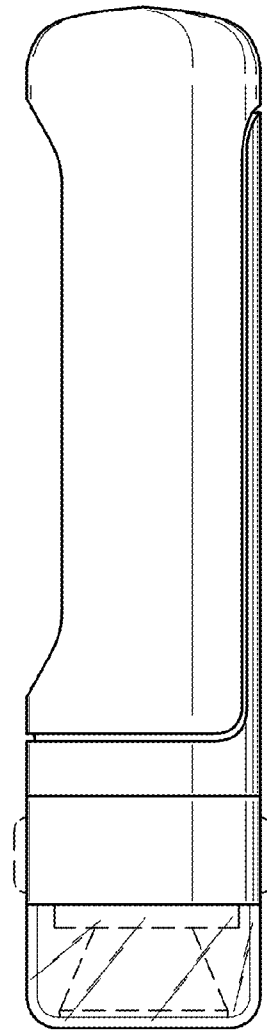

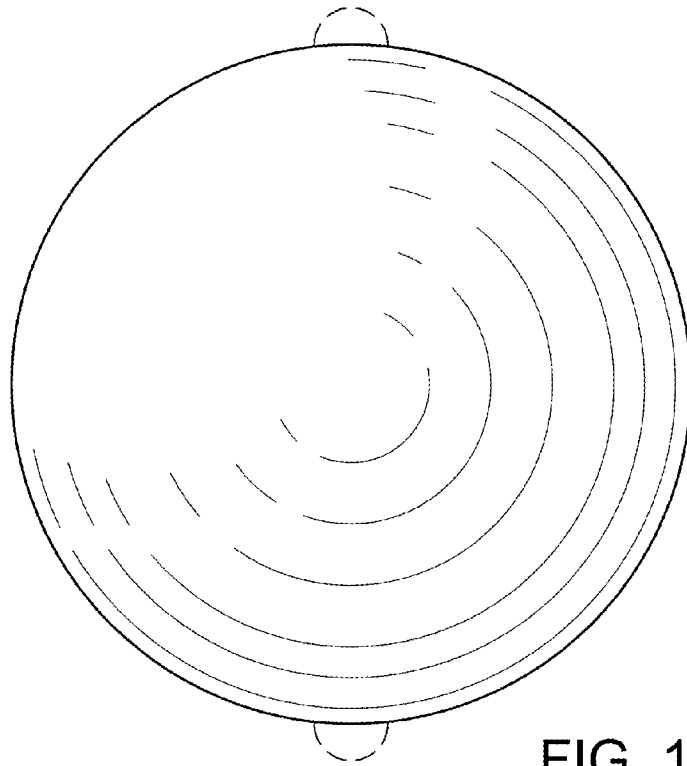

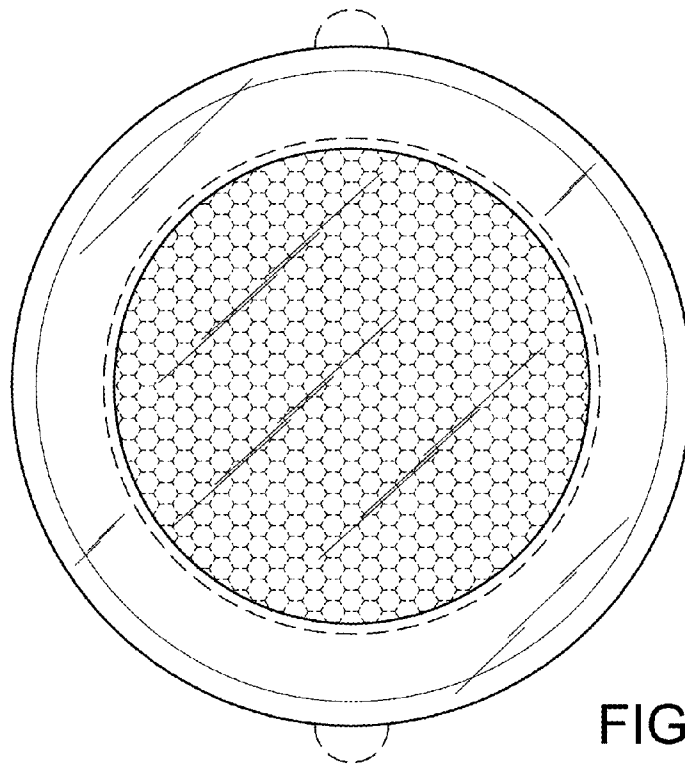

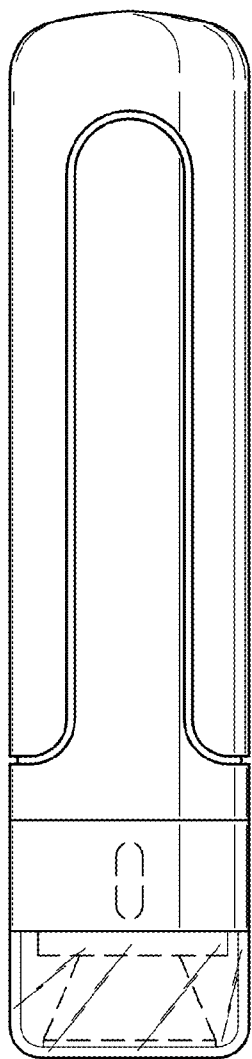

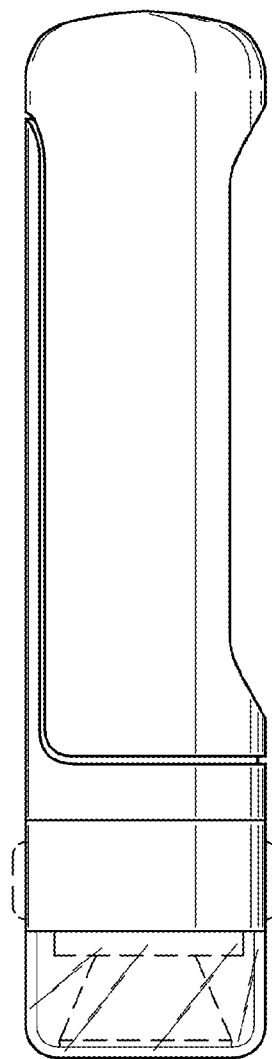
