FIG. 4 is a right side view thereof.

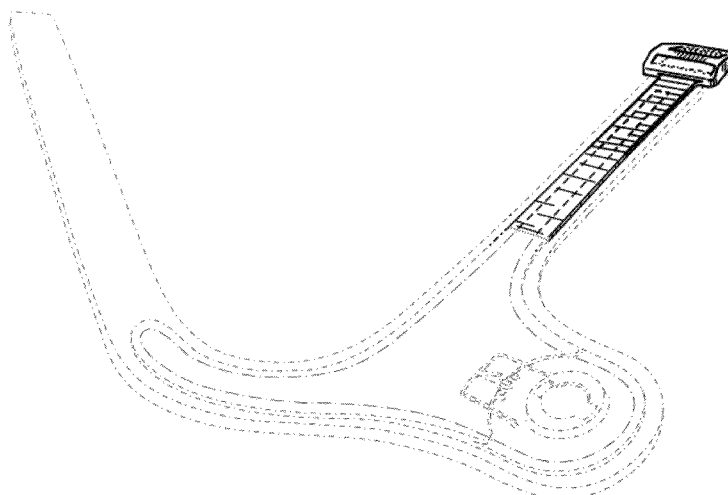
The dash-dot-dash lines in the drawing figures are included to show unclaimed portions only and form no part of the claimed design.

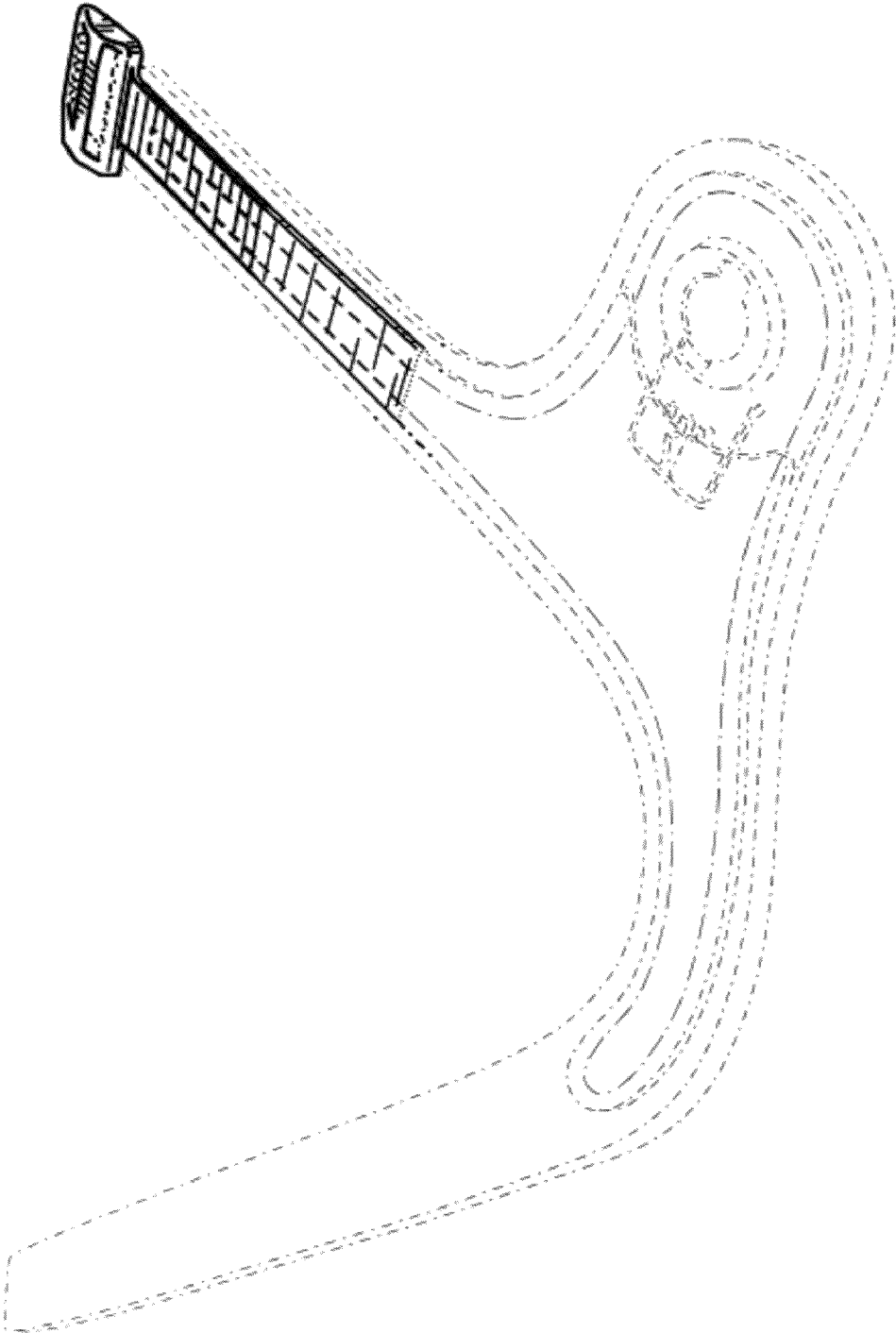

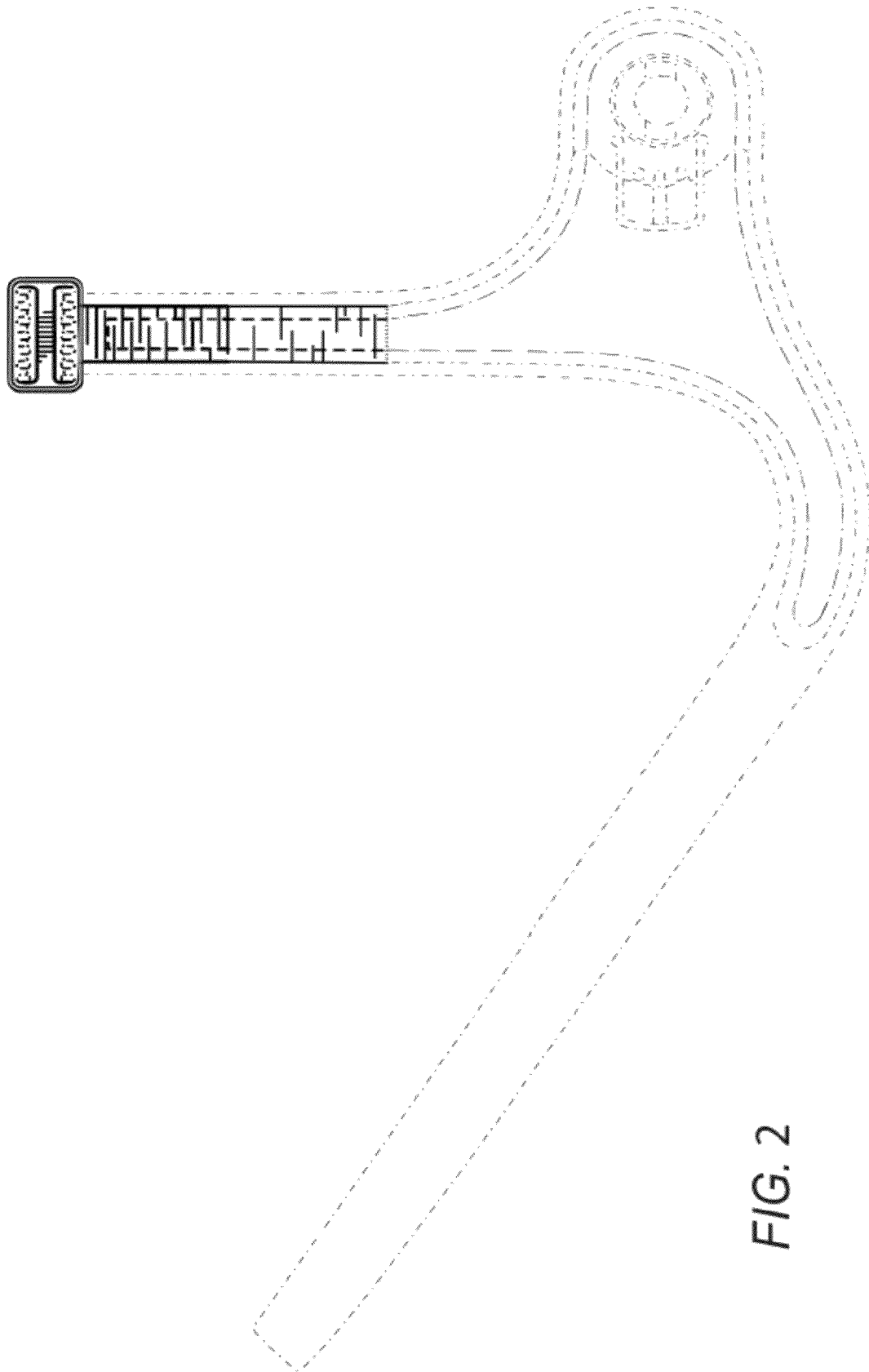

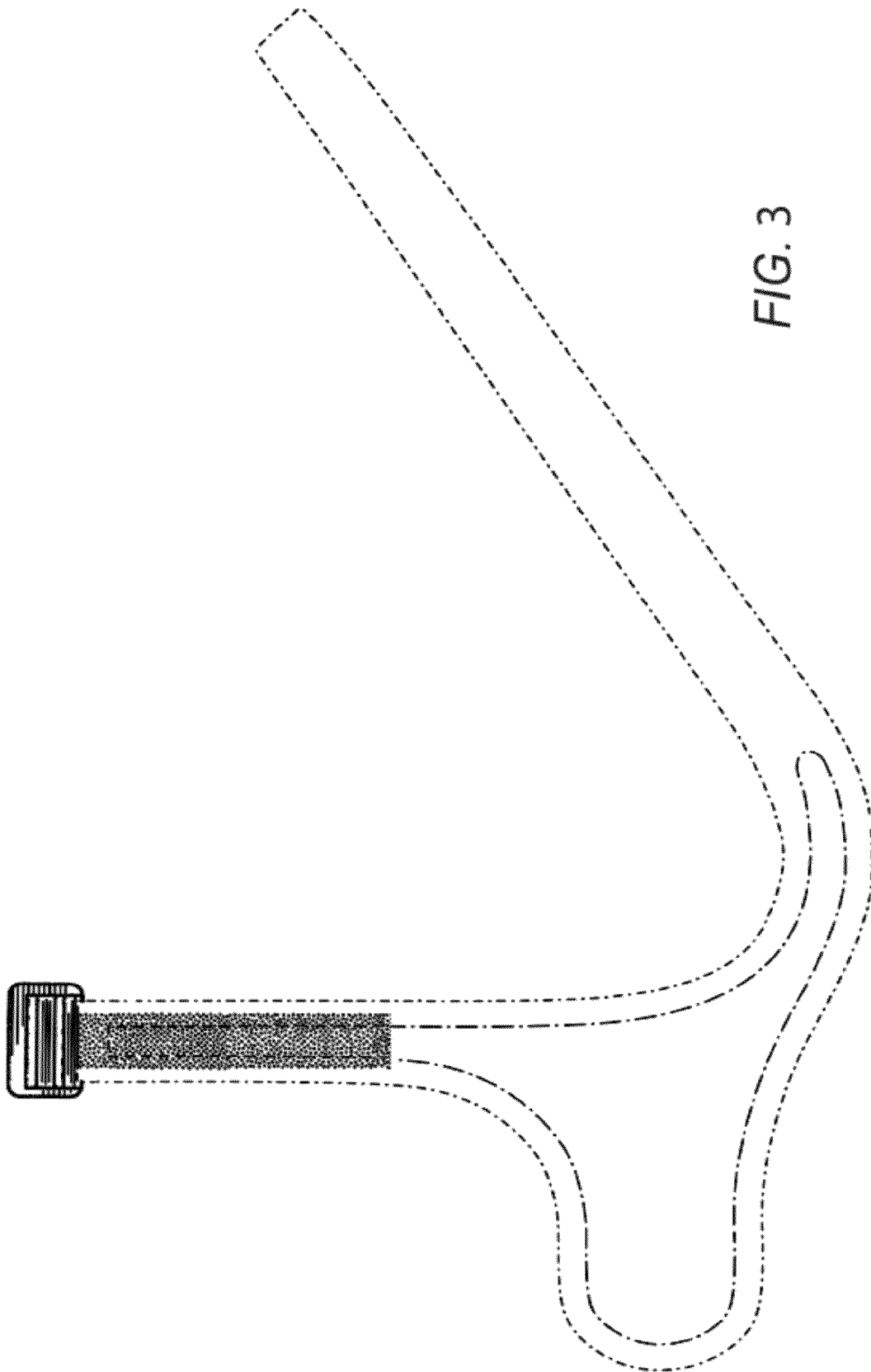
