

(54) Title: PAYMENT INFRASTRUCTURE



(57) Abstract: A computer system for processing a withdrawal request to withdraw funds from an account, for example a banking or non-banking account which does not allow direct cash withdrawals, which mediates between an account host and a payment host and issues a physical object such as a scrip which can be redeemed against the amount in cash by verifying a payment number associated with the physical object against the payment host. The payment host may be part of a bookmakers betting clearing system and the account host may be part of an online gambling or betting system. The payment host may also be part of a integrated till system at a chain of retail premises. Corresponding methods and computer programs are also provided.
