The ornamental design for a band, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a first embodiment of a band showing our new design;

FIG. 2 is a bottom perspective view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a top view thereof;

FIG. 5 is a right side view thereof, the left side view being a mirror image;

FIG. 6 is a first end view thereof;

FIG. 7 is an opposing second end view thereof;

FIG. 8 is a perspective view thereof in a configuration in which the band may be used;

FIG. 9 is a top perspective view of a second embodiment thereof;

FIG. 10 is a bottom perspective view of FIG. 9;

FIG. 11 is a bottom view of FIG. 9;

FIG. 12 is a top view of FIG. 9;


FIG. 13 is a right side view of FIG. 9;






























