FIG. 1 is a perspective view of an applicator suppository injector showing my new design;

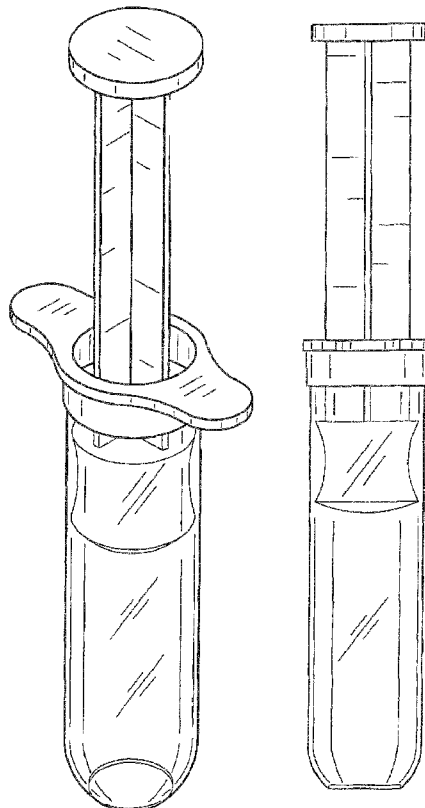
FIG. 2 is a front elevation view, the rear elevation view being the same image thereof;

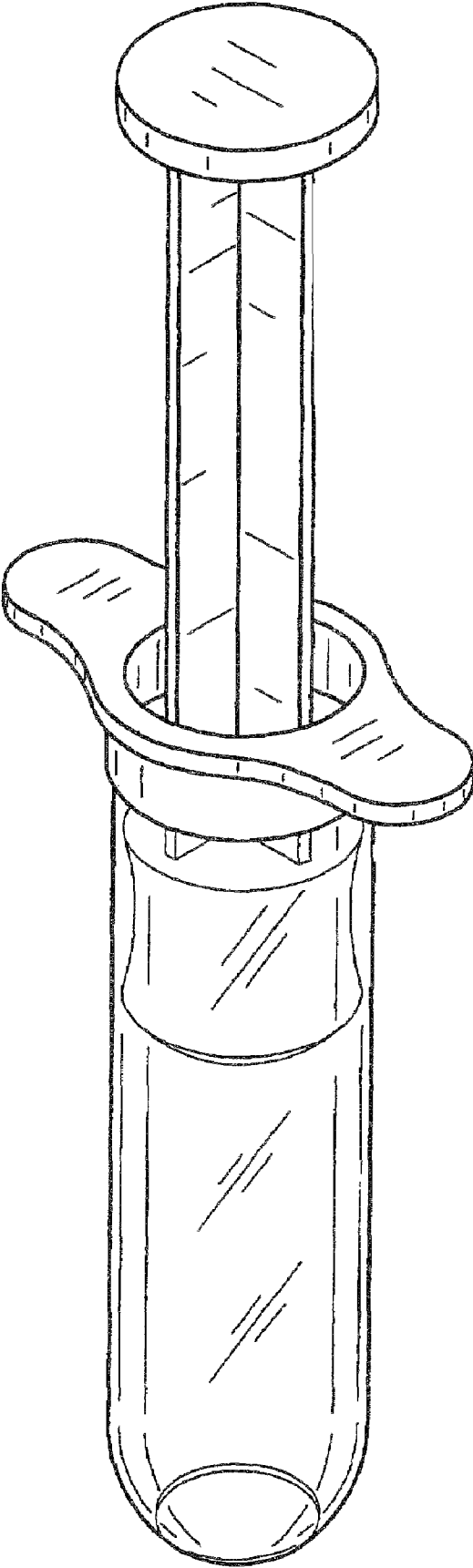

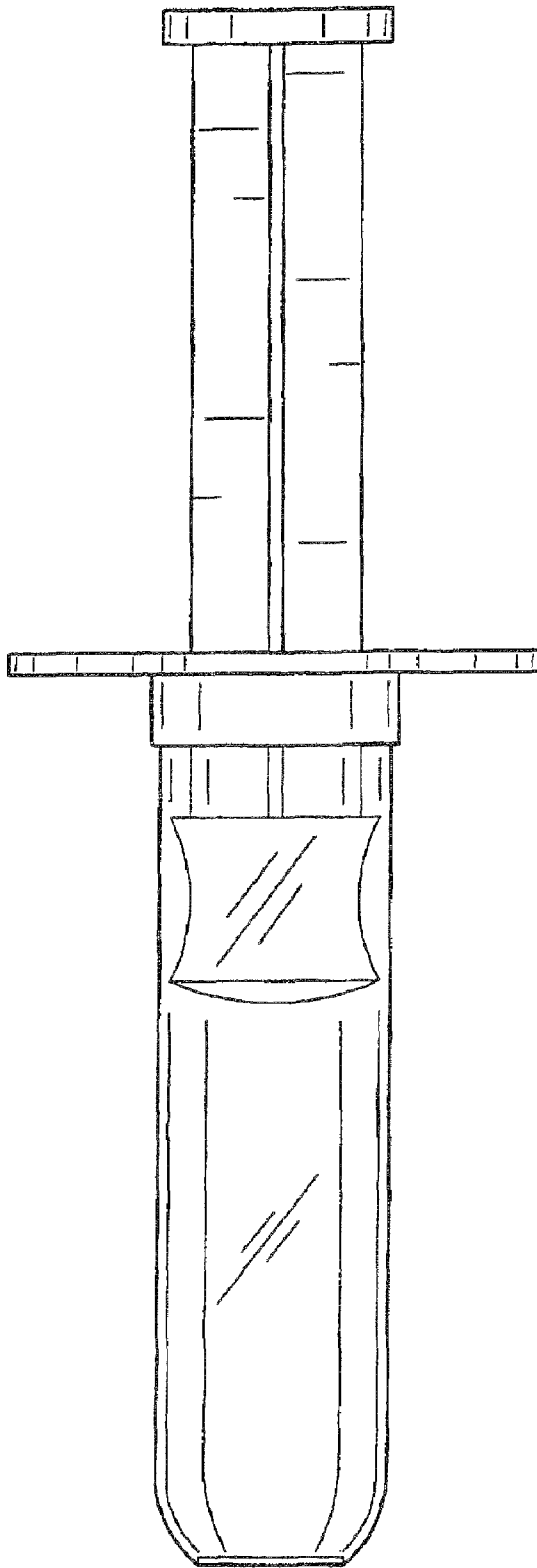

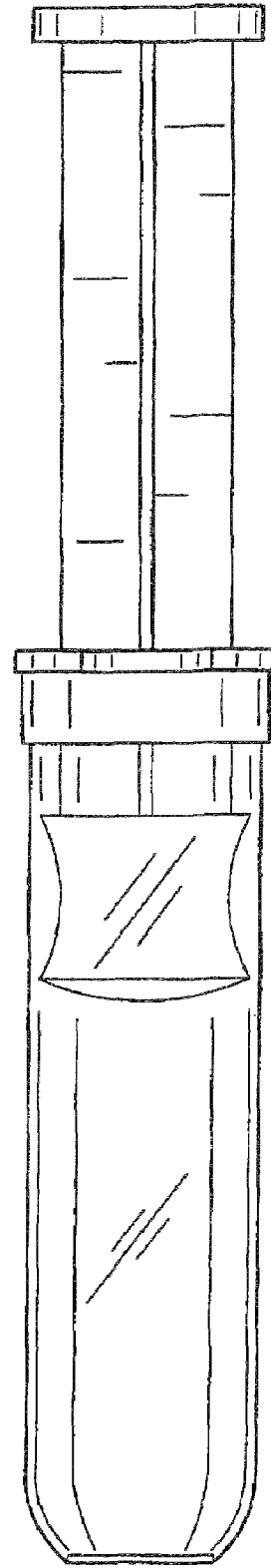

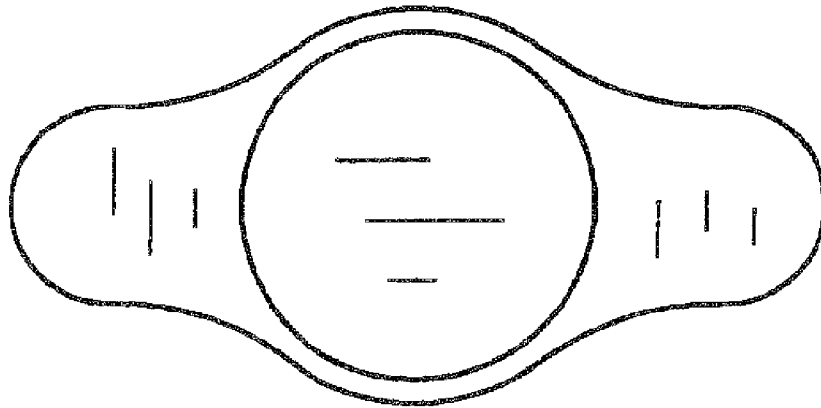

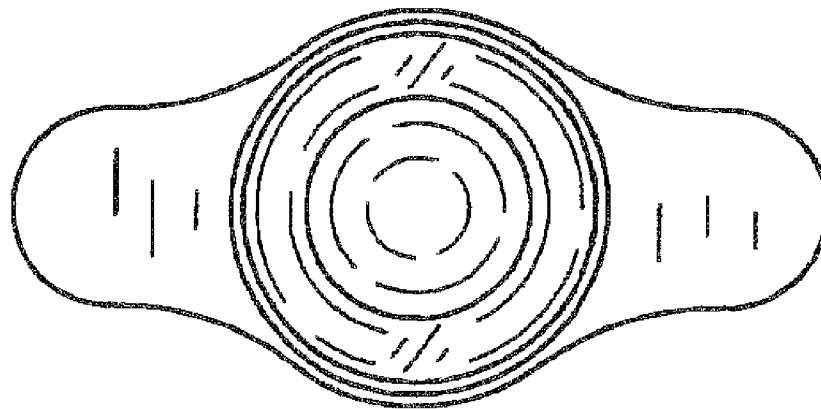
