


(57) CLAIM

The ornamental design for a light reflector, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a light reflector, as viewed from above, showing my new design; FIG. 2 is a perspective view of the light reflector shown in FIG. 1, as viewed from below; FIG. 3 is a left side view of the light reflector shown in FIG. 1; FIG. 4 is a right side view of the light reflector shown in FIG. 1; FIG. 5 is a front elevation view of the light reflector shown in FIG. 1;

FIG. 6 is a rear elevation view of the light reflector shown in FIG. 1;

FIG. 7 is a top plan view of the light reflector shown in FIG. 1;

FIG. 8 is a bottom plan view of the light reflector shown in FIG. 1;

FIG. 9 is a perspective view of a second embodiment of a light reflector, stippled for a contrasted color or surface finish appearance, as viewed from above, showing my new design;

FIG. 10 is a perspective view of the light reflector shown in FIG. 9, as viewed from below;

FIG. 11 is a left side view of the light reflector shown in FIG. 9;

FIG. 12 is a right side view of the light reflector shown in FIG. 9;

FIG. 13 is a front elevation view of the light reflector shown in FIG. 9;

FIG. 14 is a rear elevation view of the light reflector shown in FIG. 9;

FIG. 15 is a top plan view of the light reflector shown in FIG. 9;

FIG. 16 is a bottom plan view of the light reflector shown in FIG. 9;

FIG. 17 is a perspective view of a third embodiment of a light reflector, stippled for a contrasted color or surface finish appearance, as viewed from above, showing my new design;

FIG. 18 is a perspective view of the light reflector shown in FIG. 1, as viewed from below;

FIG. 19 is a left side view of the light reflector shown in FIG. 1;

FIG. 20 is a right side view of the light reflector shown in FIG. 1;

FIG. 21 is a front elevation view of the light reflector shown in FIG. 1;

FIG. 22 is a rear elevation view of the light reflector shown in FIG. 1;

FIG. 23 is a top plan view of the light reflector shown in FIG. 1; and,

FIG. 24 is a bottom plan view of the light reflector shown in FIG. 1.

The broken-line disclosure shown in the views is understood to represent portions of the article in which the claimed design is embodied, but which form no part of the claimed design.

The stippling shown in the drawings illustrate portions of the light reflector to which color or surface treatment form a part of the claimed design, and the stippling itself forms no part of the claimed design.
















































