The ornamental design for a wainscot cap, as shown and described.


DESCRIPTION

FIG. 1 is a front perspective view of our wainscot cap;
FIG. 2 is a right side view thereof, the left side view being a mirror image thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof; and
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.
In the drawings the wainscot cap is fragmented to indicate indeterminate length.











