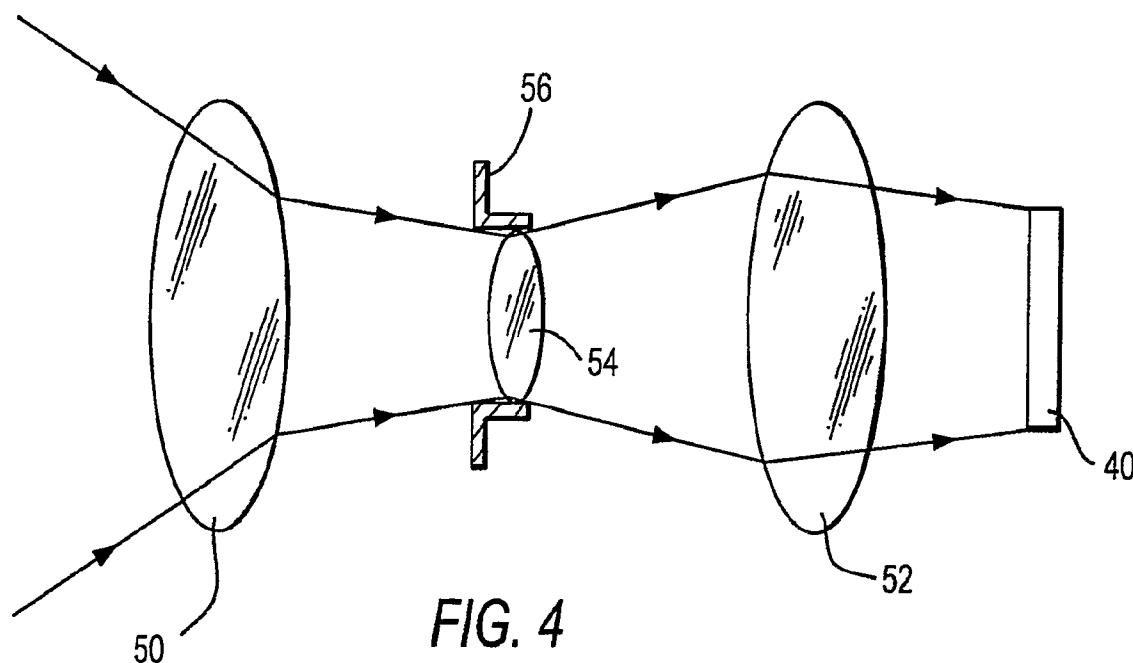

(54) **Title:** COMPACT IMAGING LENS ASSEMBLY IN IMAGING READER



(57) **Abstract:** A compact imaging lens assembly focuses light from indicia along an optical path onto a solid-state imager of an imaging reader. The lens assembly includes a pair of end focusing lenses of substantially a same size and spaced apart along the optical path, an intermediate lens between the end lenses, and an aperture stop between the end lenses.
