(57) **CLAIM**

The ornamental design for a garment hanger, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a garment hanger, showing my new design;

FIG. 2 is a front elevation view of the first embodiment, the rear elevation view is a mirror image thereto;

FIG. 3 is a top plan view of the first embodiment;

FIG. 4 is a bottom plan view of the first embodiment;

FIG. 5 is a left side elevation view of the first embodiment, the right side elevation view is a mirror image thereto;

FIG. 6 is a cross-sectional view of the first embodiment, taken along line 6—6 of FIG. 2;

FIG. 7 is a perspective view of a second embodiment of a garment hanger;

FIG. 8 is a front elevation view of the second embodiment, the rear elevation view is a mirror image thereto;

FIG. 9 is a top plan view of the second embodiment;

FIG. 10 is a bottom plan view of the second embodiment;

FIG. 11 is a left side elevation view of the second embodiment, the right side elevation view is a mirror image thereto;

FIG. 12 is a cross-sectional view of a second embodiment, taken along line 12—12 of FIG. 8;

FIG. 13 is a perspective view of a third embodiment of a garment hanger;

FIG. 14 is a front elevation view of the third embodiment;

FIG. 15 is a rear elevation view of the third embodiment;

FIG. 16 is a top plan view of the third embodiment;

FIG. 17 is a bottom plan view of the third embodiment;

FIG. 18 is a left side elevation view of the third embodiment, the right side elevation view is a mirror image thereto;

FIG. 19 is a cross-sectional view of the third embodiment, taken along line 19—19 of FIG. 14;

FIG. 20 is a perspective view of a fourth embodiment of a garment hanger;

FIG. 21 is a front elevation view of the fourth embodiment;

FIG. 22 is a rear elevation view of the fourth embodiment;

FIG. 23 is a top plan view of the fourth embodiment;

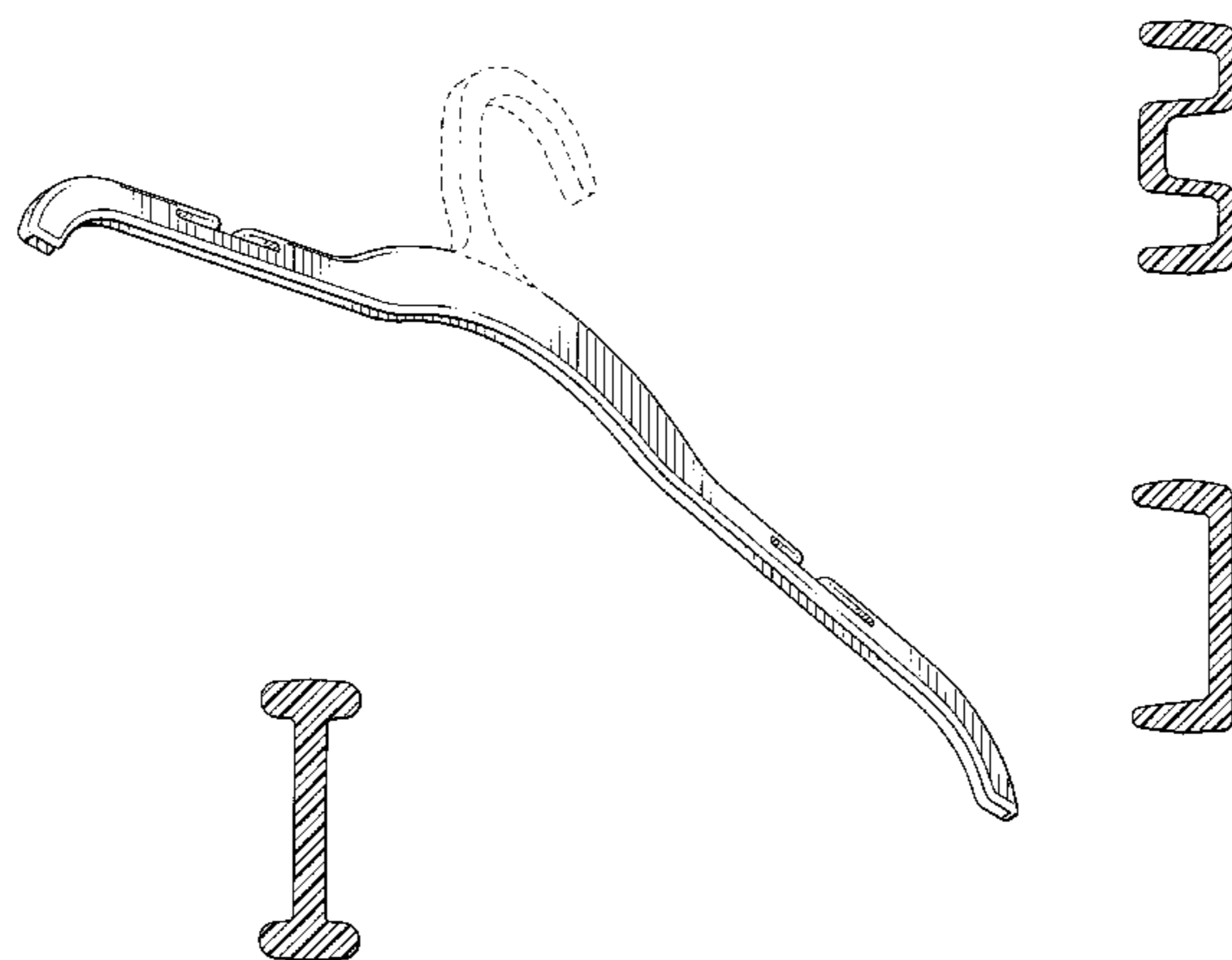
FIG. 24 is a bottom plan view of the fourth embodiment;

FIG. 25 is a left side elevation view of the fourth embodiment, the right side elevation view is a mirror image thereto; and,

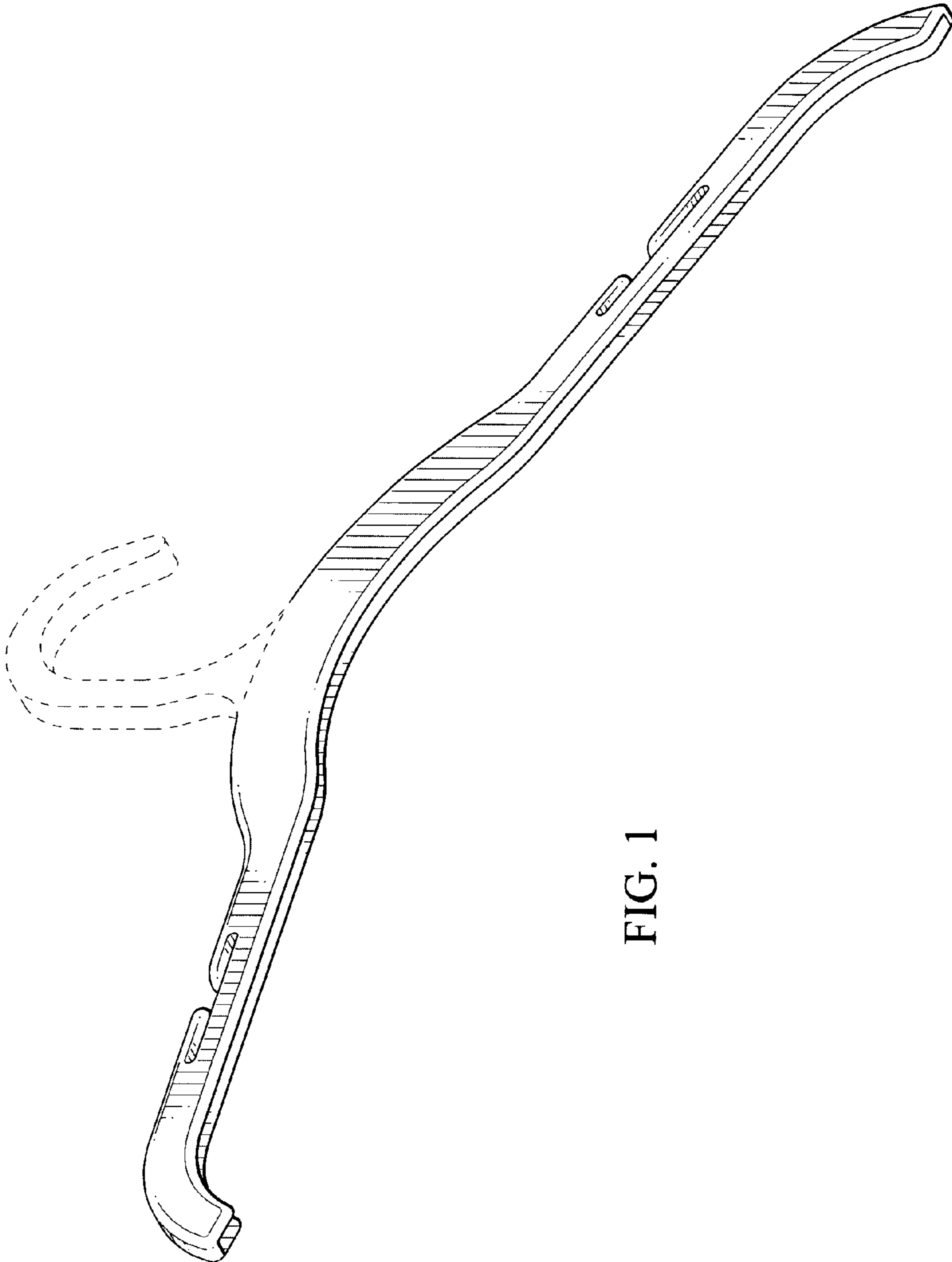

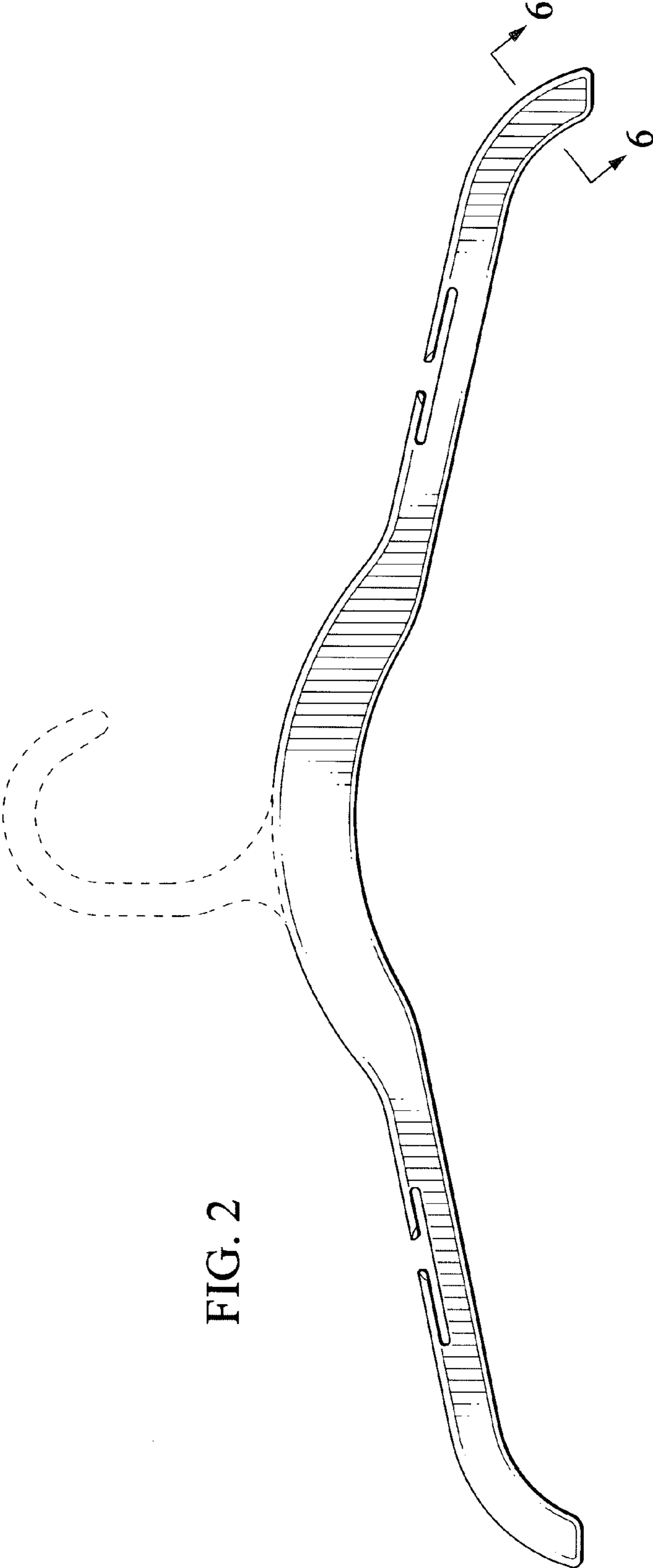

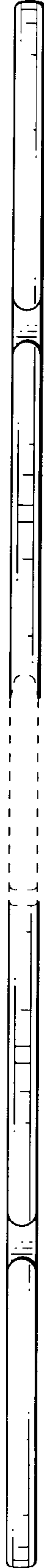

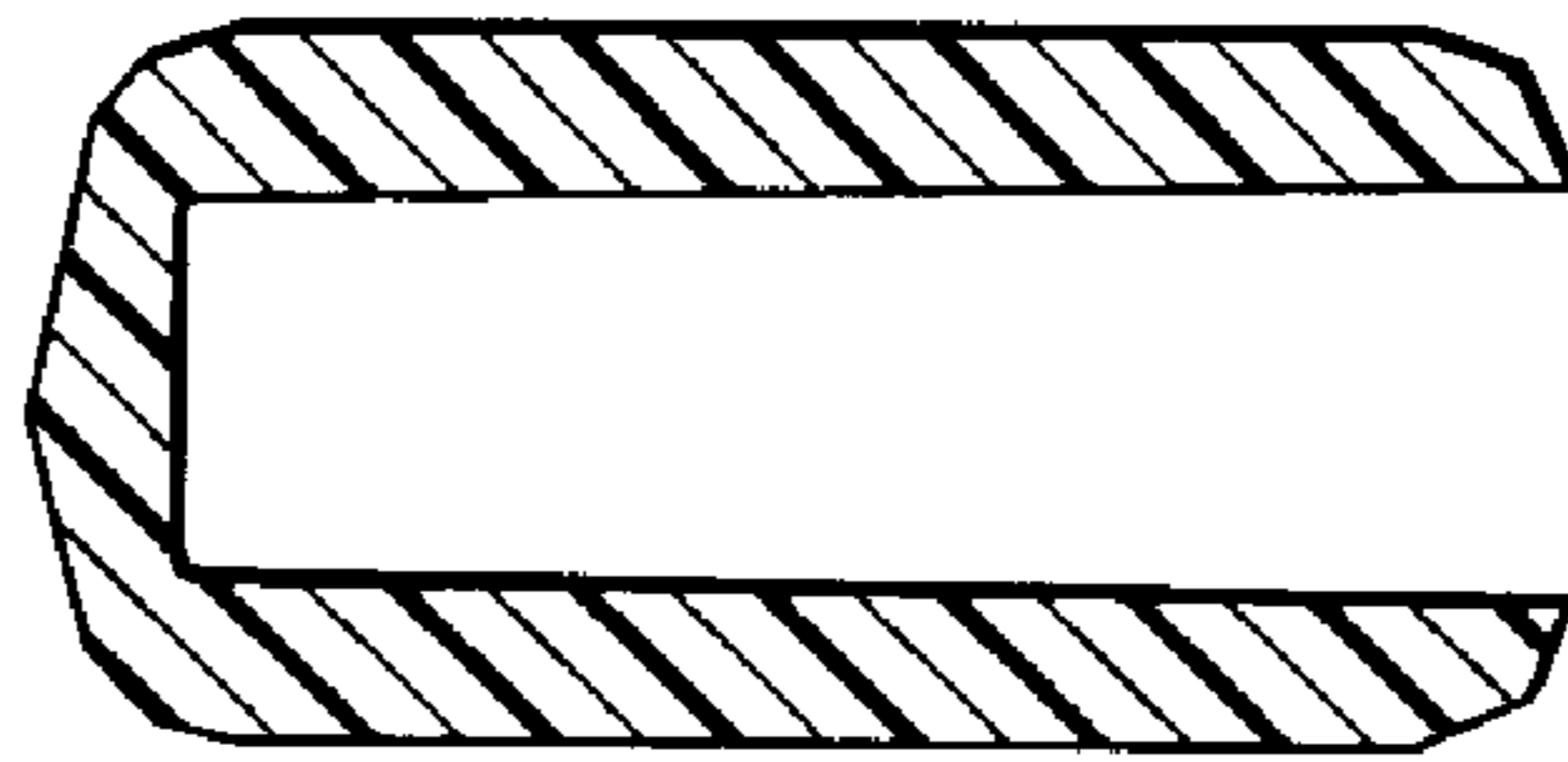

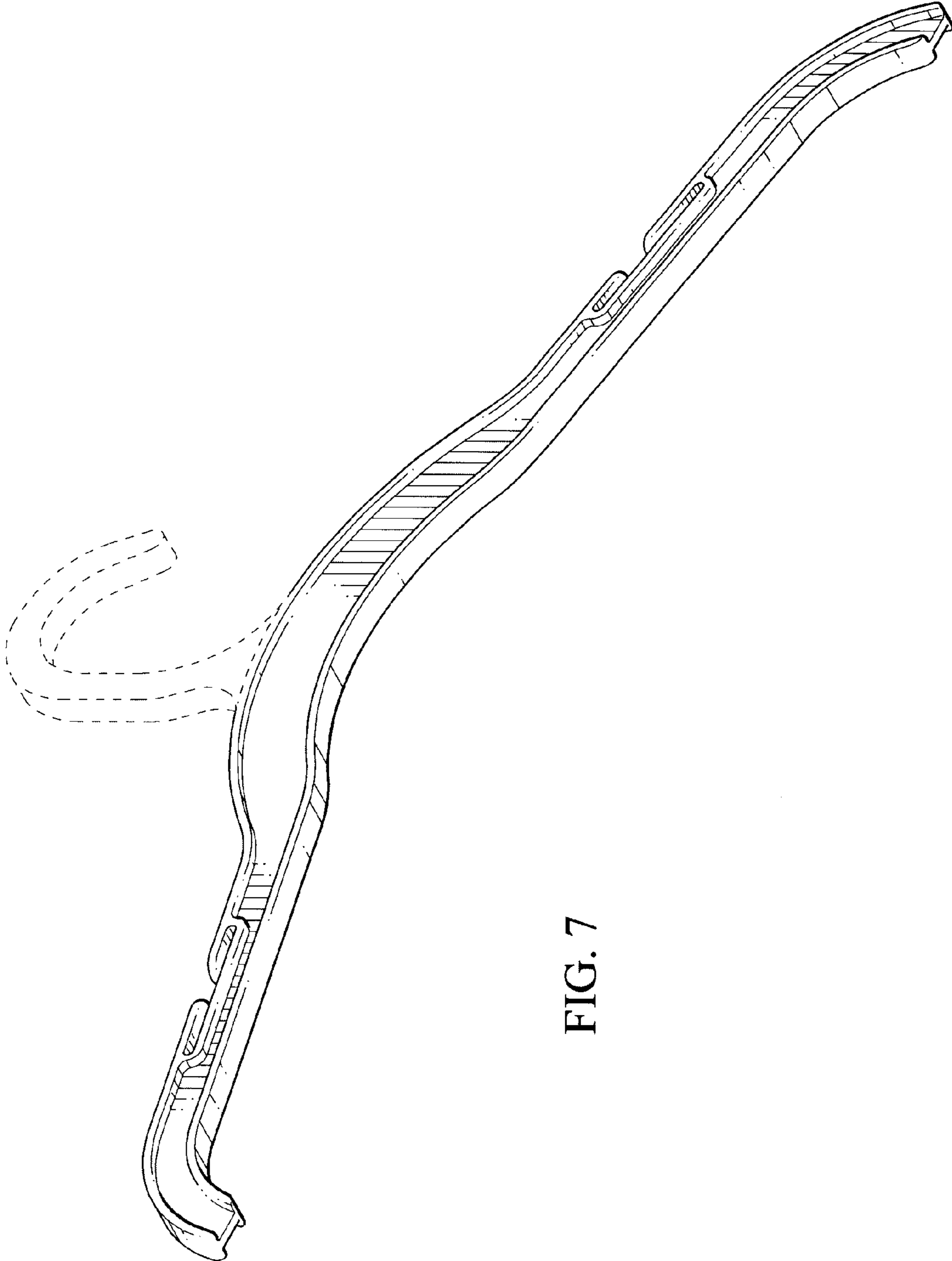

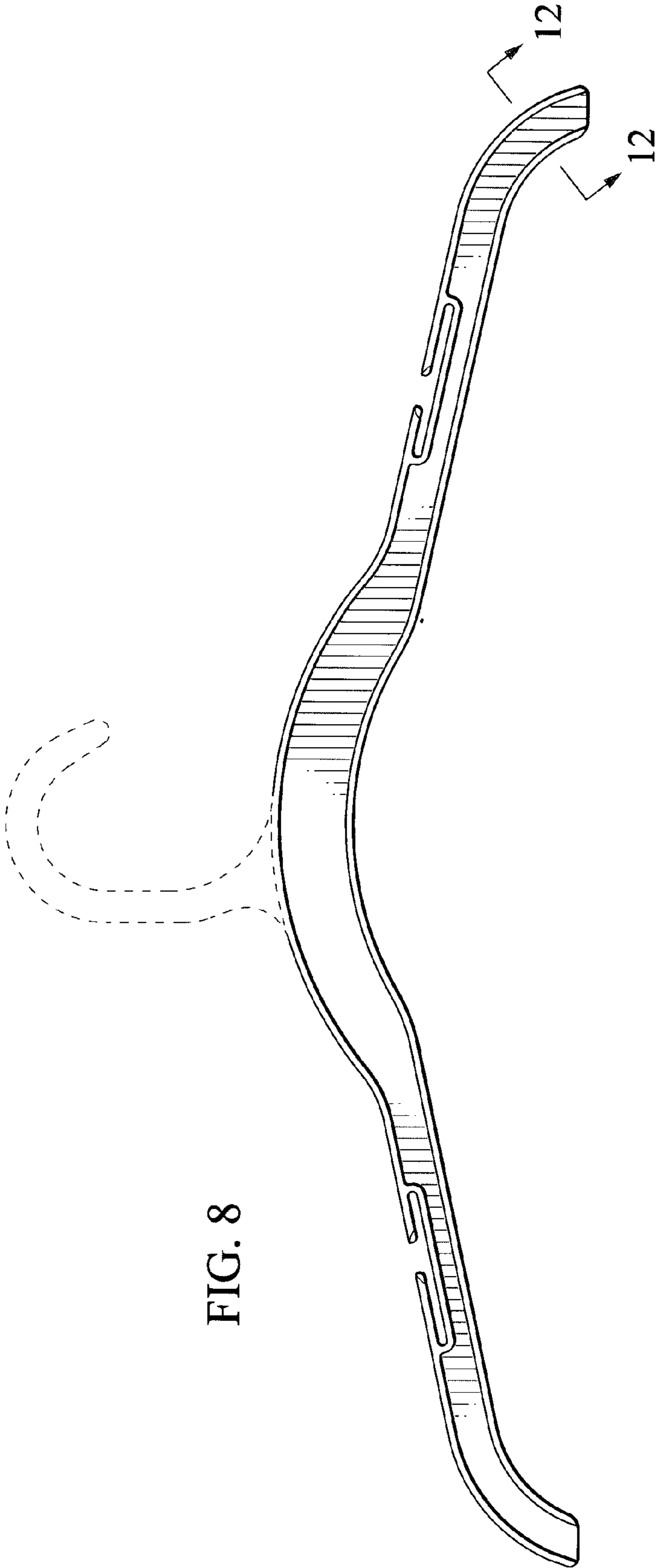

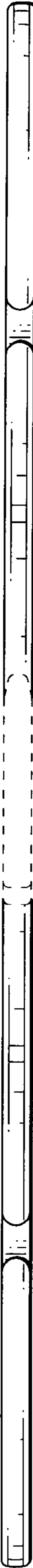

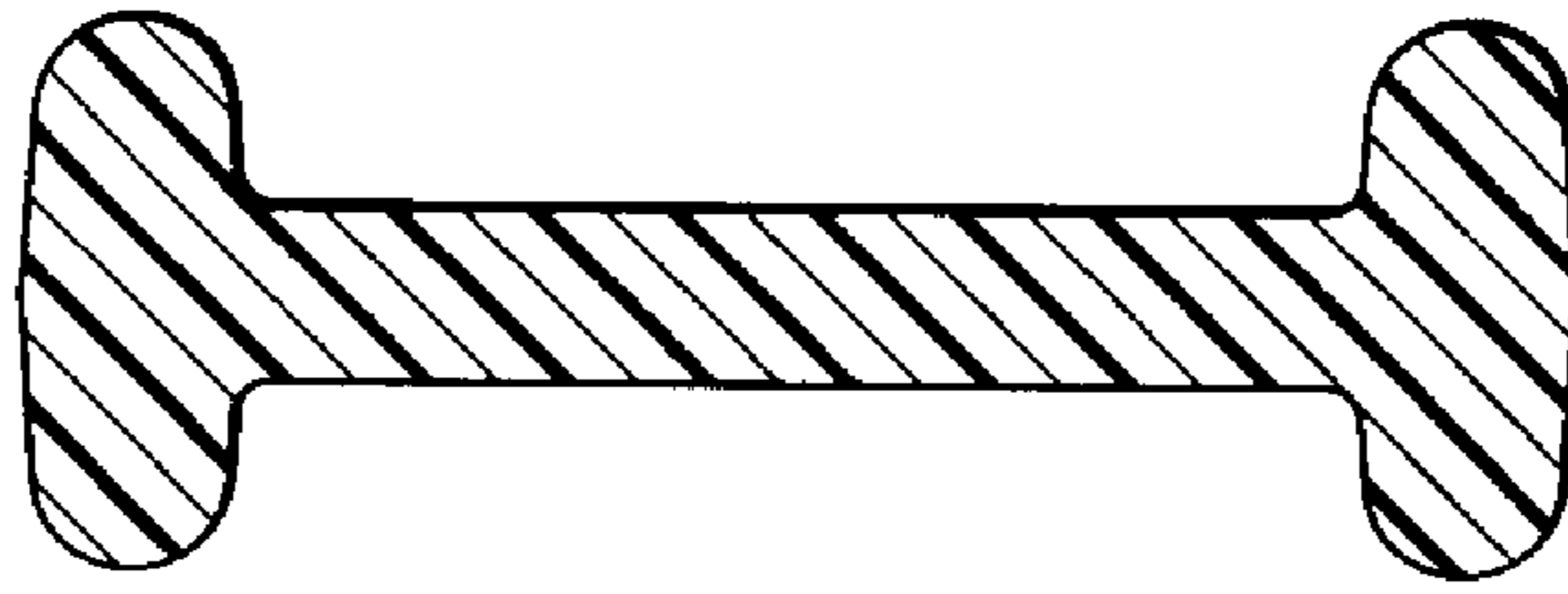

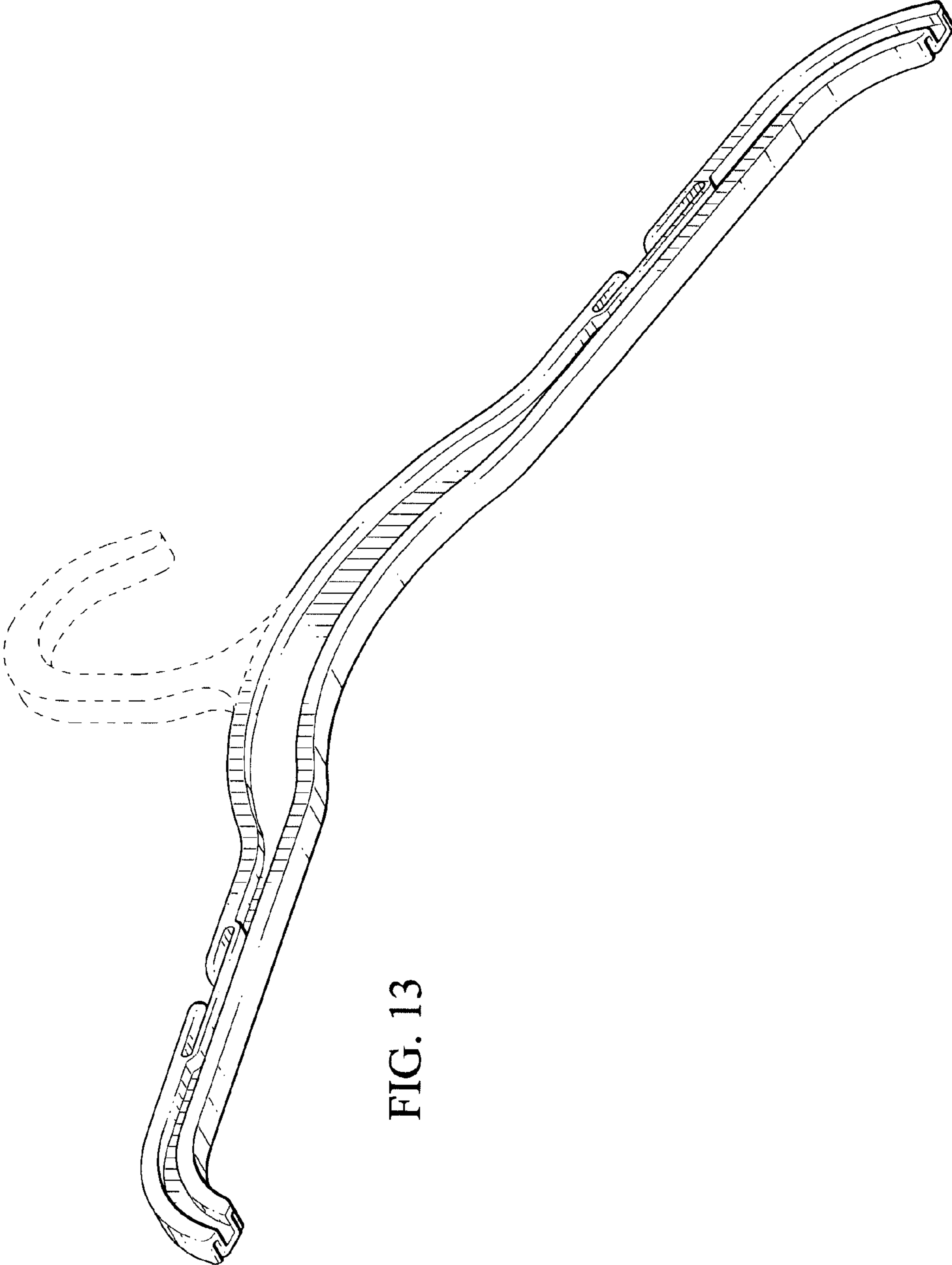

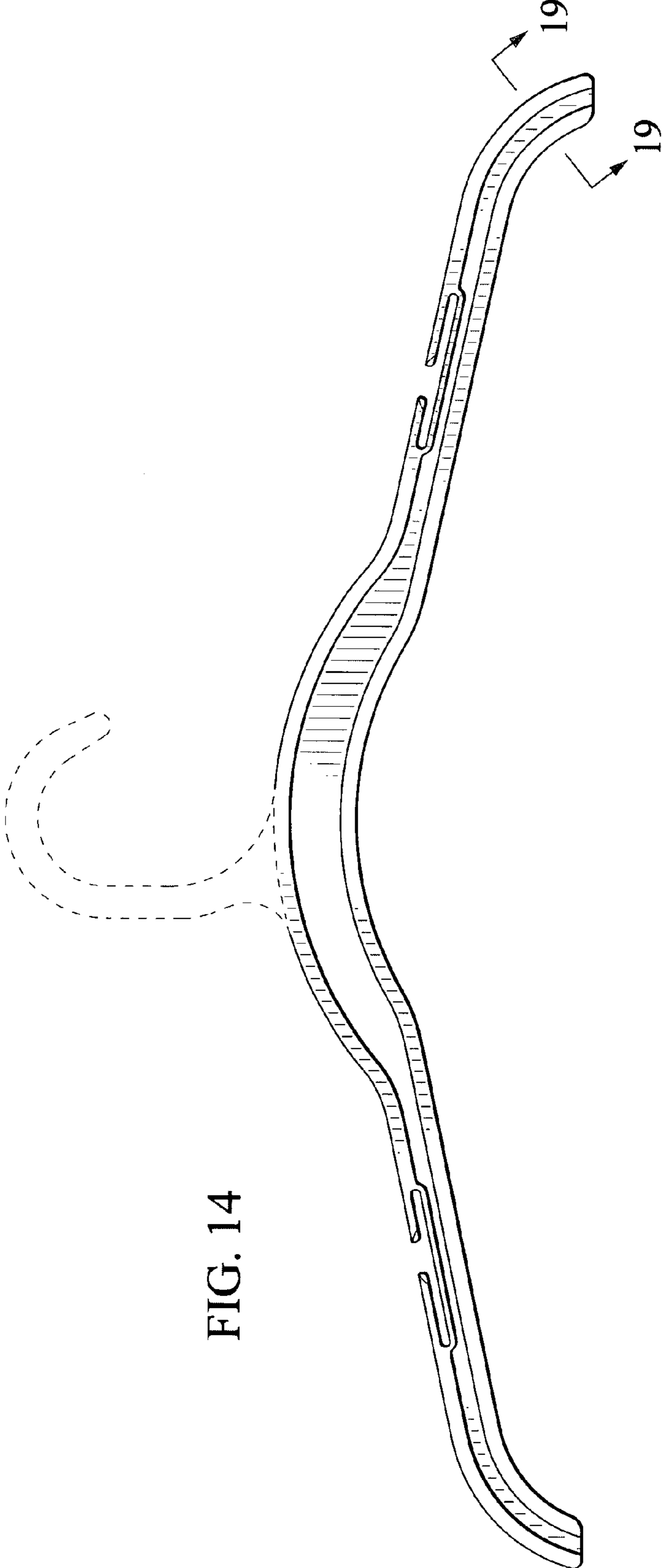

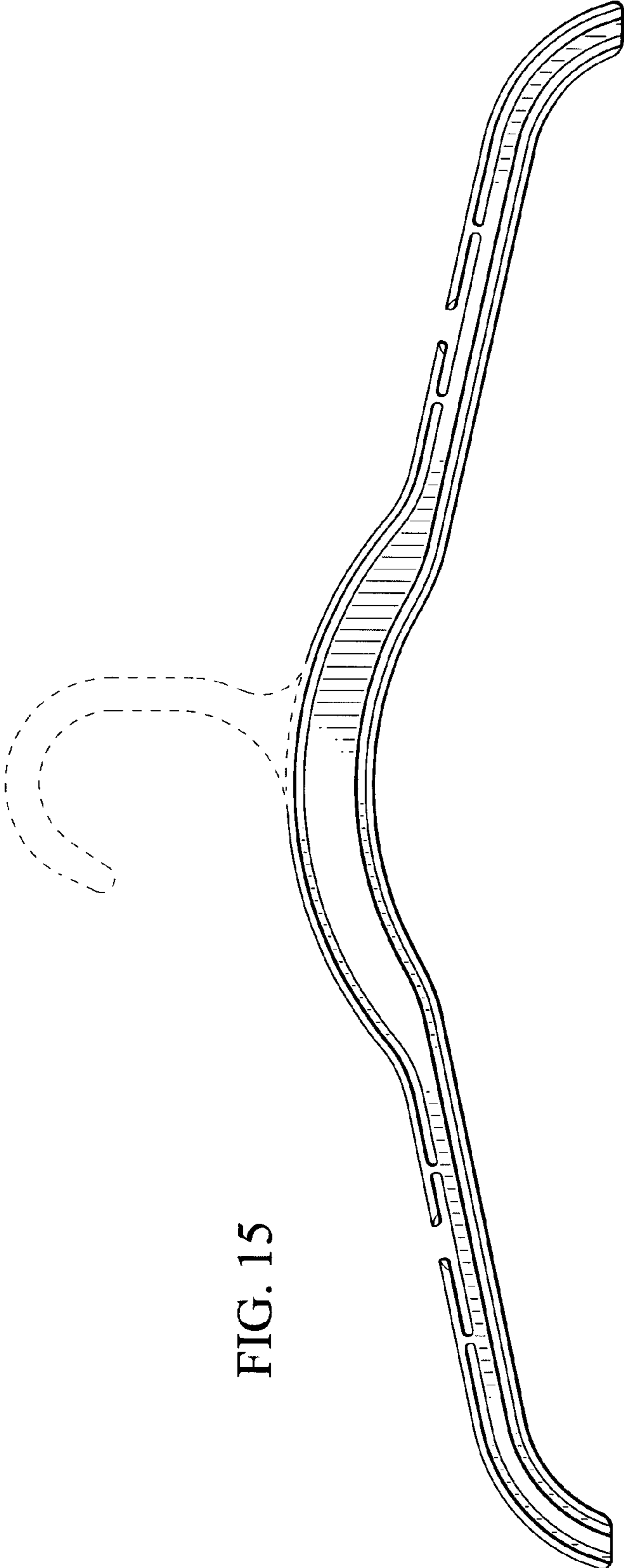

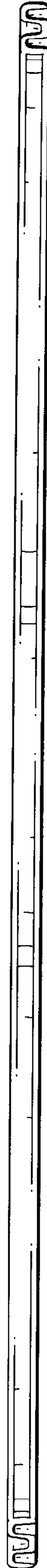

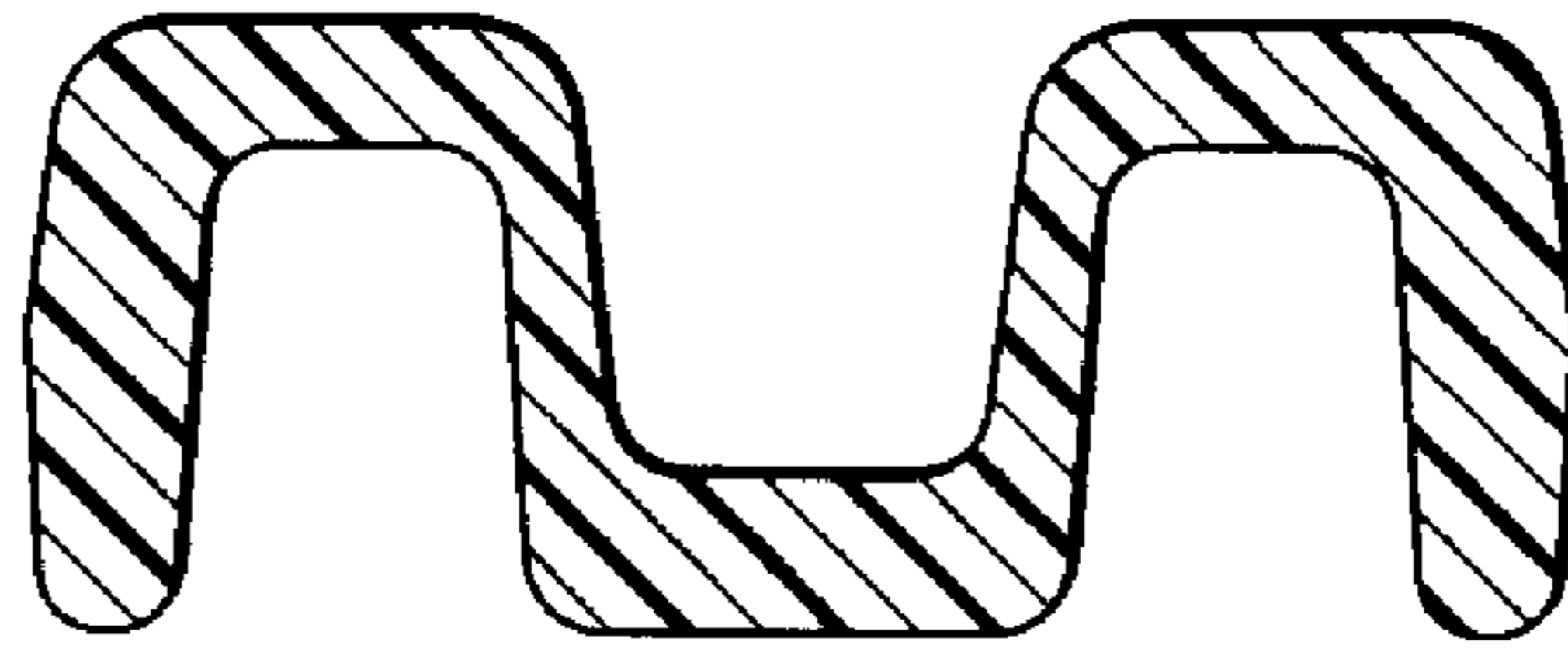

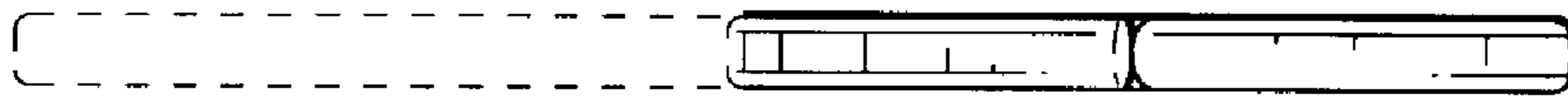

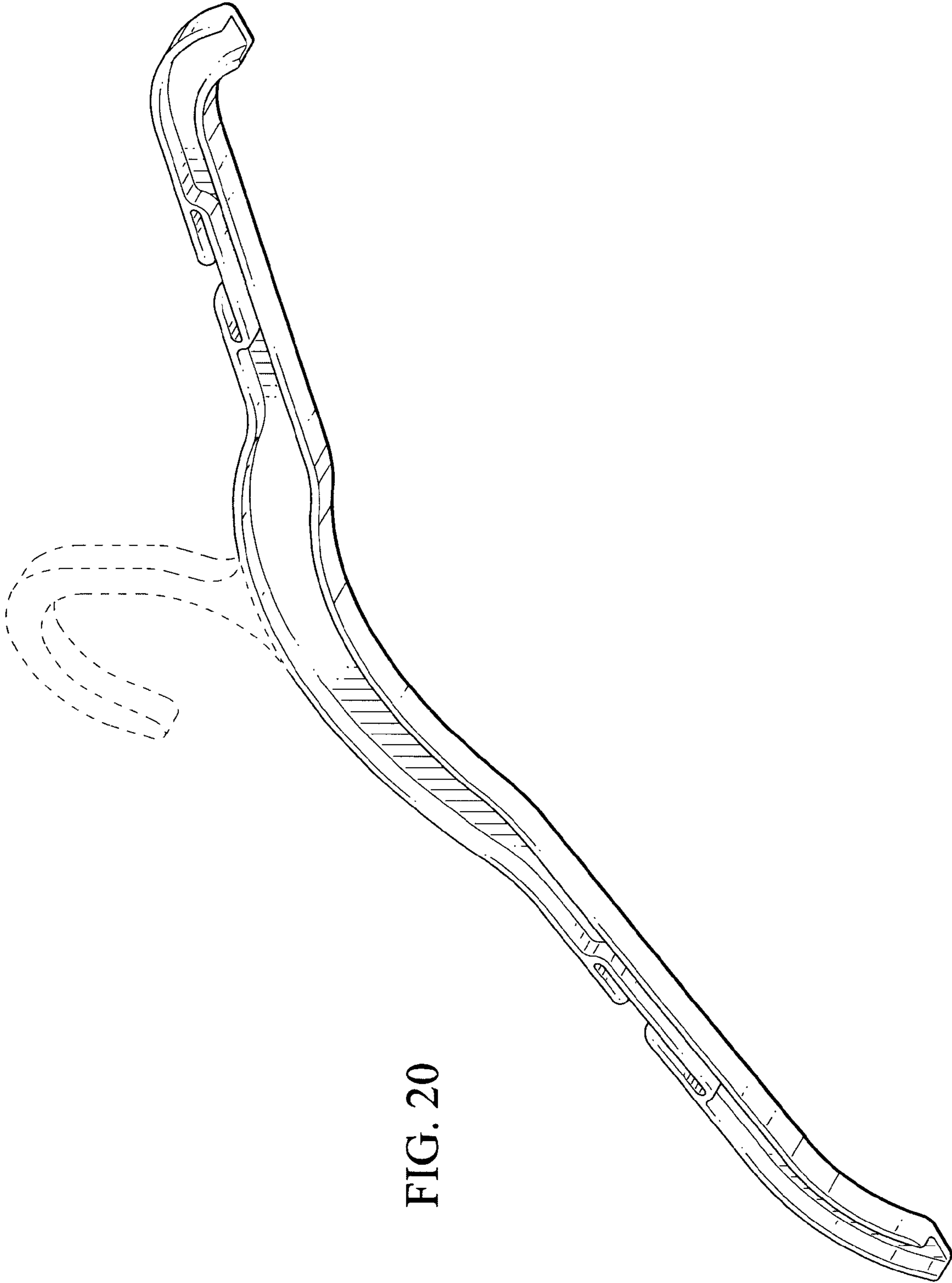

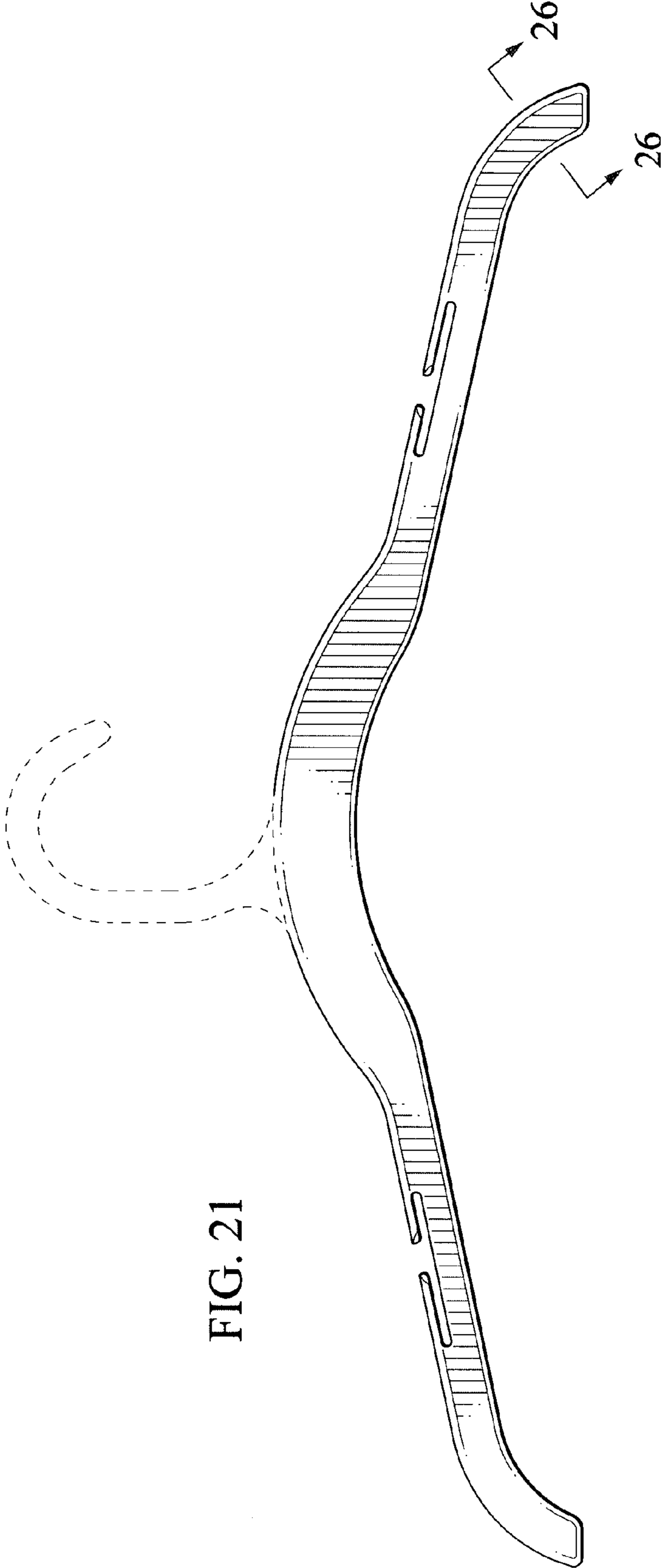

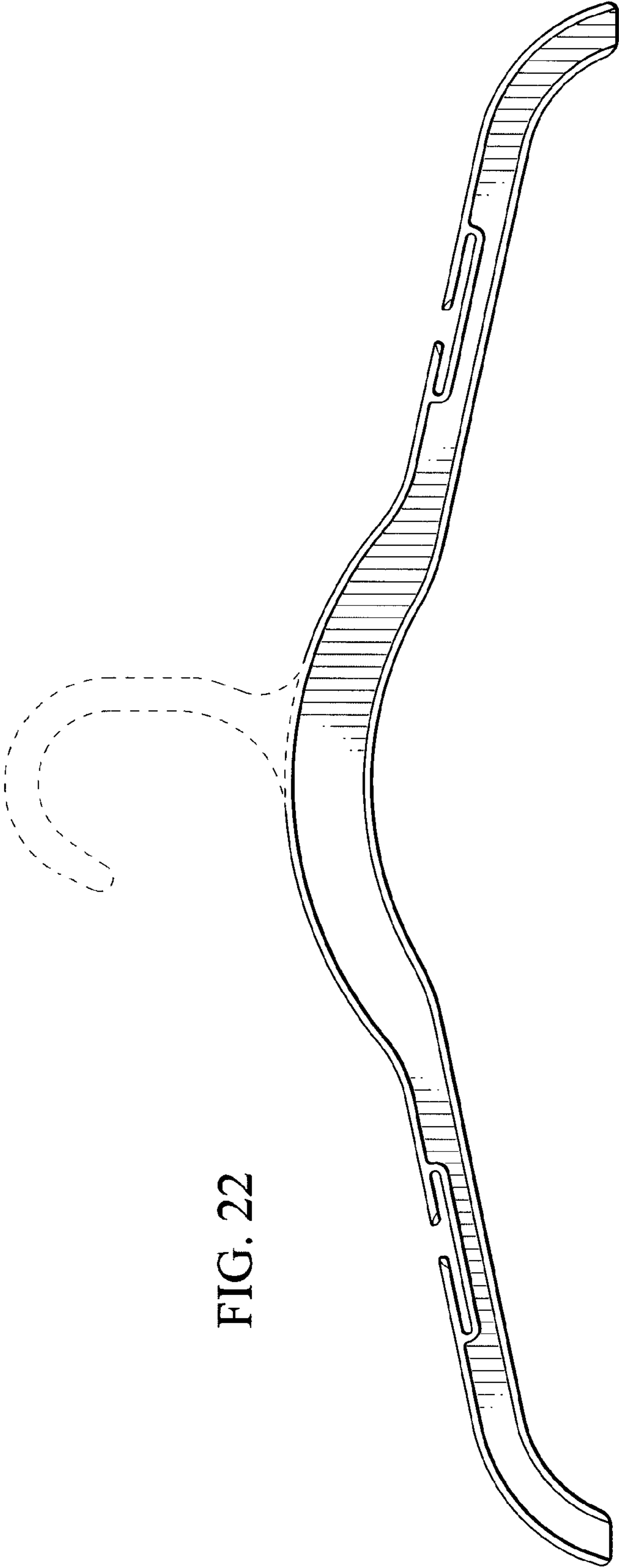

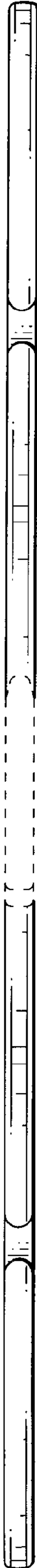

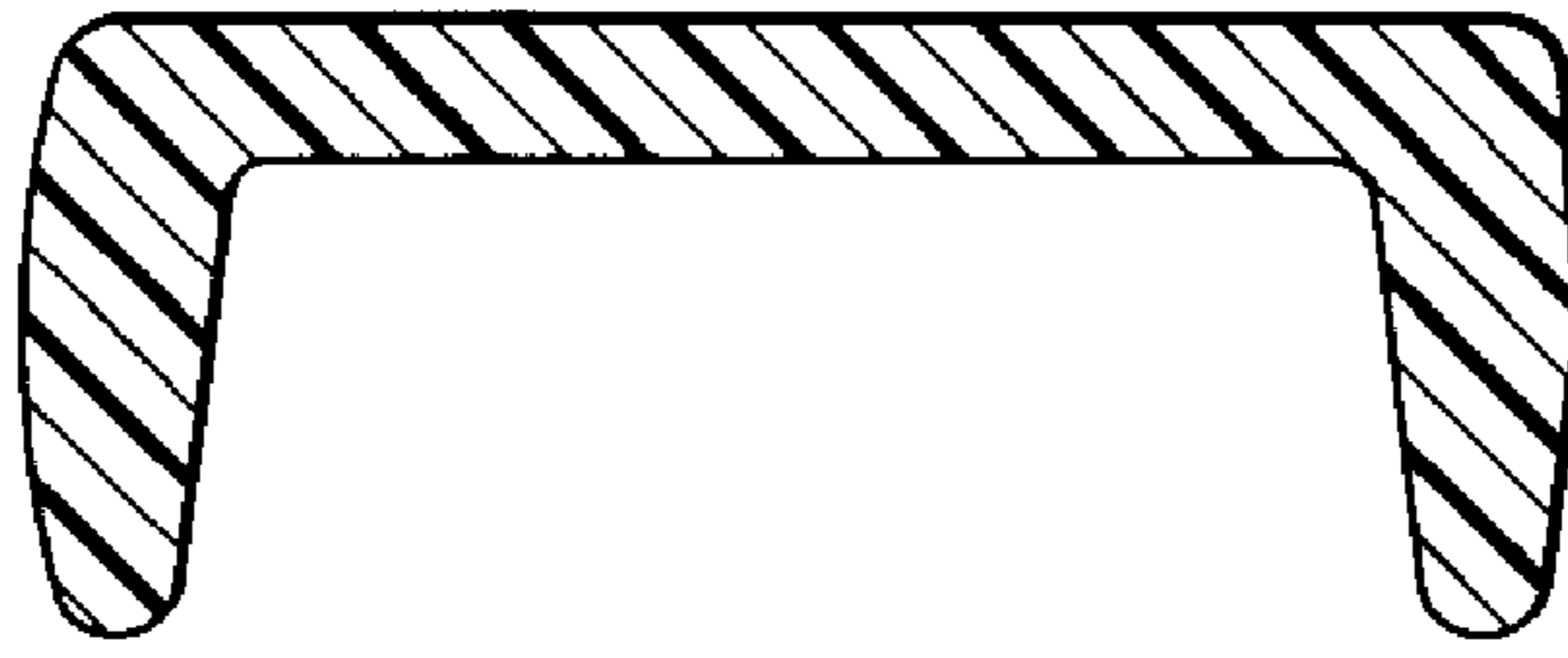

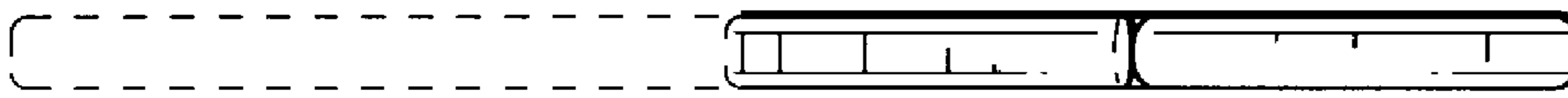
