

(54) Title: ONLINE REAL AND PERSONAL PROPERTY MANAGEMENT SYSTEM AND METHOD



(57) Abstract: A property management system and method (see Fig. 1). The system comprises a database (150) and one or more data records stored in the database. The first set of data is used to store data unique to the first property which is able to be used to manage the first property. A second set of data records are stored in the database. The second set is for storing data unique to a first owner of the first property. The data unique to the first owner is capable of being used for the first owner's management of the first property in combination with the data unique to the first property. A database management system is adapted to parse the first one or more data records for use by a second owner of the first property after the first property is conveyed from the first owner. The database management system is further adapted to parse the second one or more data records for retention by the first owner for use by the first owner in management of a second property.
