(57) **CLAIM**

The ornamental design for a television receiver, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a television receiver showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a reference front elevational view thereof, showing a line 9—9 and portions 10, 11, and 12;

FIG. 9 is a reference cross-sectional view thereof, taken along a line 9—9 in a direction of arrows of FIG. 8;


FIG. 10 is a reference enlarged view of a portion 10 of FIG. 8;





















