FIG. 1 is a perspective view of an avocado tool, showing our new design;

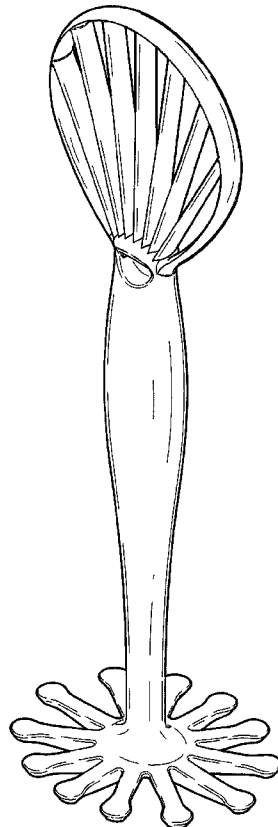
FIG. 2 is a front view of the avocado tool, the back view being identical;

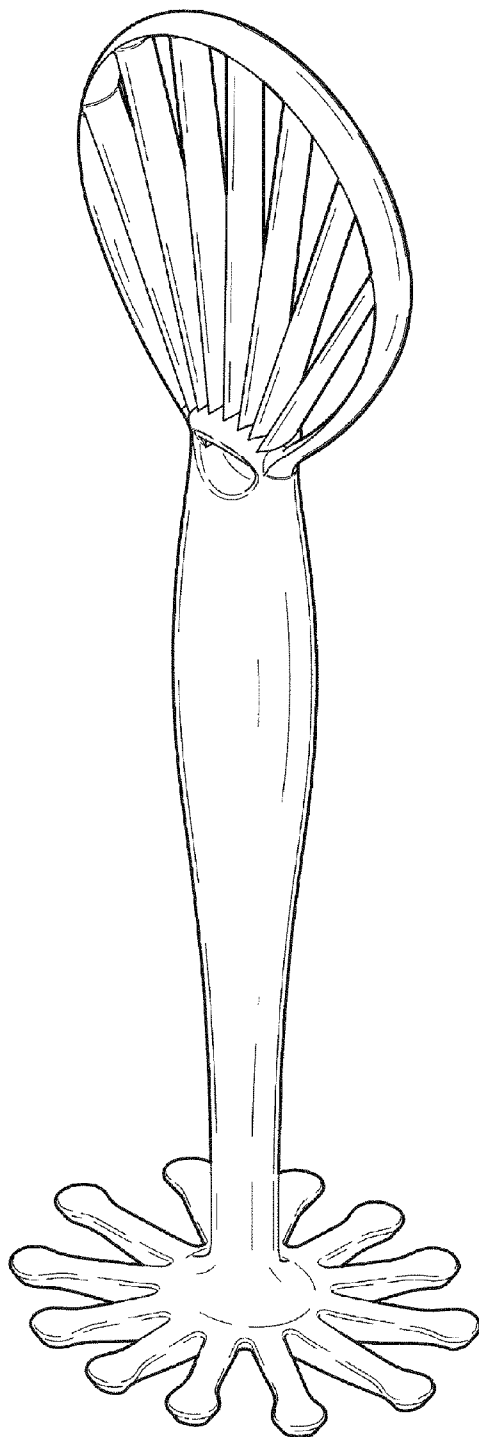

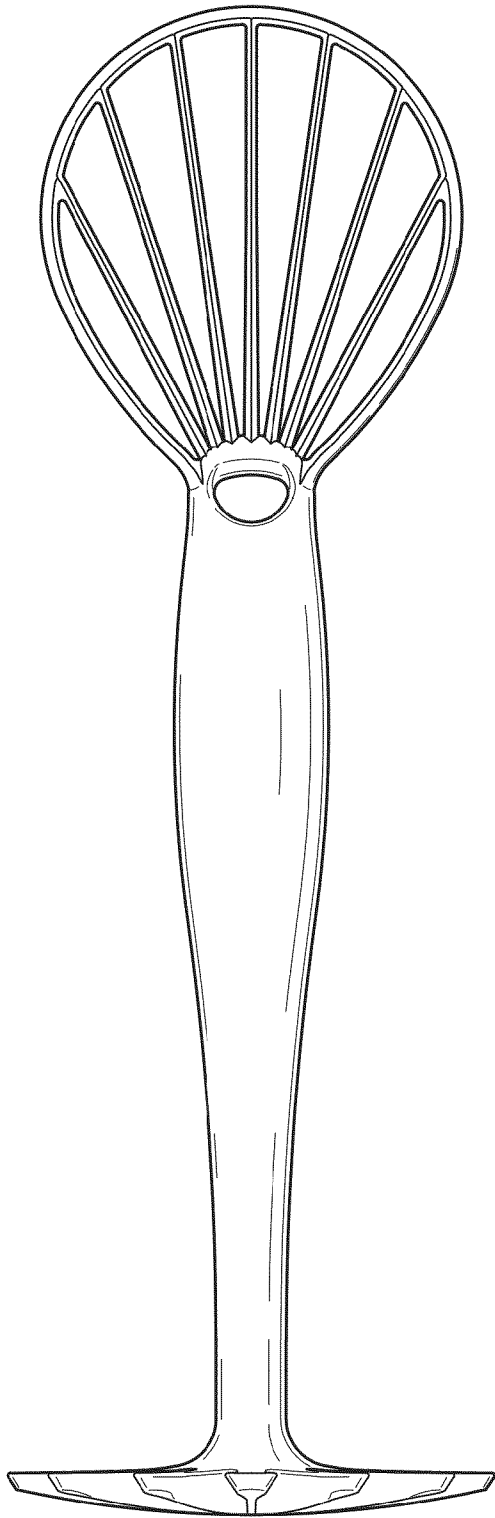

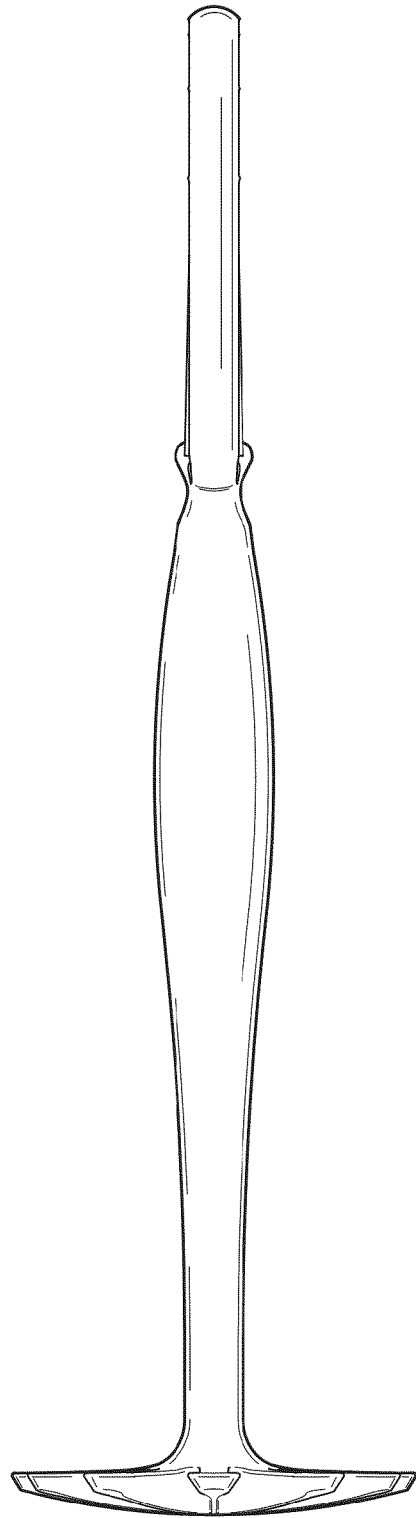

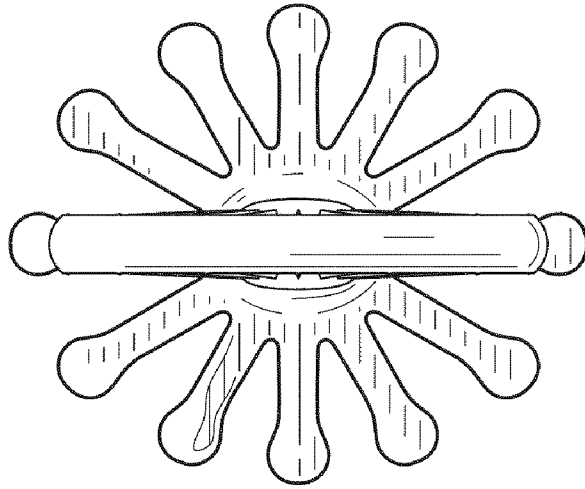

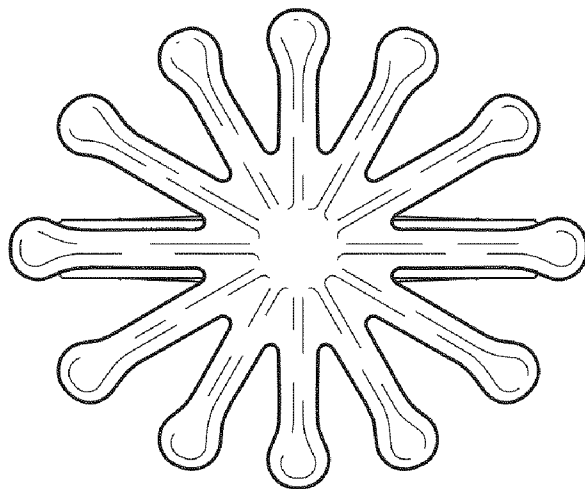
