

(54) Title: METHOD FOR DELIVERY OF DIGITAL CONTENT TO HANDHELD AND WIRELESS COMPUTING DEVICES



(57) Abstract: A method of downloading digital content from a web site computer system to a handheld computer device (Fig.13) by simply clicking on a hyperlink displayed in a window on a desktop computer system (Fig.4). In response to clicking on the hyperlink, the desktop and web site computer systems perform a series of automated functions that cause digital content associated with the hyperlink and stored on the web site computer system (Fig.4) to be downloaded from the web site computer system to the desktop computer system (Fig.5) and then to the handheld computing device (Fig.13). To facilitate the downloading process, the desktop computer system includes a novel file downloading helper program (Fig.11) that allows the digital content to be automatically downloaded from the web site computer system to the handheld computing device.
