
(57) **CLAIM**

The ornamental design for a mounting block for paving apparatus, as shown and described.

**DESCRIPTION**

FIG. 1 is a right front view of a mounting block for paving apparatus showing our new design; FIG. 2 is a right rear perspective view thereof; FIG. 3 is a bottom left perspective view thereof; FIG. 4 is a top left perspective view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom perspective view thereof; and, FIG. 9 is a top perspective view thereof, with environment depicted in broken lines and elements in broken lines forming no part of the claimed design. The bottom of the design is not seen during ordinary use and is not part of the claimed design.


















