The ornamental design for a ceiling fan blade iron, as shown and described.


**DESCRIPTION**

FIG. 1 is a bottom perspective view of a ceiling fan blade iron shown in the environment of a ceiling fan;  
FIG. 2 is a bottom perspective view of the ceiling fan blade iron of FIG. 1;  
FIG. 3 is a bottom view of the ceiling fan blade iron of FIG. 1;  
FIG. 4 is a top view of the ceiling fan blade iron of FIG. 1;
















