FIG. 4 is a rear view of the holster mug;

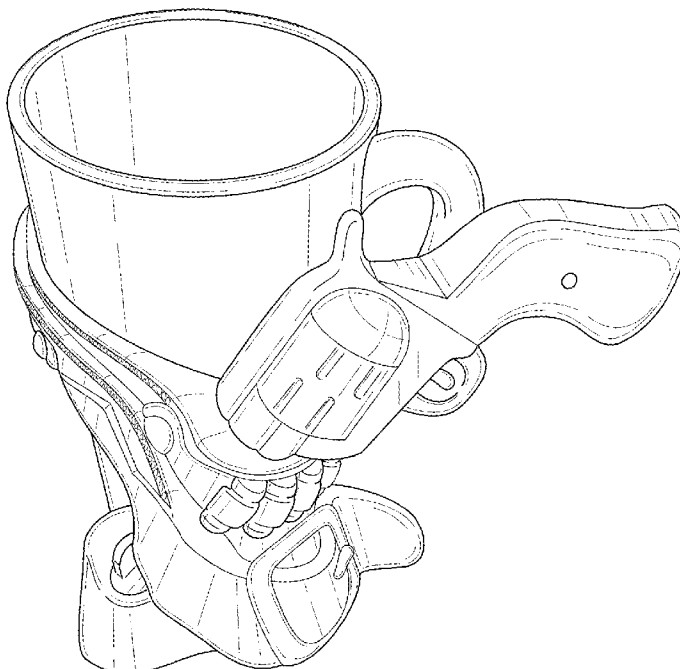
FIG. 5 is a left side of the holster mug;

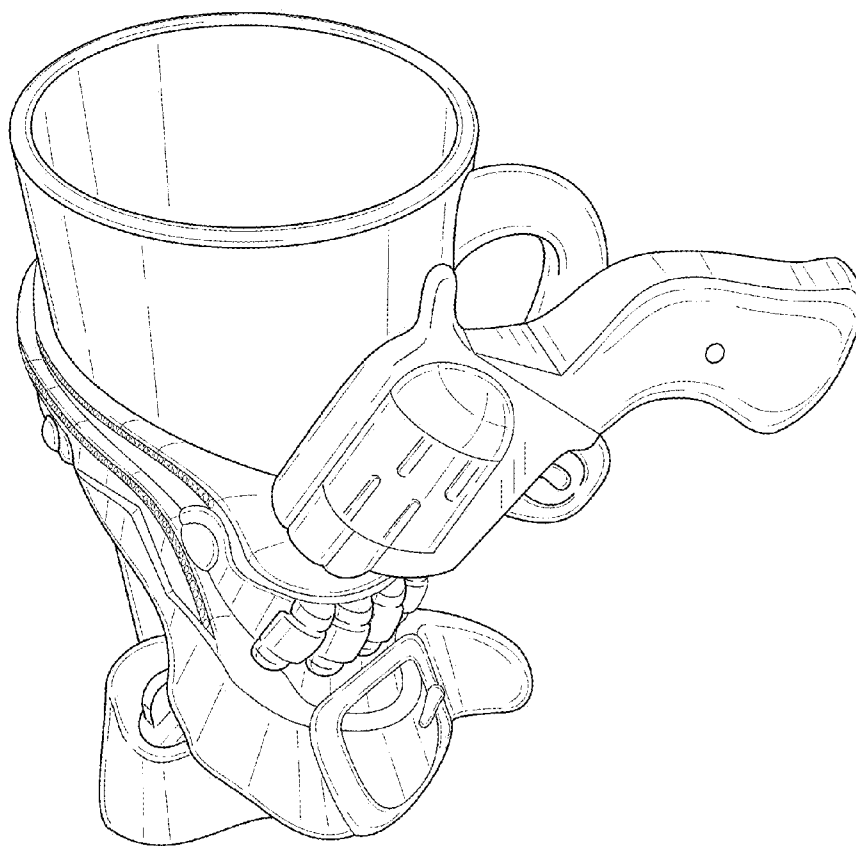

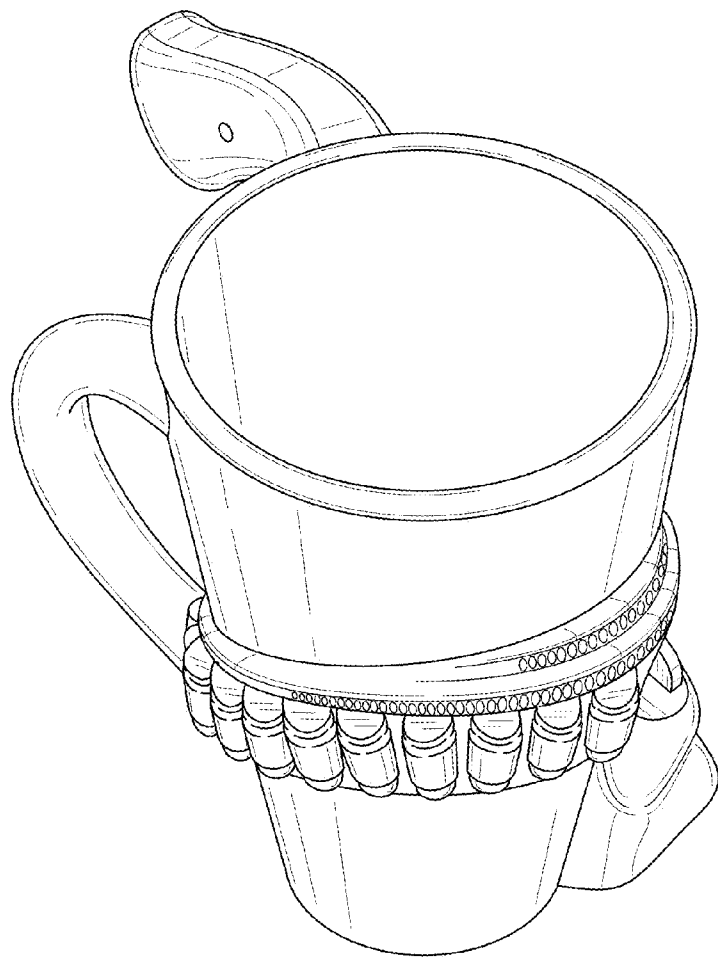

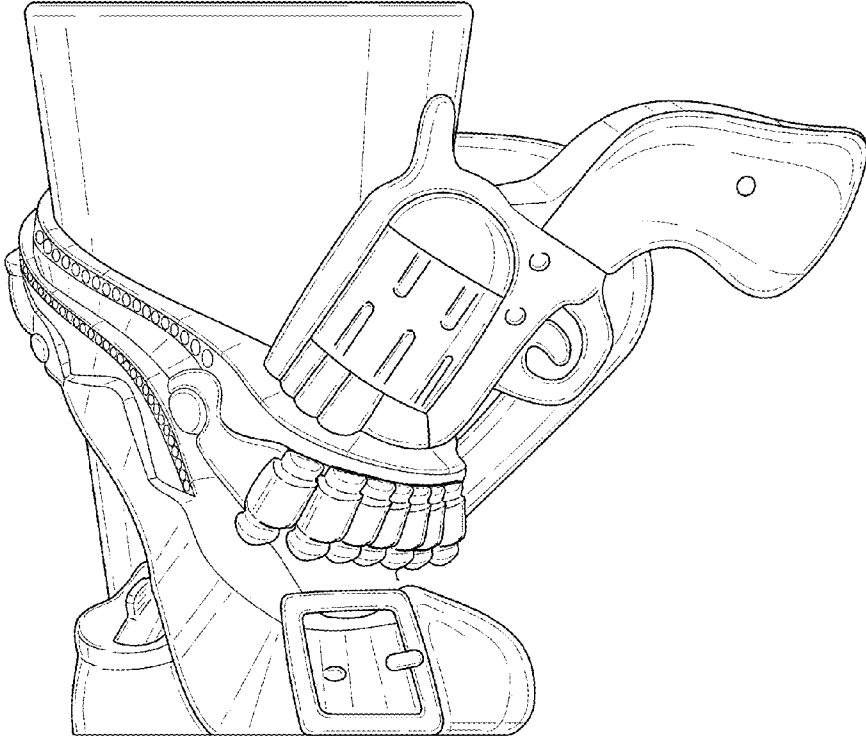

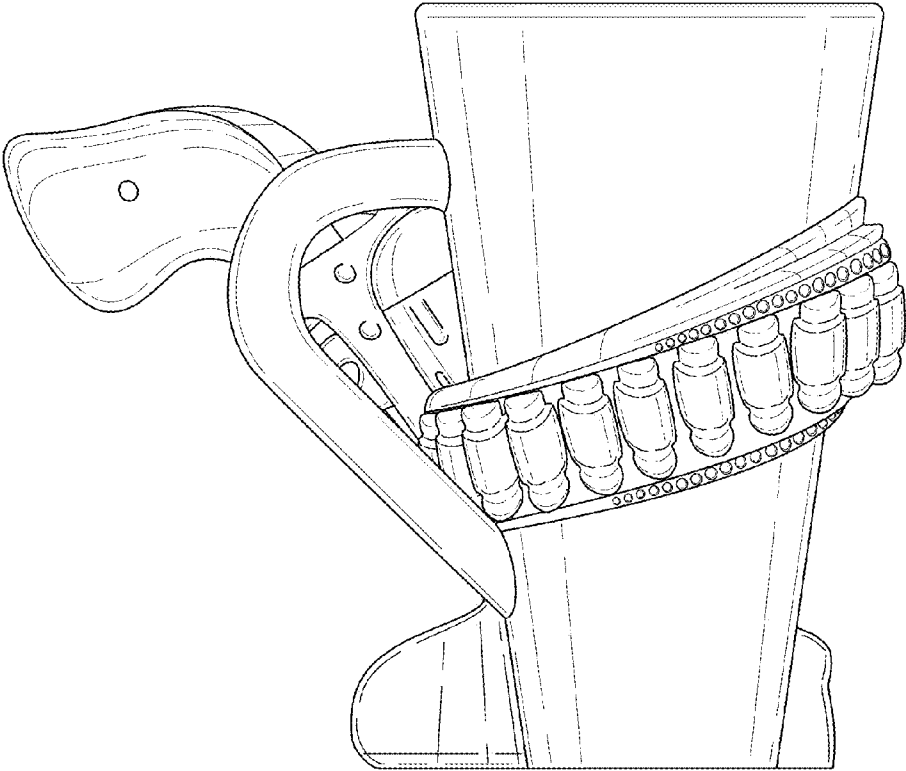

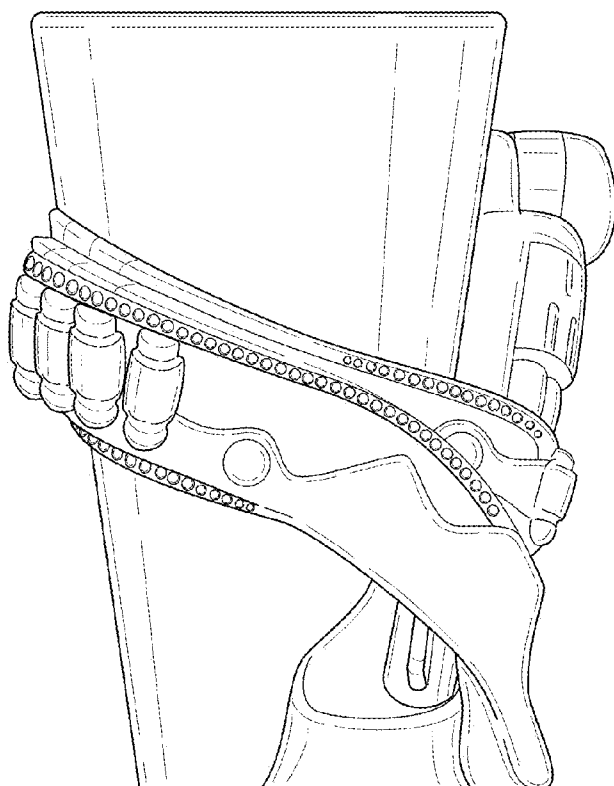

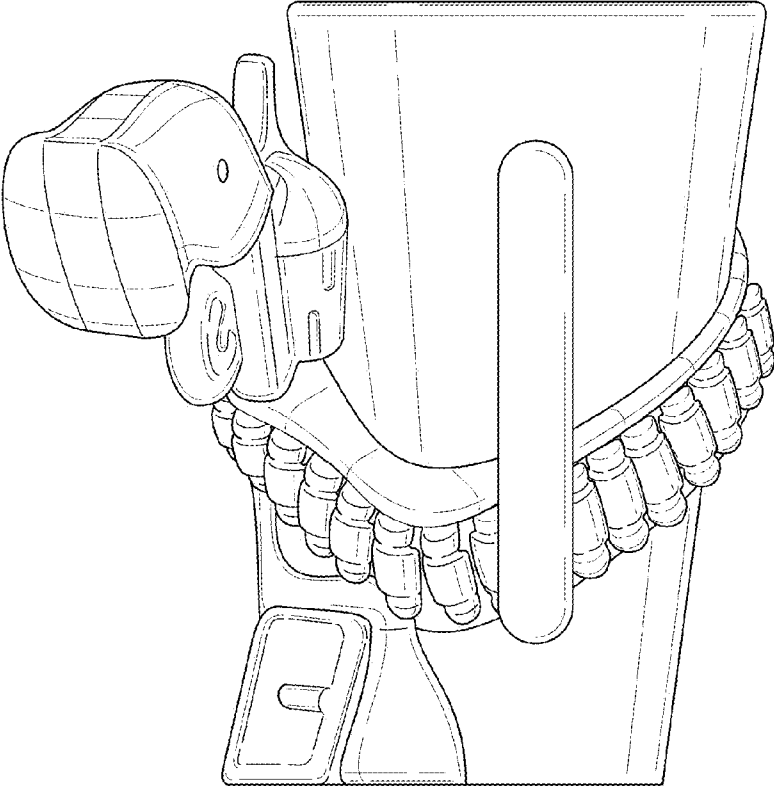

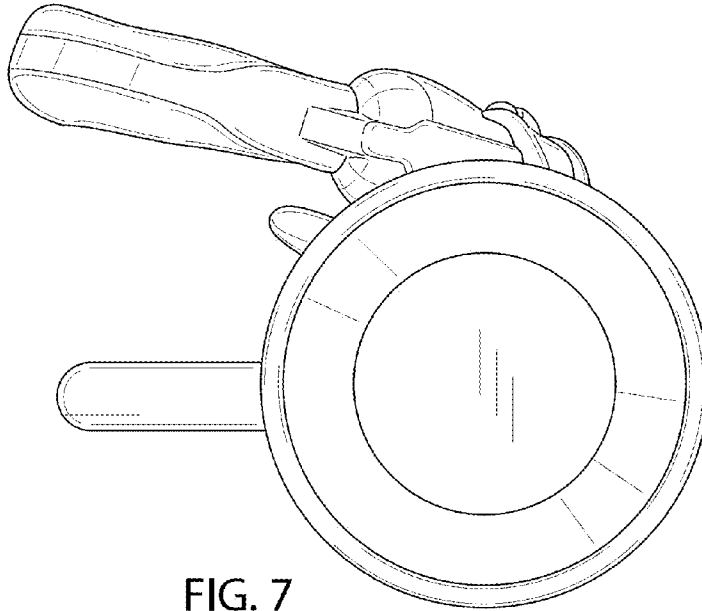

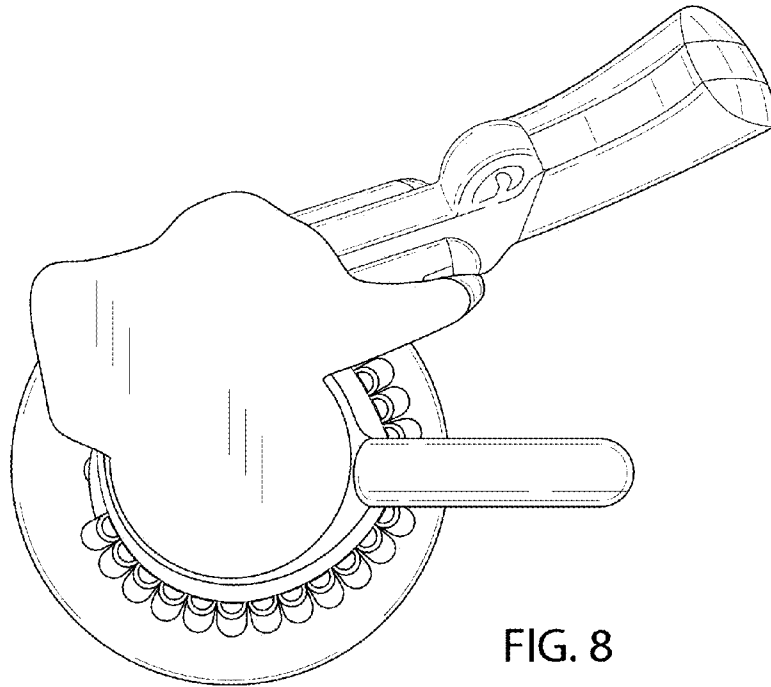
