
(57) **CLAIM**
The ornamental design for a bottle cap, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a bottle cap showing my new design with the neck of the cap disclaimed; FIG. 2 is a front view thereof; FIG. 3 is a back view thereof; FIG. 4 is a left side view thereof; FIG. 5 is right side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is another top perspective view thereof; and, FIG. 9 is a top perspective view therefore in the environment of a bottle.
In FIGS. 1-8, the broken lines show portions of a bottle cap that form no part of the claim; In FIG. 9, the broken lines depict a bottle that forms no part thereof.


















