FIG. 2 is a side elevational view of the other side of the shoe upper shown in FIG. 1;

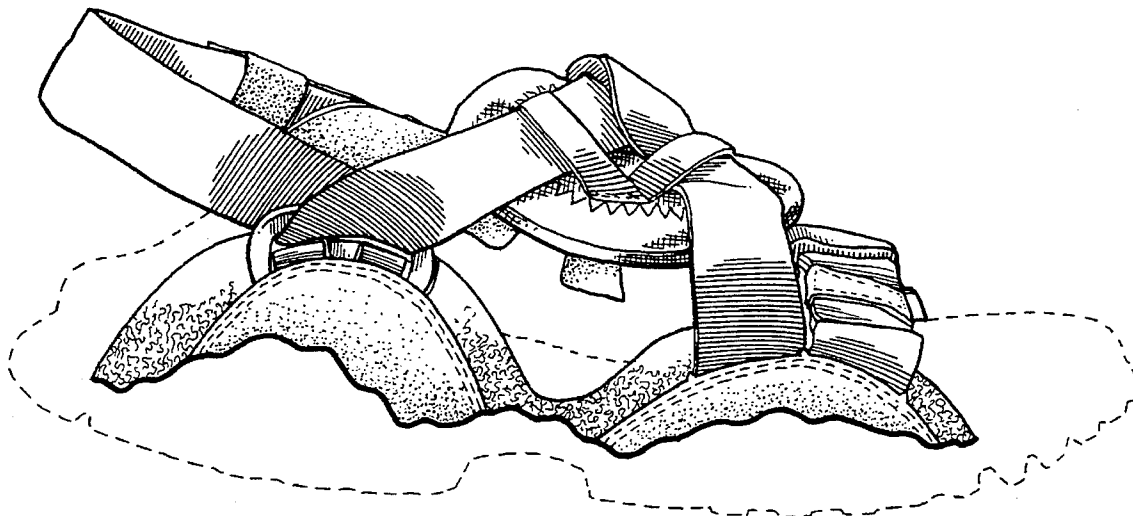
FIG. 3 is a front elevational view of the shoe upper shown in FIG. 1;

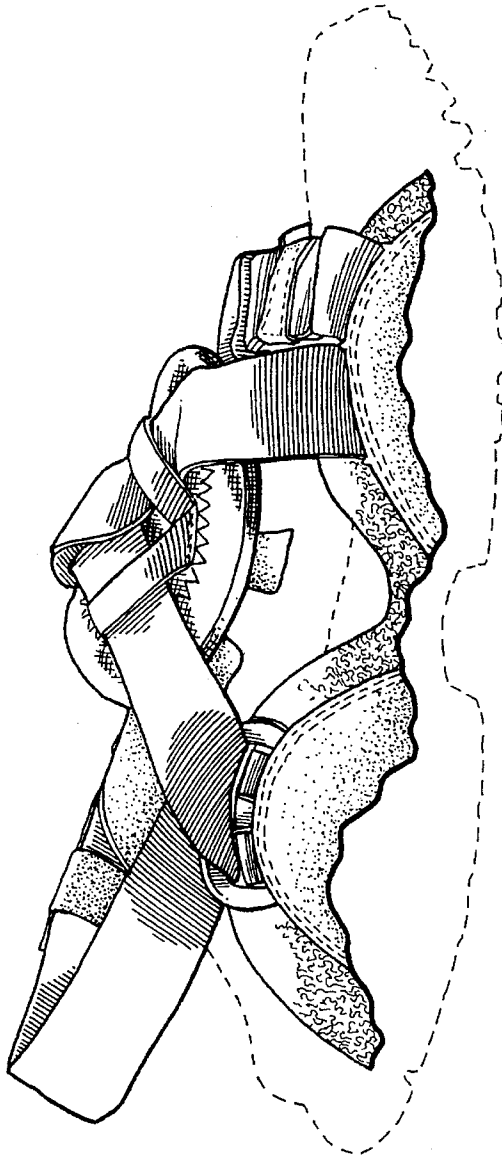

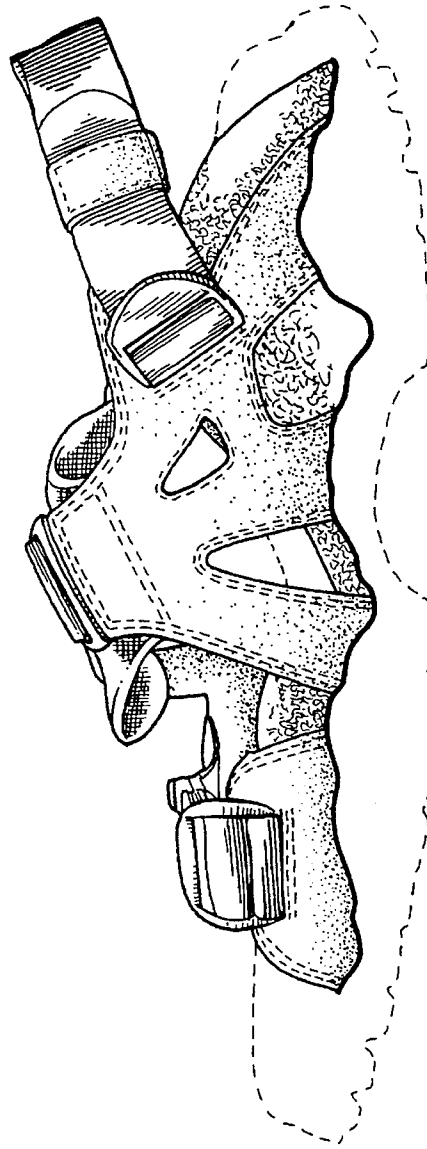

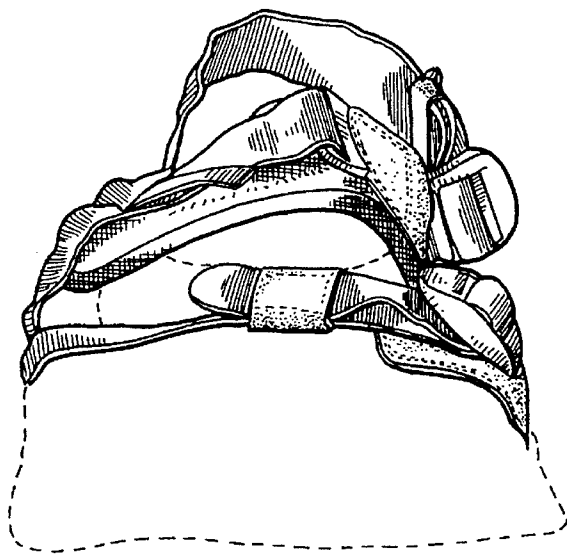

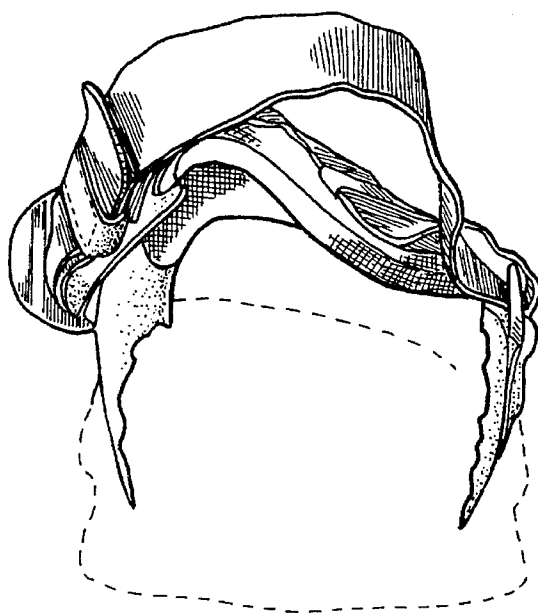

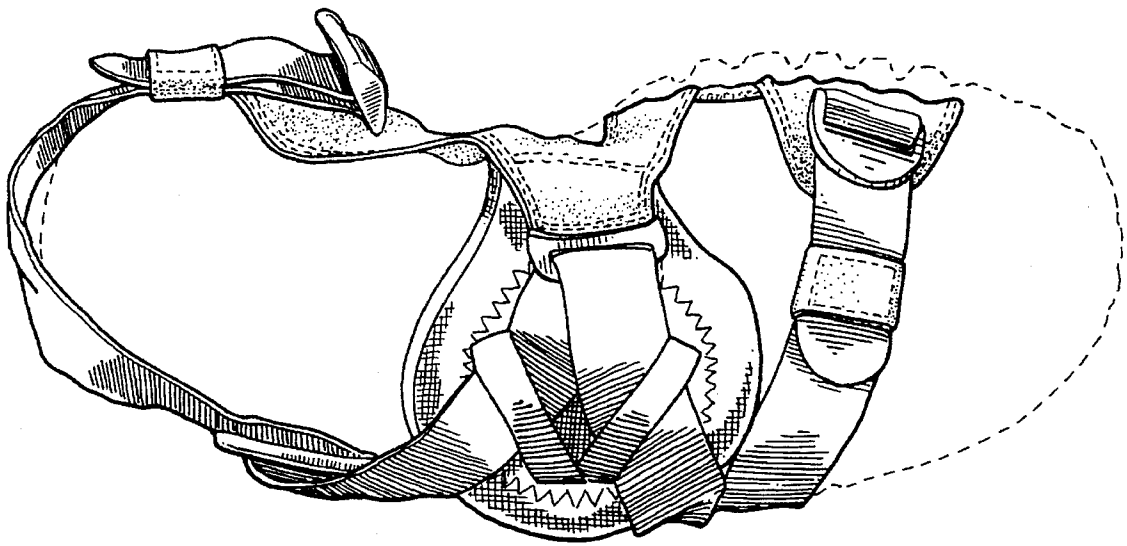
