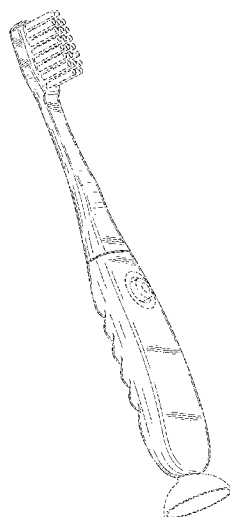

The ornamental design for a toothbrush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a toothbrush showing my new design;
FIG. 2 is a front view of the toothbrush of FIG. 1;
FIG. 3 is a back view of the toothbrush of FIG. 1; and,
FIG. 4 is a right side view of the toothbrush of FIG. 1, the left side view being a mirror image thereof.
The broken lines depict portions of the article that form no part of the claimed design.

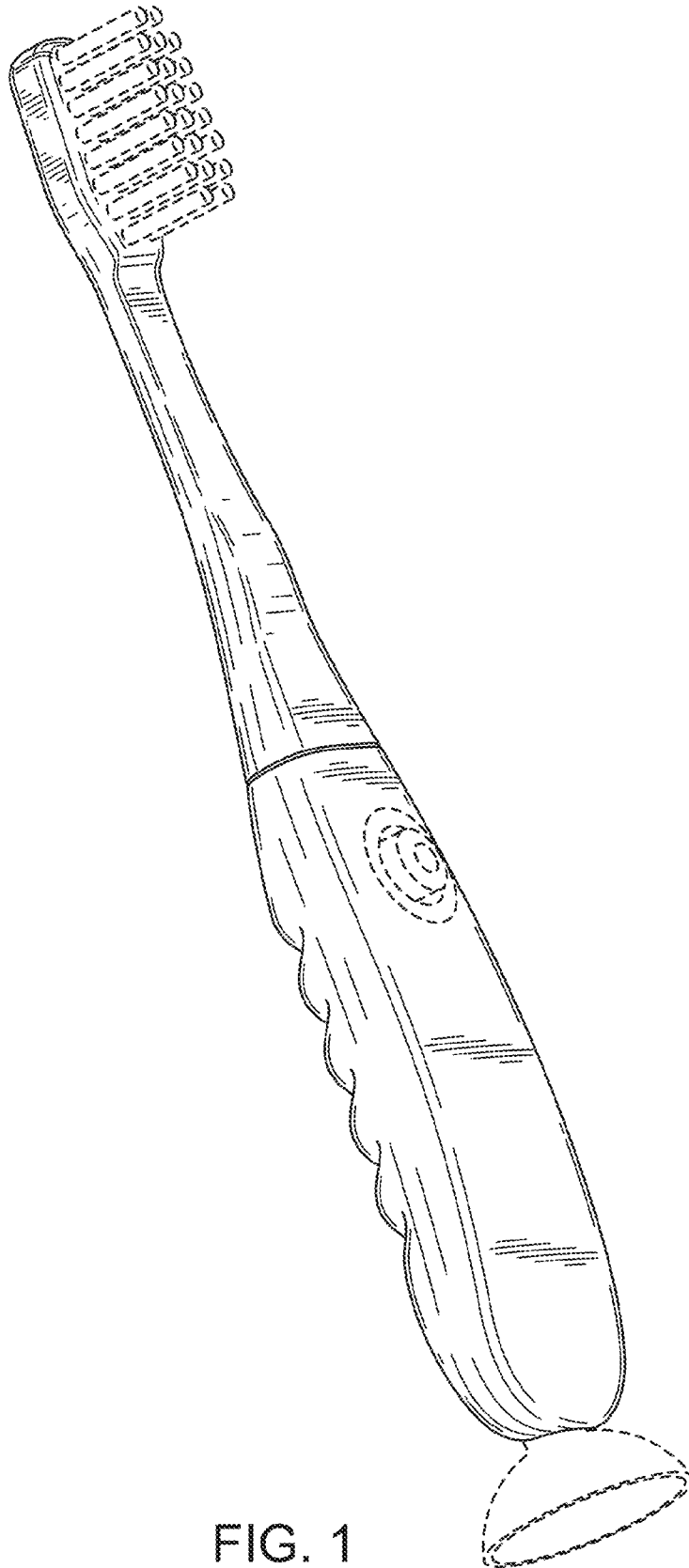

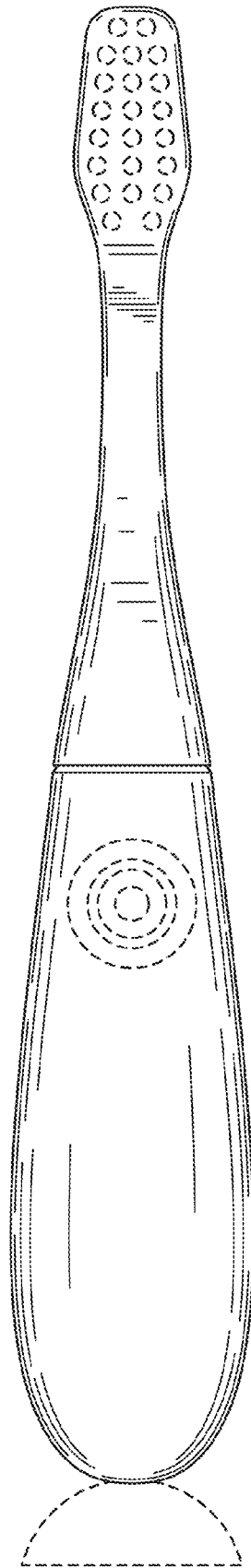

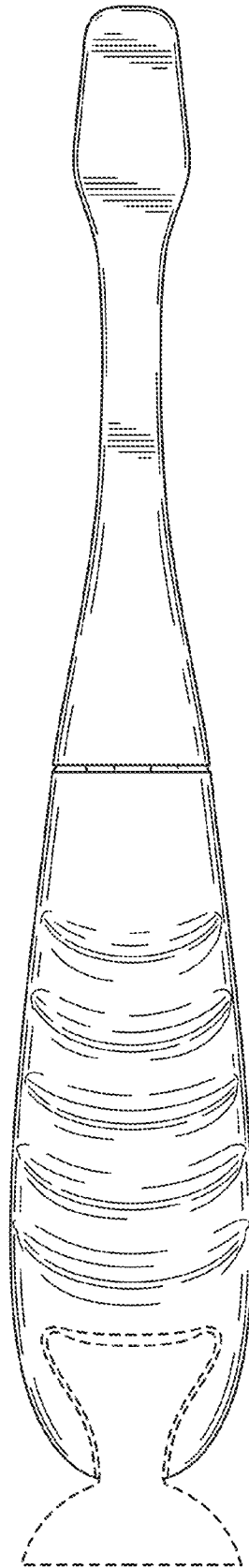

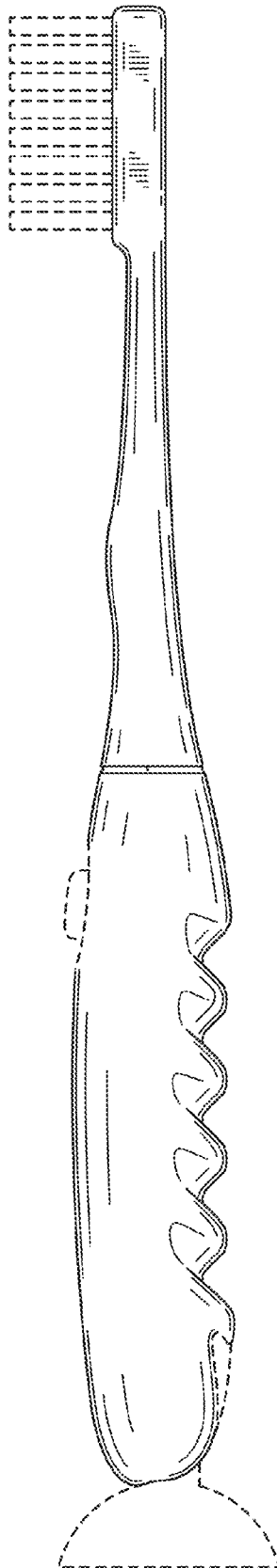
