The ornamental design for a package insert, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a first variant of the present package insert;
FIG. 2 is a front view of the first variant of the package insert of FIG. 1;

FIG. 3 is a rear view of the first variant of the package insert of FIG. 1;

FIG. 4 is a left side view of the first variant of the package insert of FIG. 1;

FIG. 5 is a right side view of the first variant of the package insert of FIG. 1;

FIG. 6 is a perspective view of the package insert of FIG. 1 deployed within a package with packaged products;

FIG. 7 is a plan view of a second variant of the package insert of FIG. 1;

FIG. 8 is a front view of the second variant of the package insert of FIG. 7;

FIG. 9 is a rear view of the second variant of the package insert of FIG. 7;

FIG. 10 is a left side view of the second variant of the package insert of FIG. 7;

FIG. 11 is a right side view of the second variant of the package insert of FIG. 7;

FIG. 12 is a plan view of a third variant of the package insert of FIG. 1;

FIG. 13 is a front view of the third variant of the package insert of FIG. 12;

FIG. 14 is a rear view of the third variant of the package insert of FIG. 12;

FIG. 19 is a rear view of the fourth variant of the package insert of FIG. 17;


FIG. 20 is a left side view of the fourth variant of the package insert of FIG. 17; and,



































