FIG. 8 is a left rear perspective view thereof;

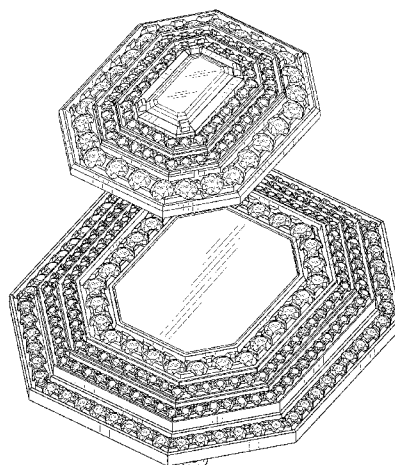
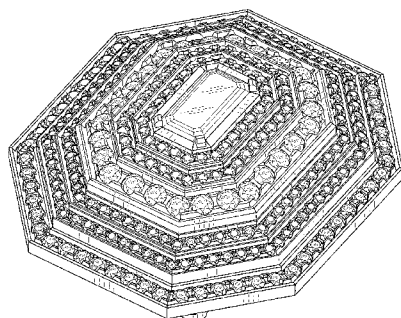
FIG. 9 is a right front perspective view thereof with the cover in an open position;

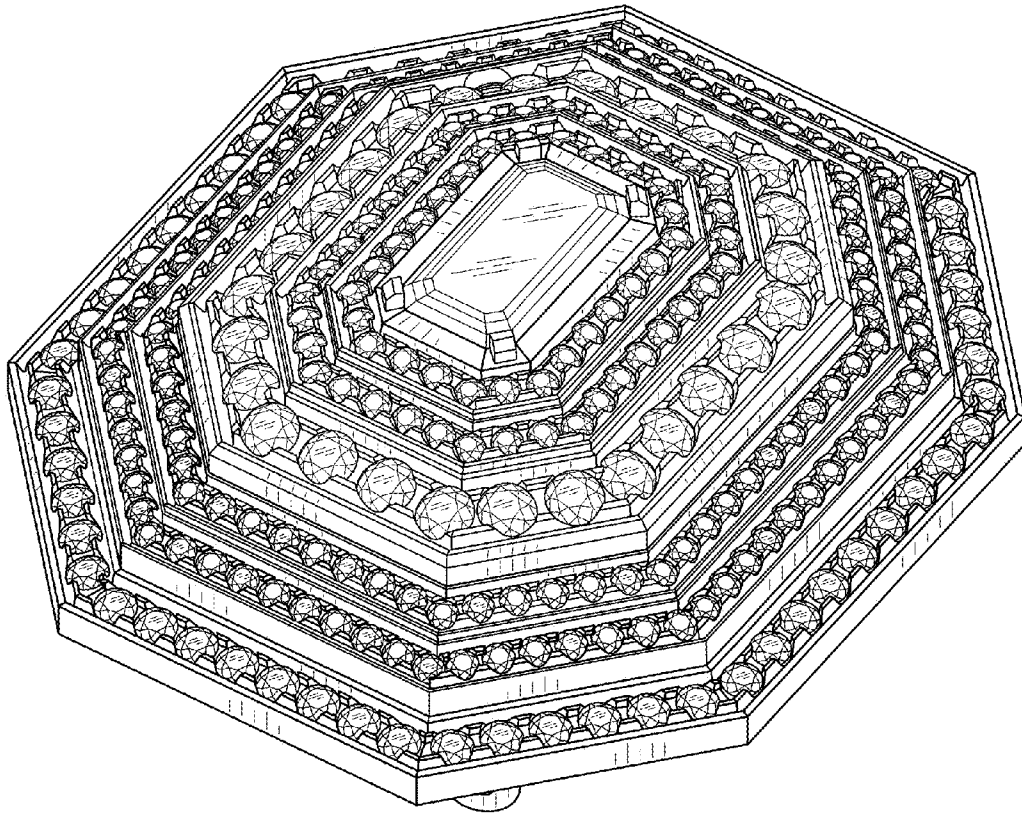

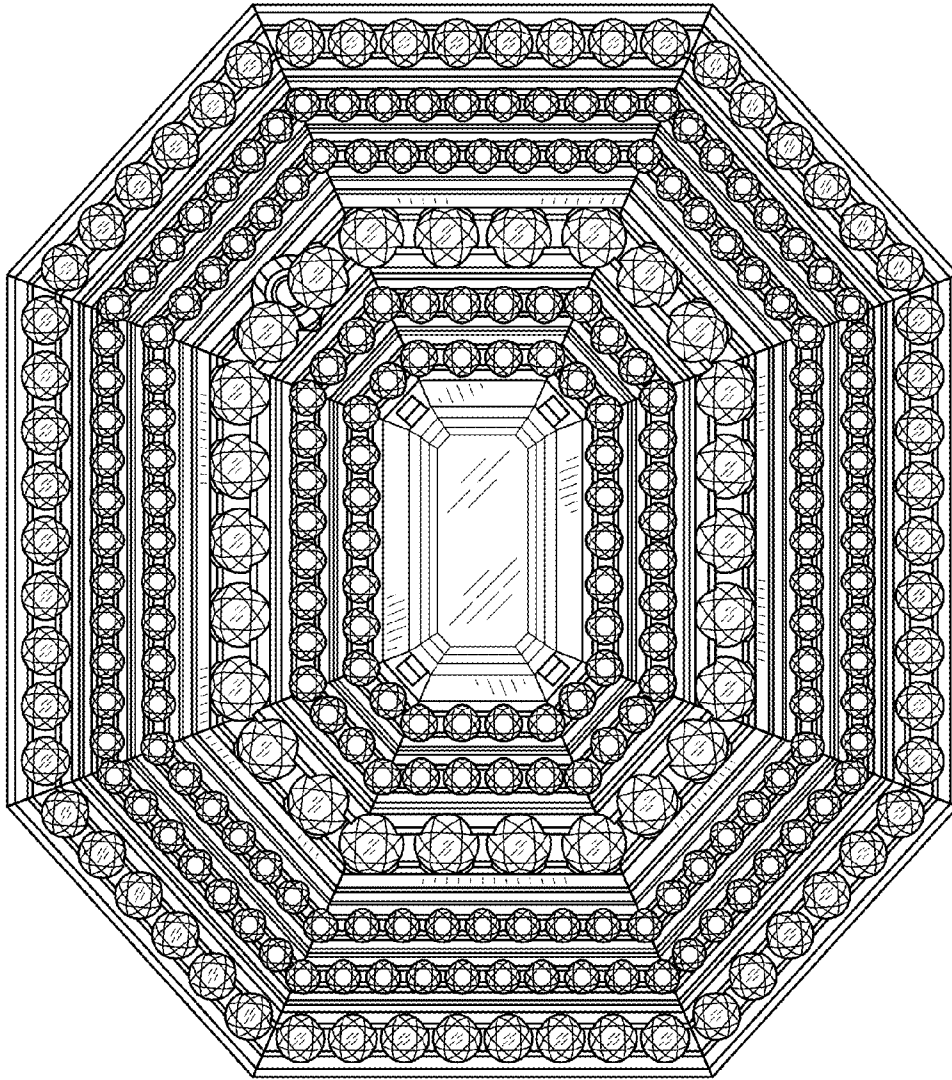

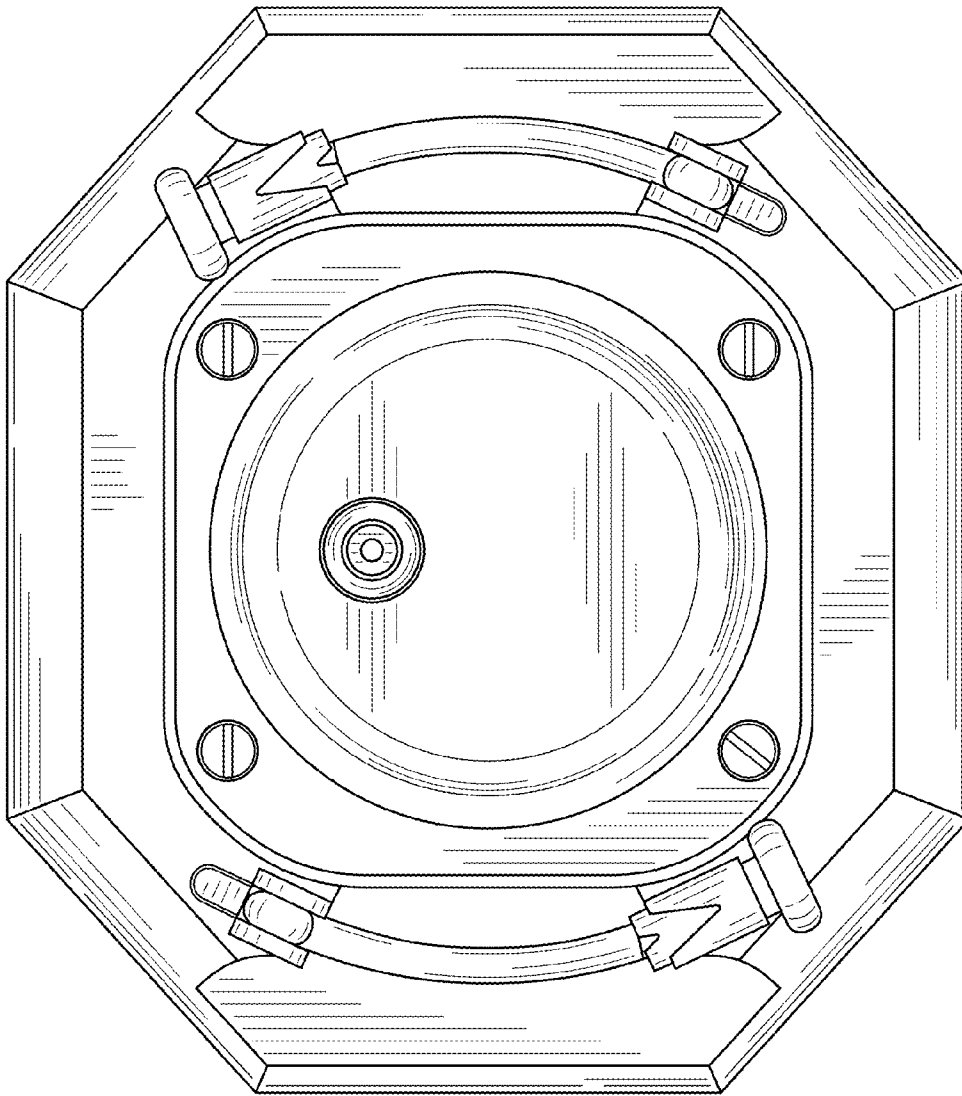

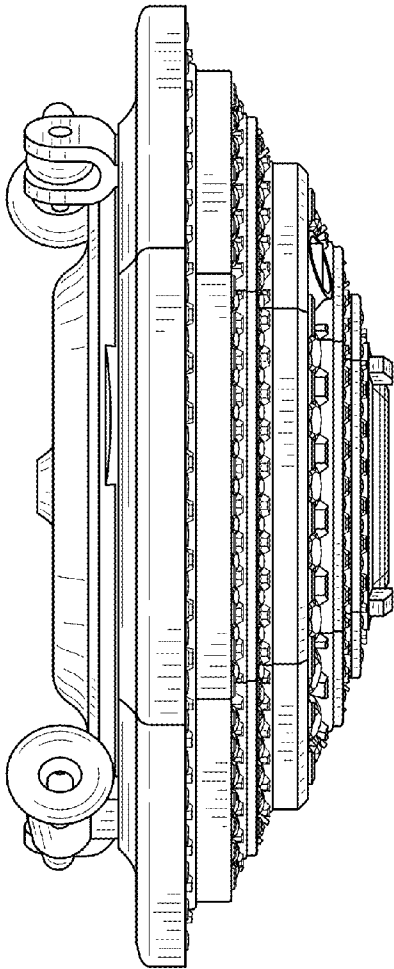

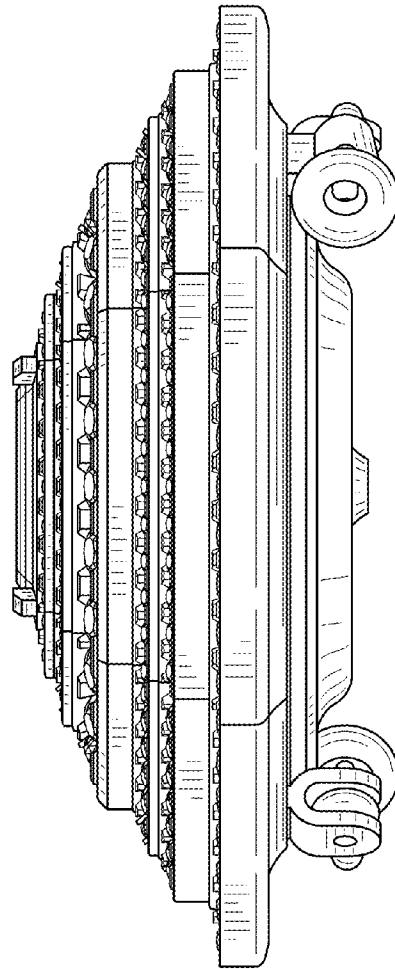

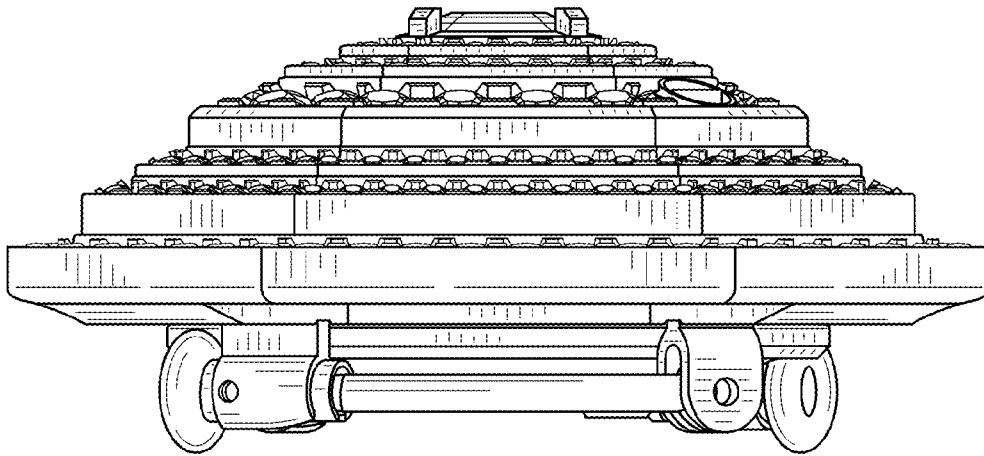

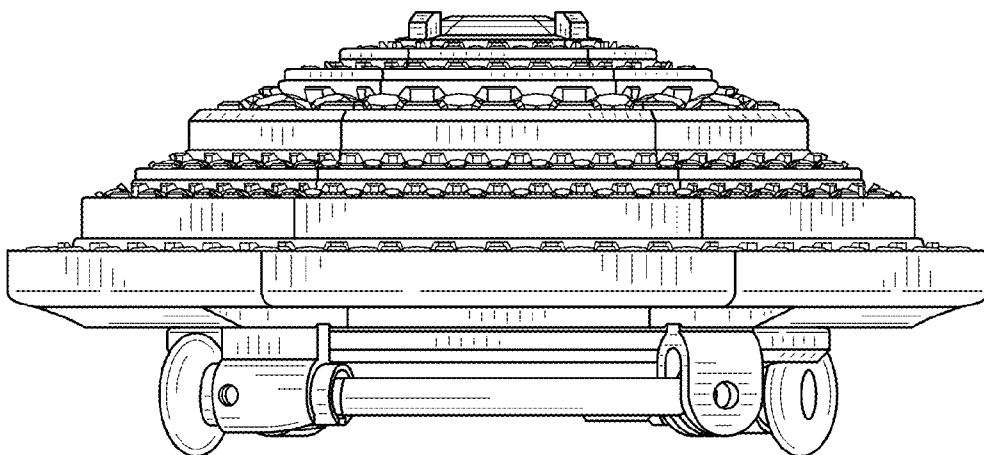

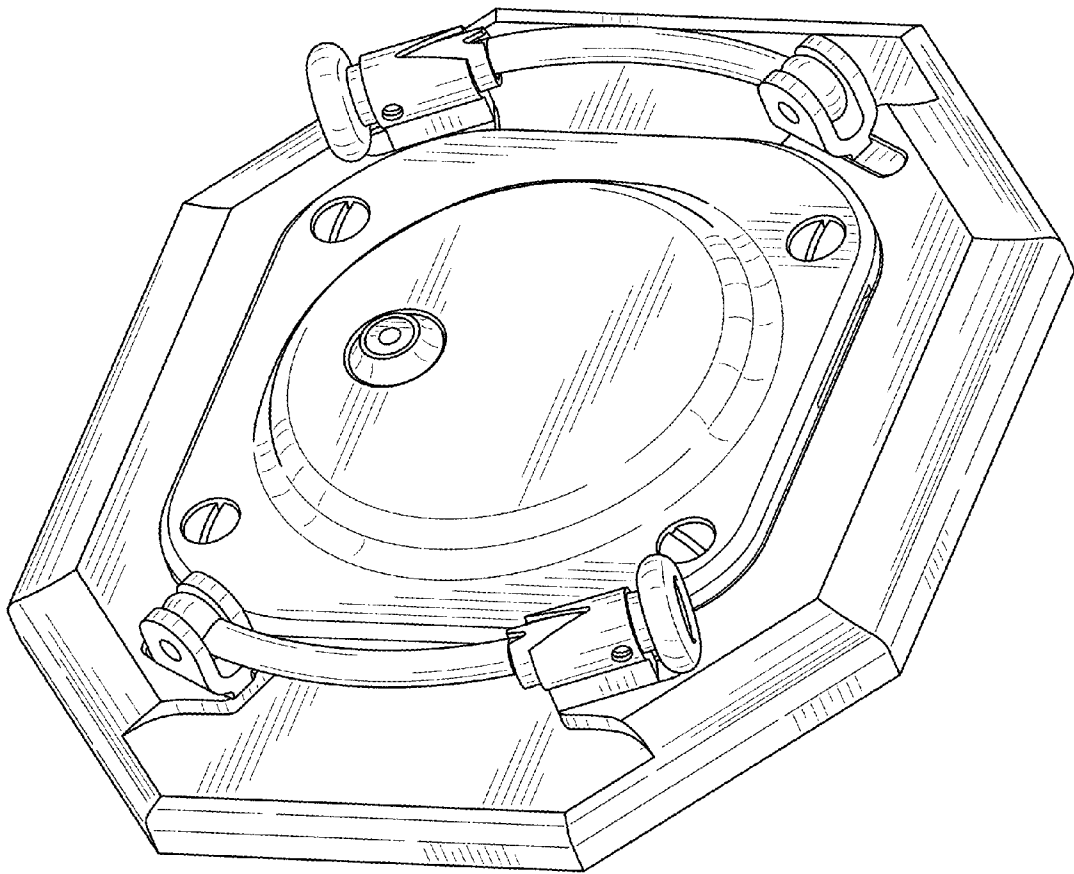

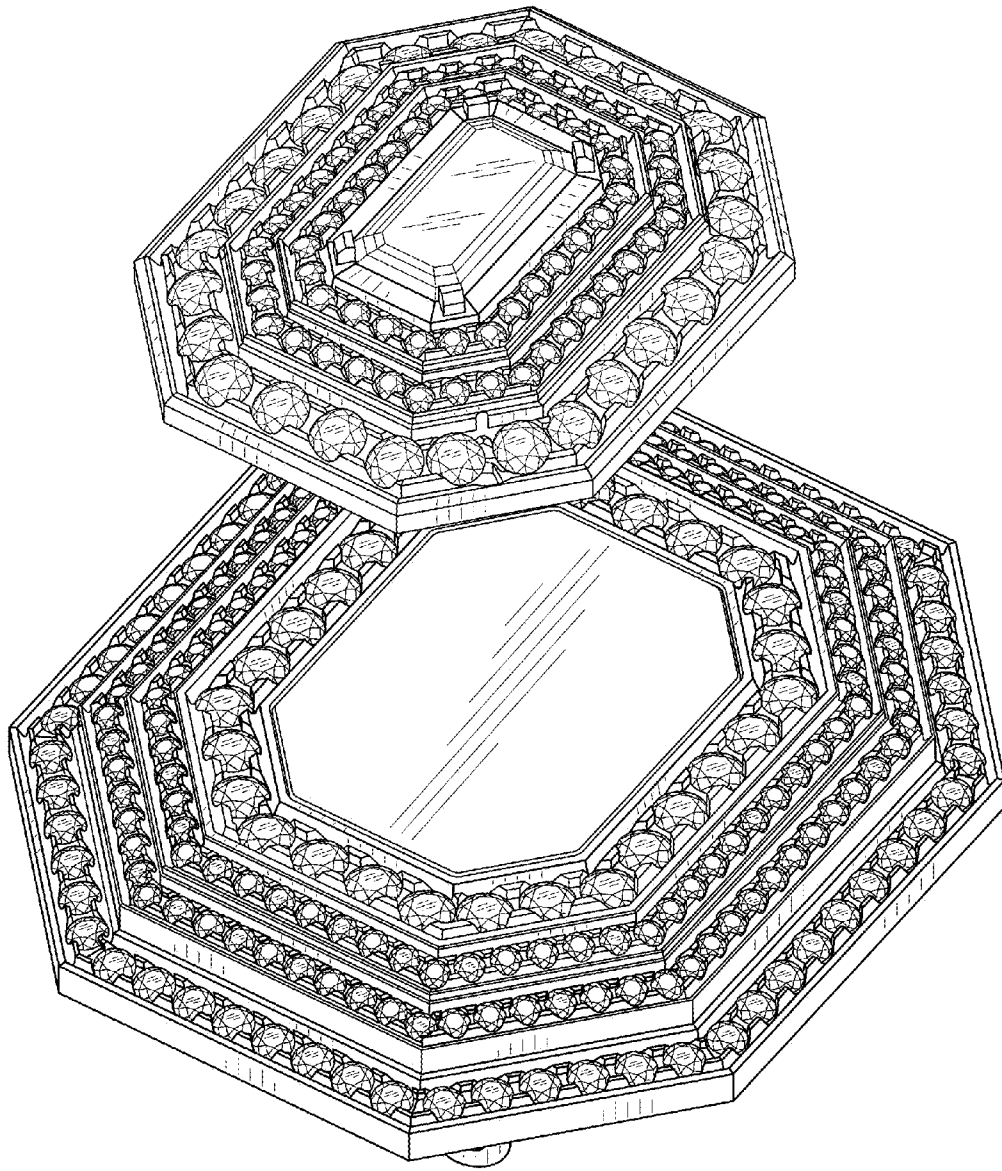

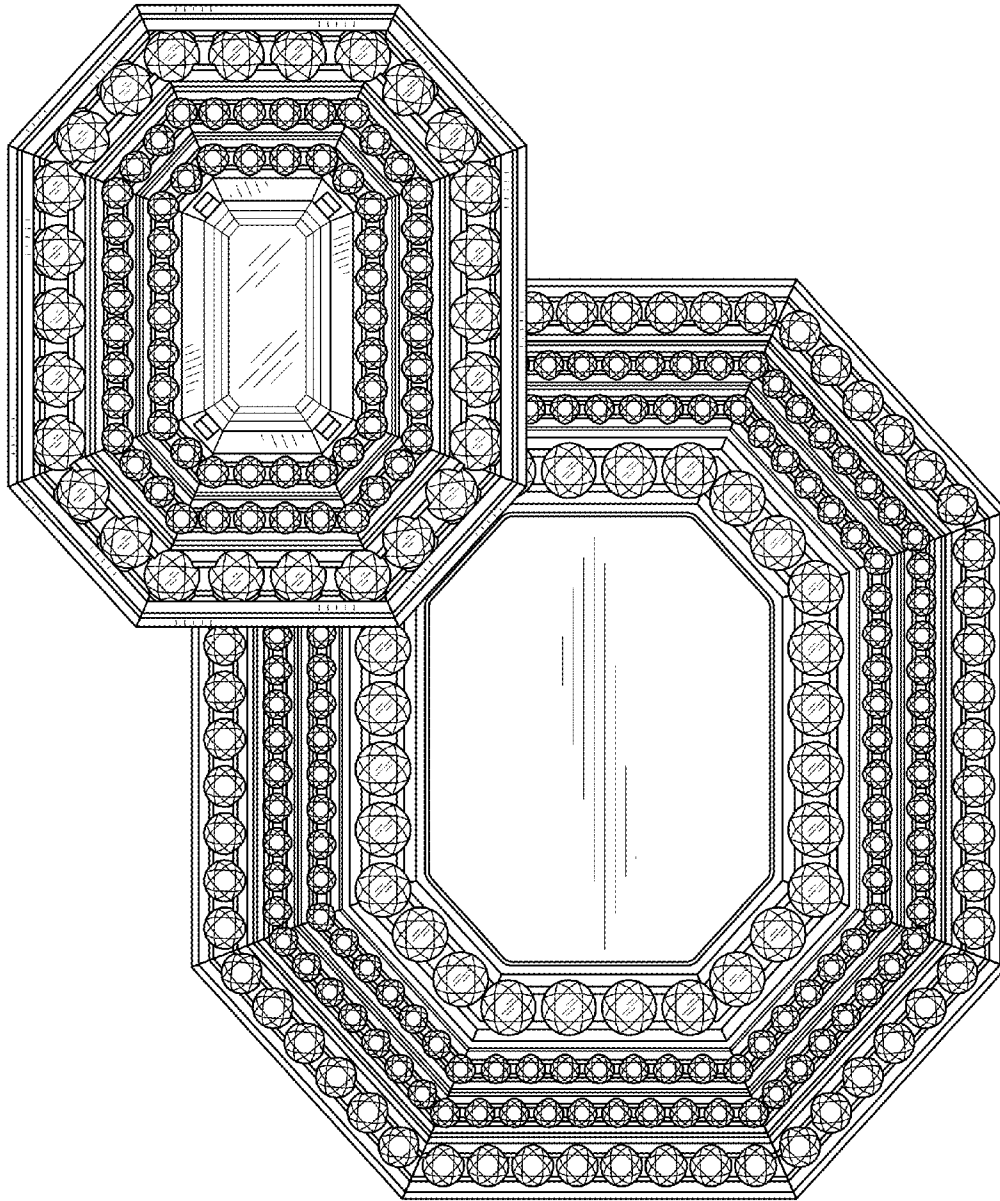

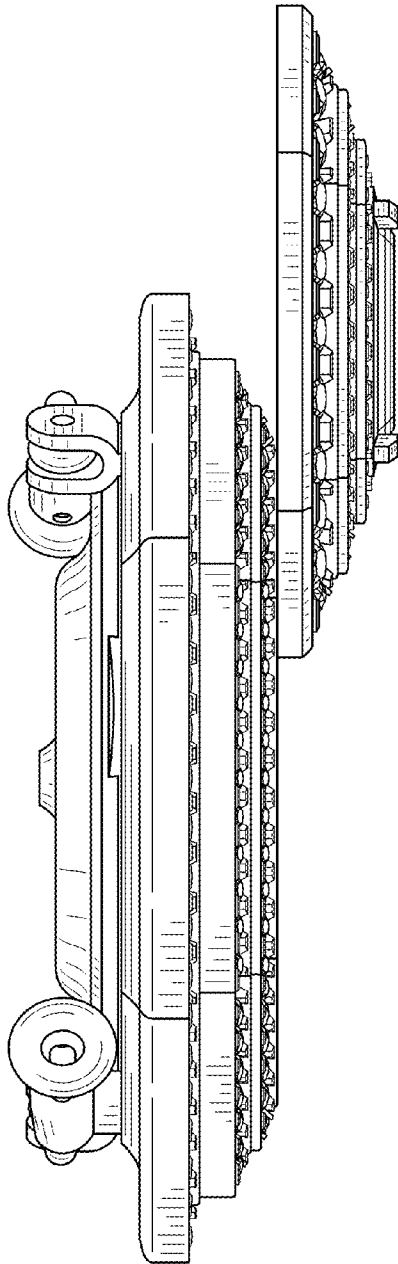

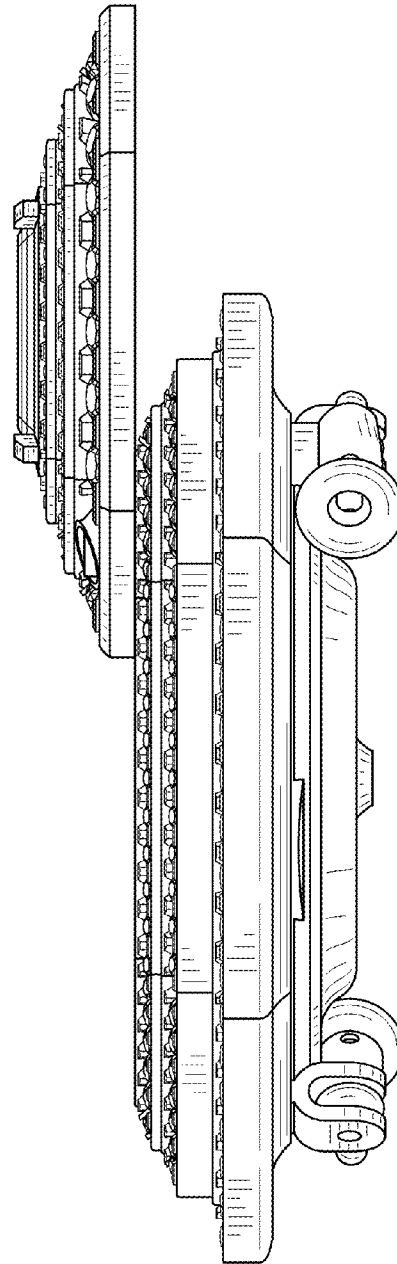
