

(57) Abstract: The present invention provides a composition adapted to supply locally to the site of need in a patient in need thereof a compound having a pharmaceutical activity, wherein the active agent of said composition comprises an extract of *Spilanthes oleracea*. The composition is of particular use, for example, as an analgesic in providing rapid treatment of neuropathic pain and as a long-lasting anaesthetic. Compositions of the invention for buccal admininistration can preferably be in the form of lozenges, tablets or mucoadhesive gels.
