The ornamental design for a medical equipment for mixing medical liquids, as shown and described.

**DESCRIPTION**


FIG. 1 is a top view of medical equipment for mixing medical liquids according to a first embodiment of my/our design; FIG. 2 is a perspective view thereof; and, FIG. 3 is a reverse perspective view thereof.

Applicants respectfully reserve the right to pursue portions of each of the designs disclosed herein, e.g., various portions of the medical equipment, such as the “T” shaped groove only, the round main body, the chamfered/rounded upper edge of the main body, the hemi-circle, each of both “quarters”, various portions thereof and/or the combination or the interface between subportions or portions thereof.

Throughout the various figures of the drawings, certain views may not be provided. The omission of a particular view is intended to convey that the element(s) depicted is/are plain and unornamented in that omitted view, or that the particular ornamental appearance in that view is simply not claimed.






