(57) **CLAIM**

The ornamental design for a front cover portion of a handset, as shown and described.

DESCRIPTION

FIG. 1 is a bottom view of a front cover portion of a handset showing our new design with a front cover of a handset shown in isolation;

FIG. 2 is a front view thereof;


FIG. 3 is a right side view thereof;








