**DESCRIPTION**

FIG. 6 is a front view of a sixth embodiment thereof;

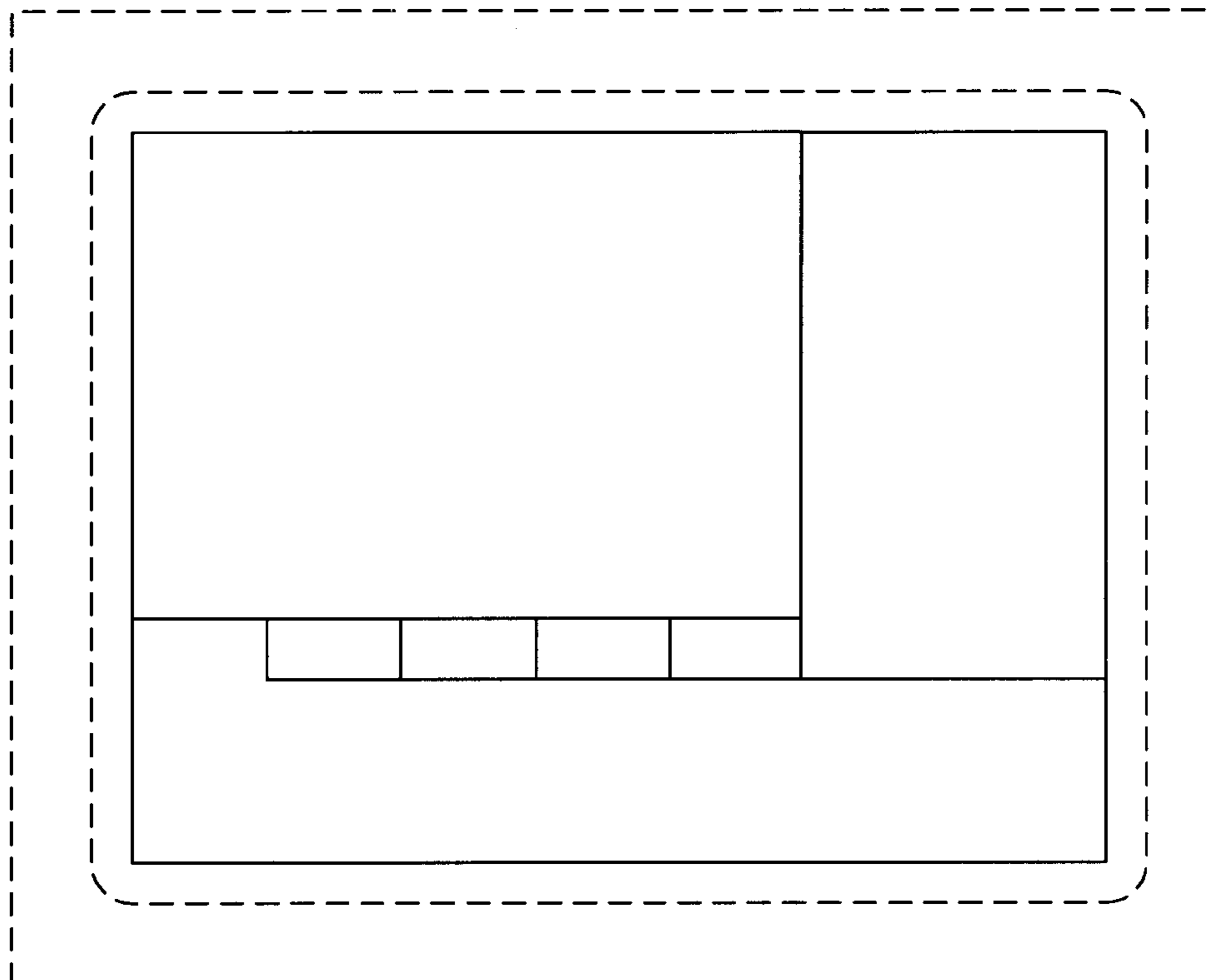
FIG. 7 is a front view of a seventh embodiment thereof;

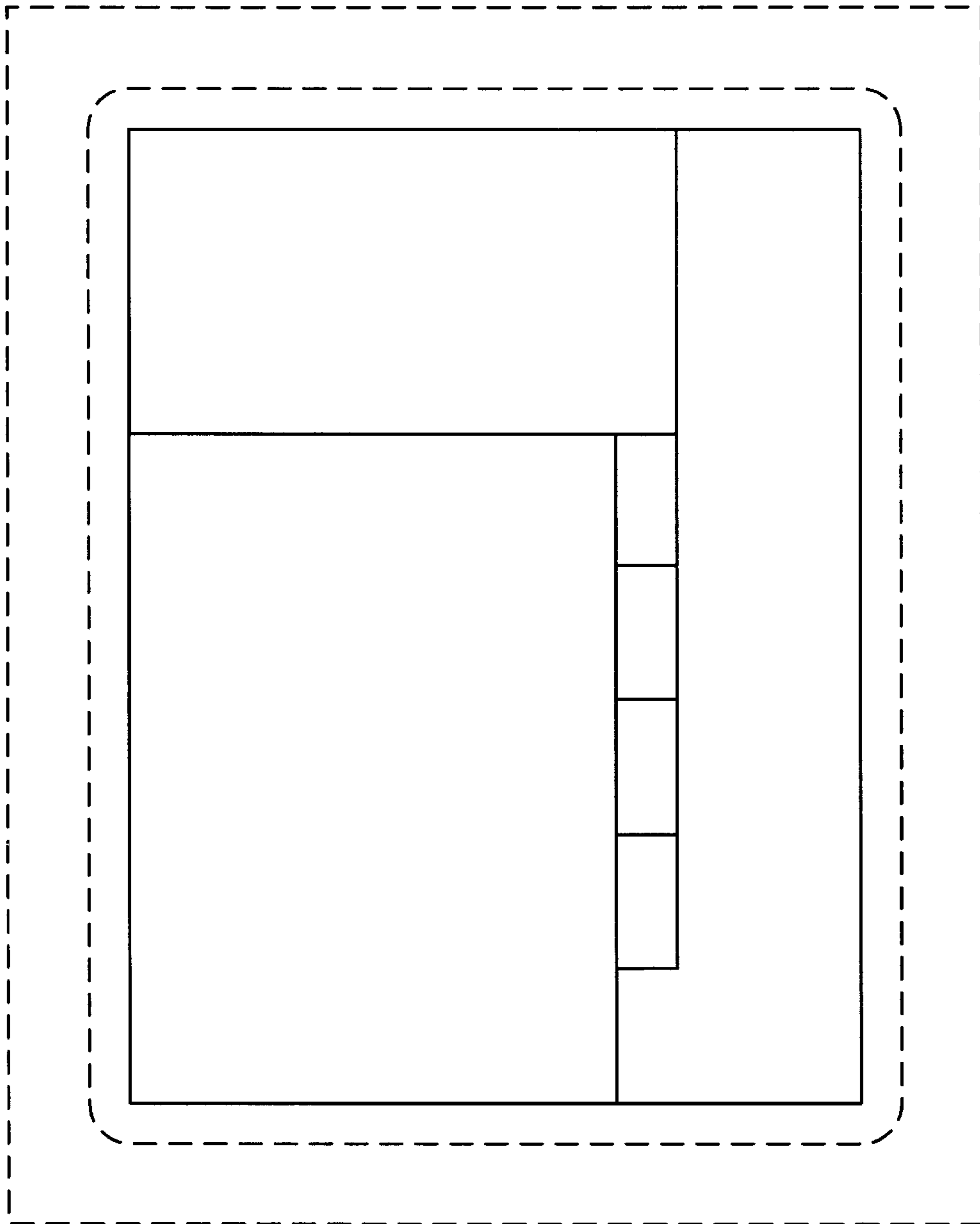

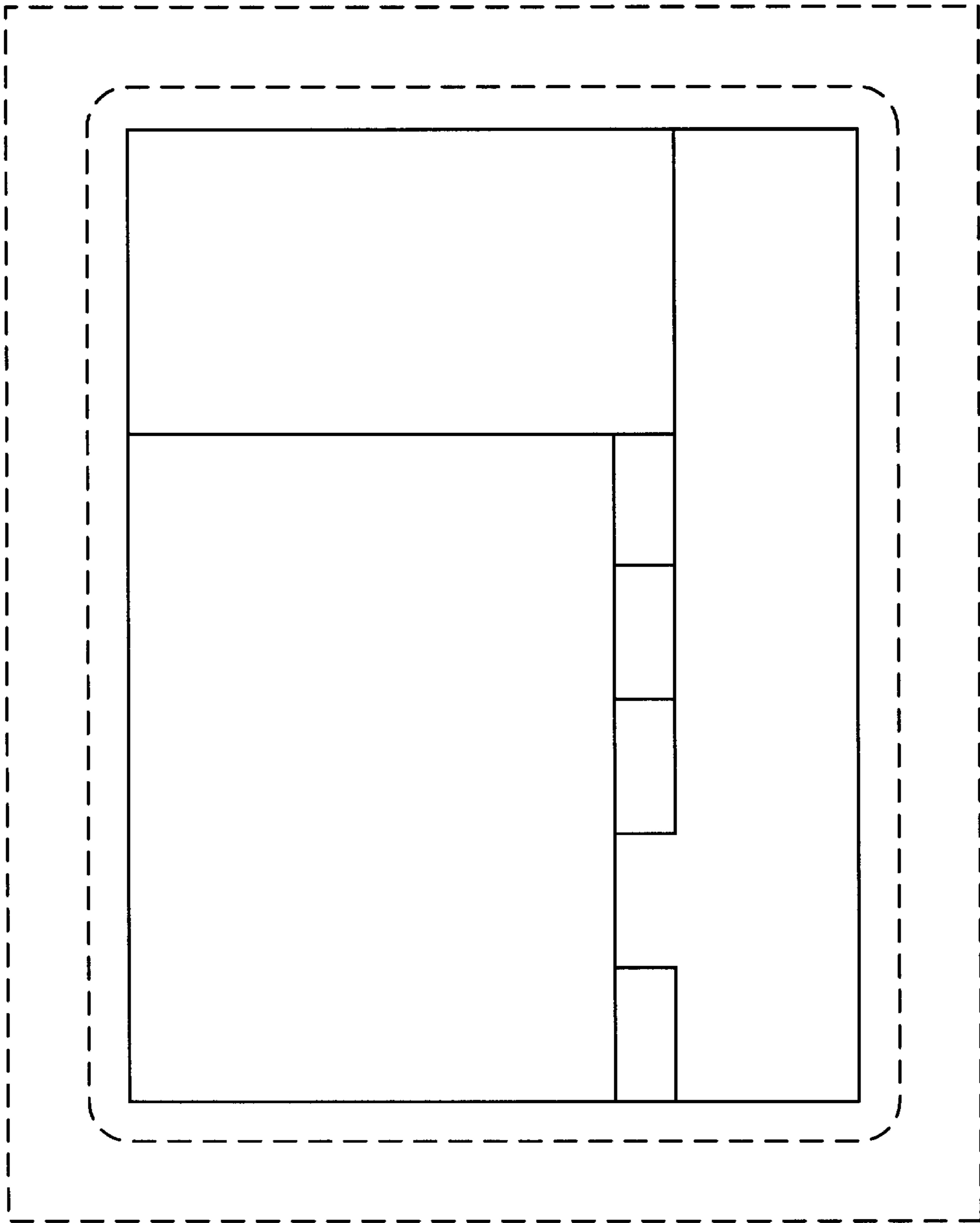

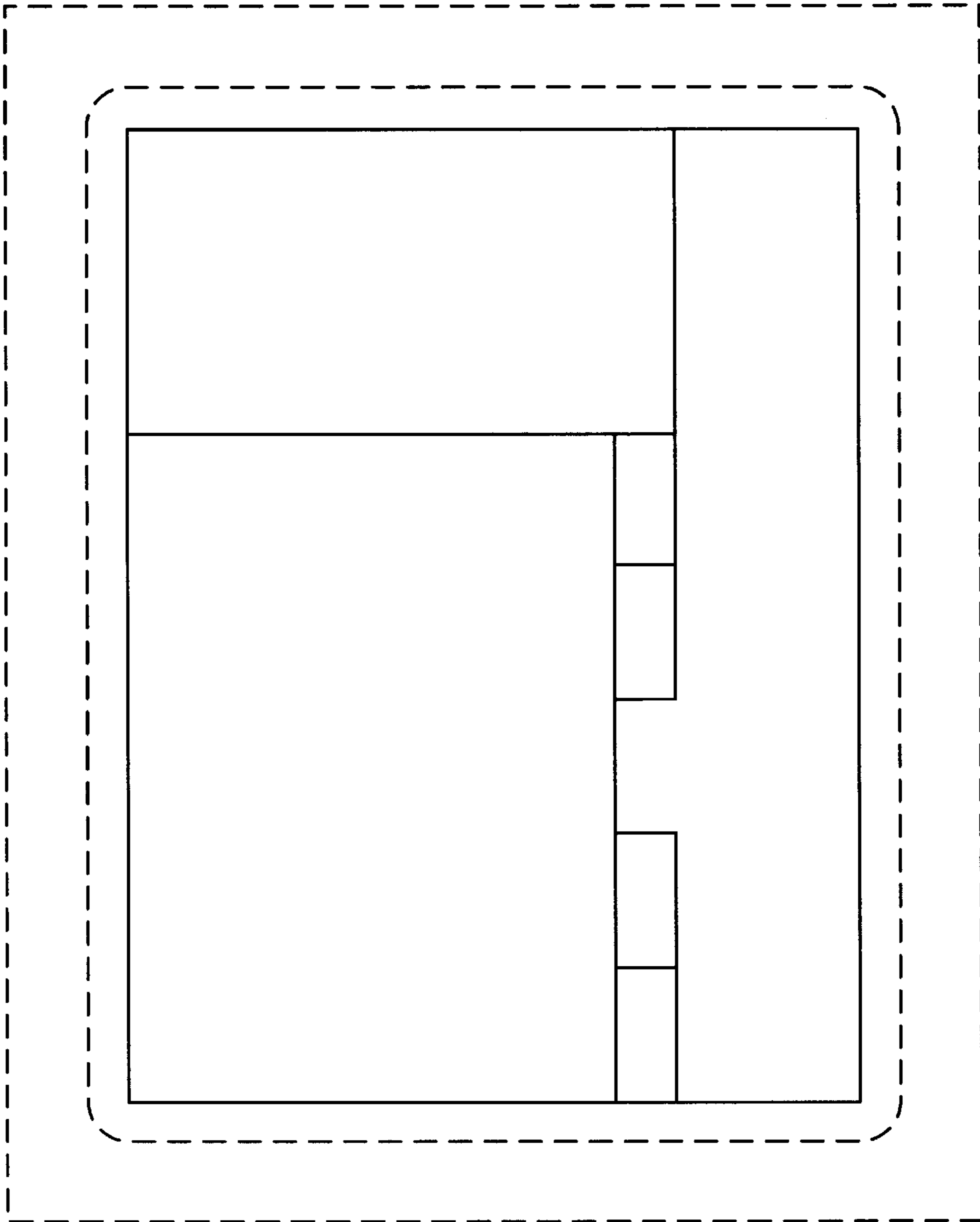

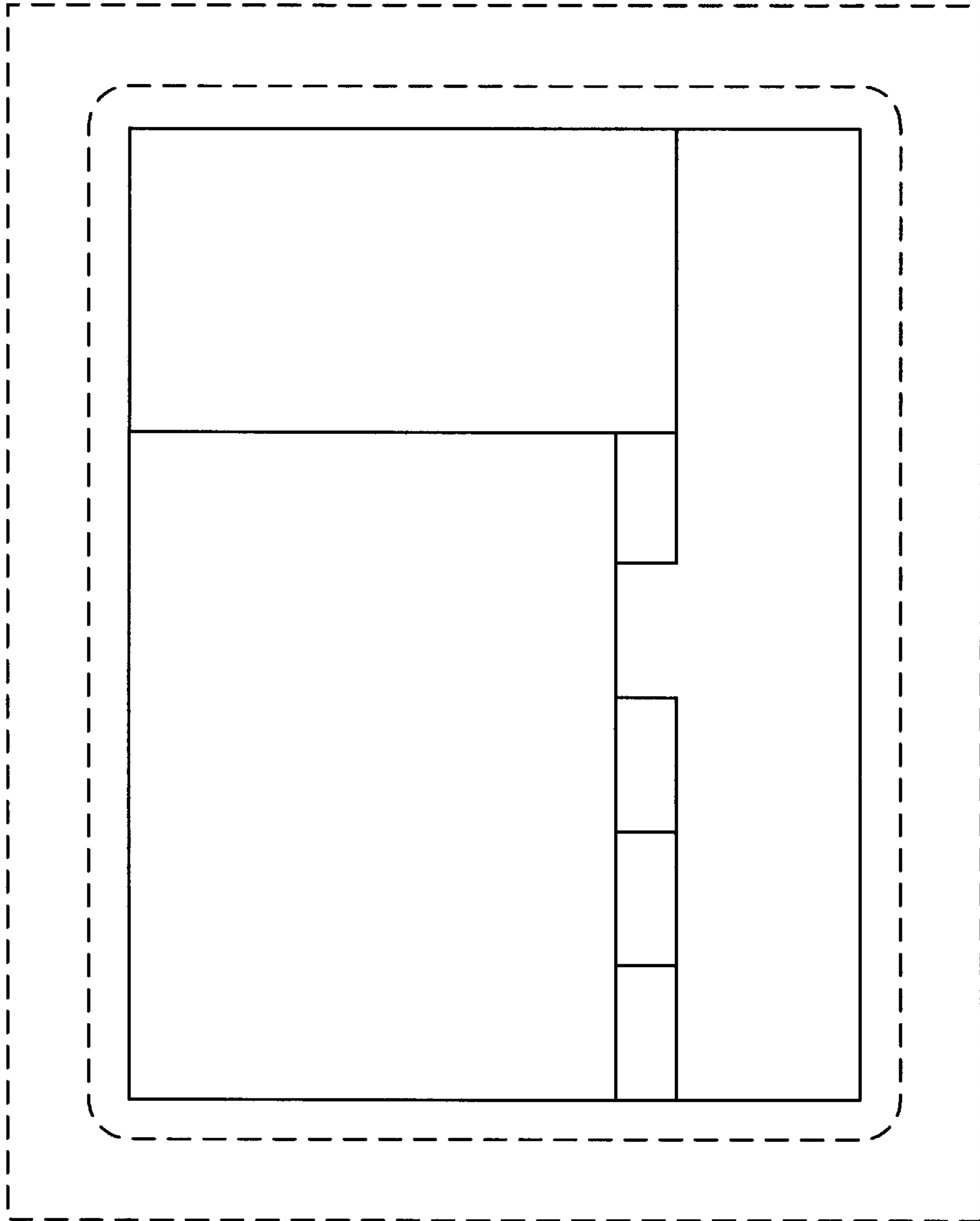

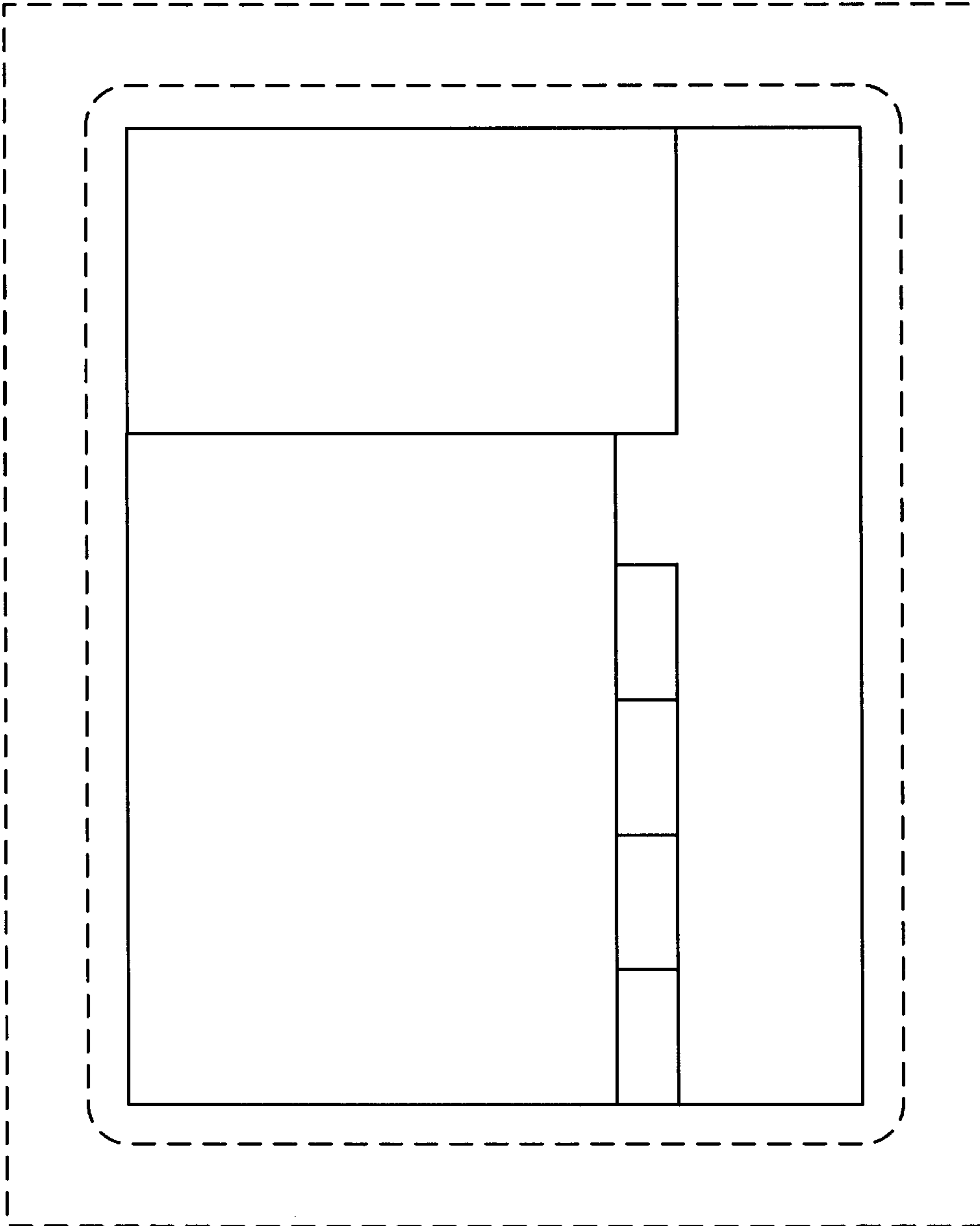

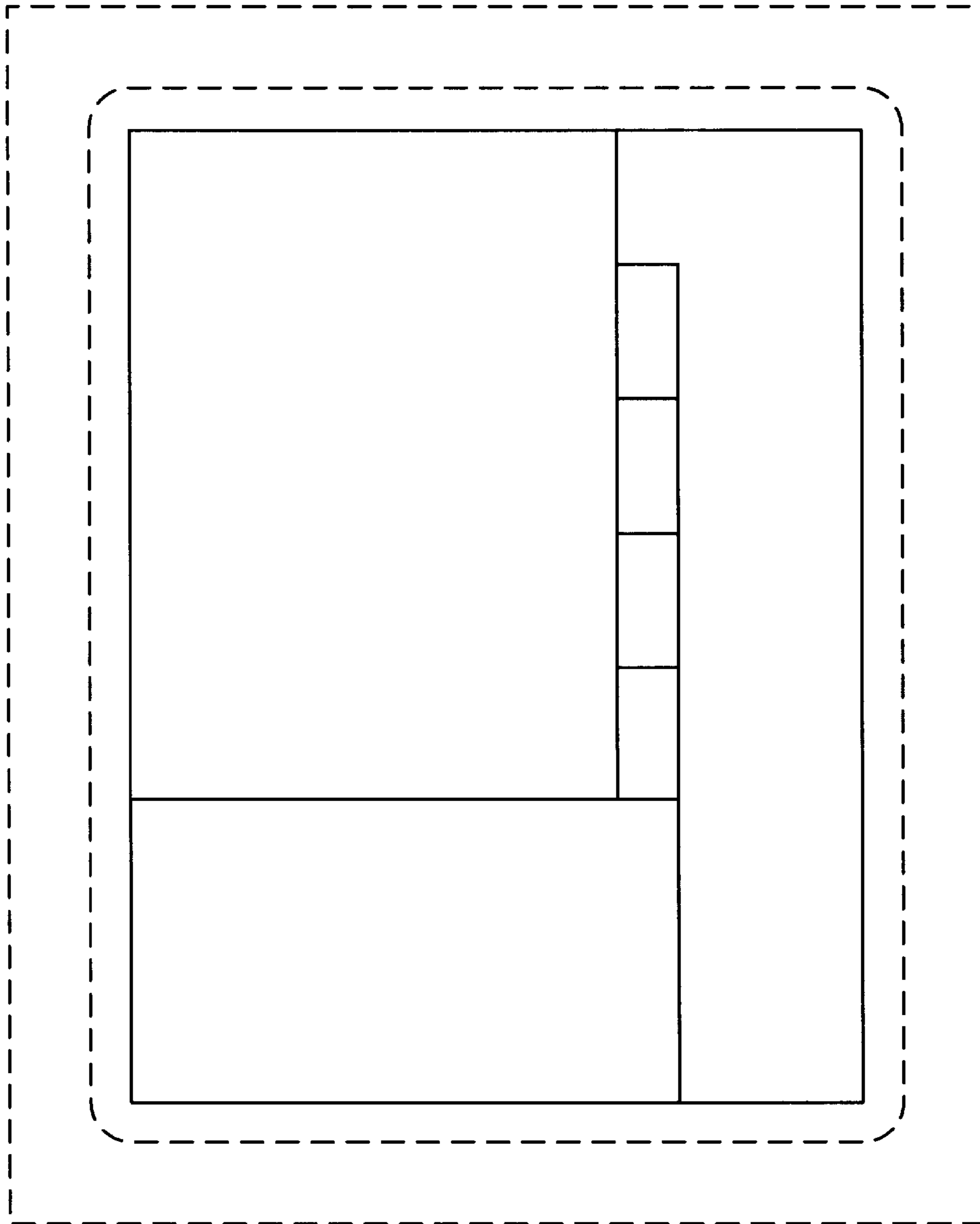

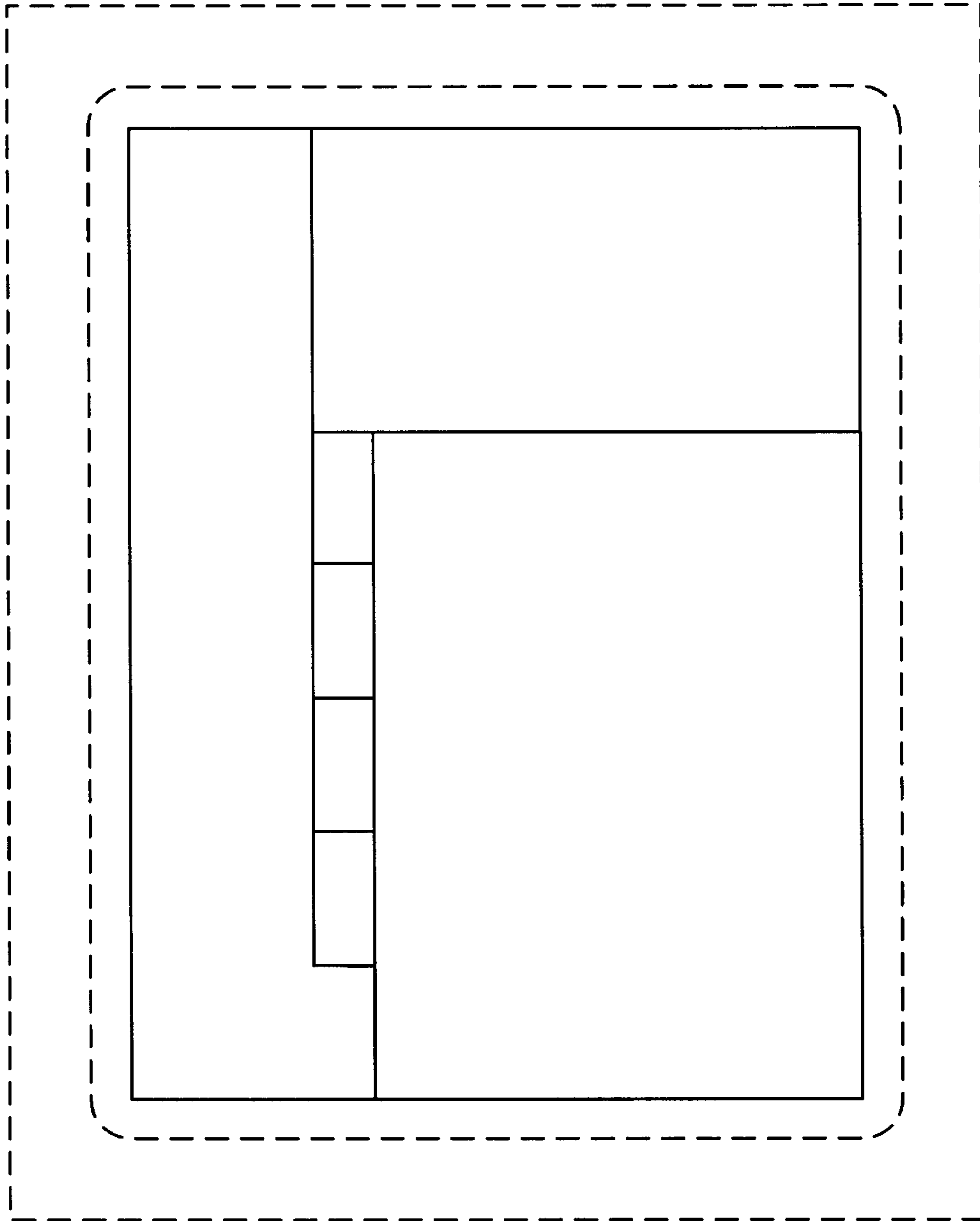

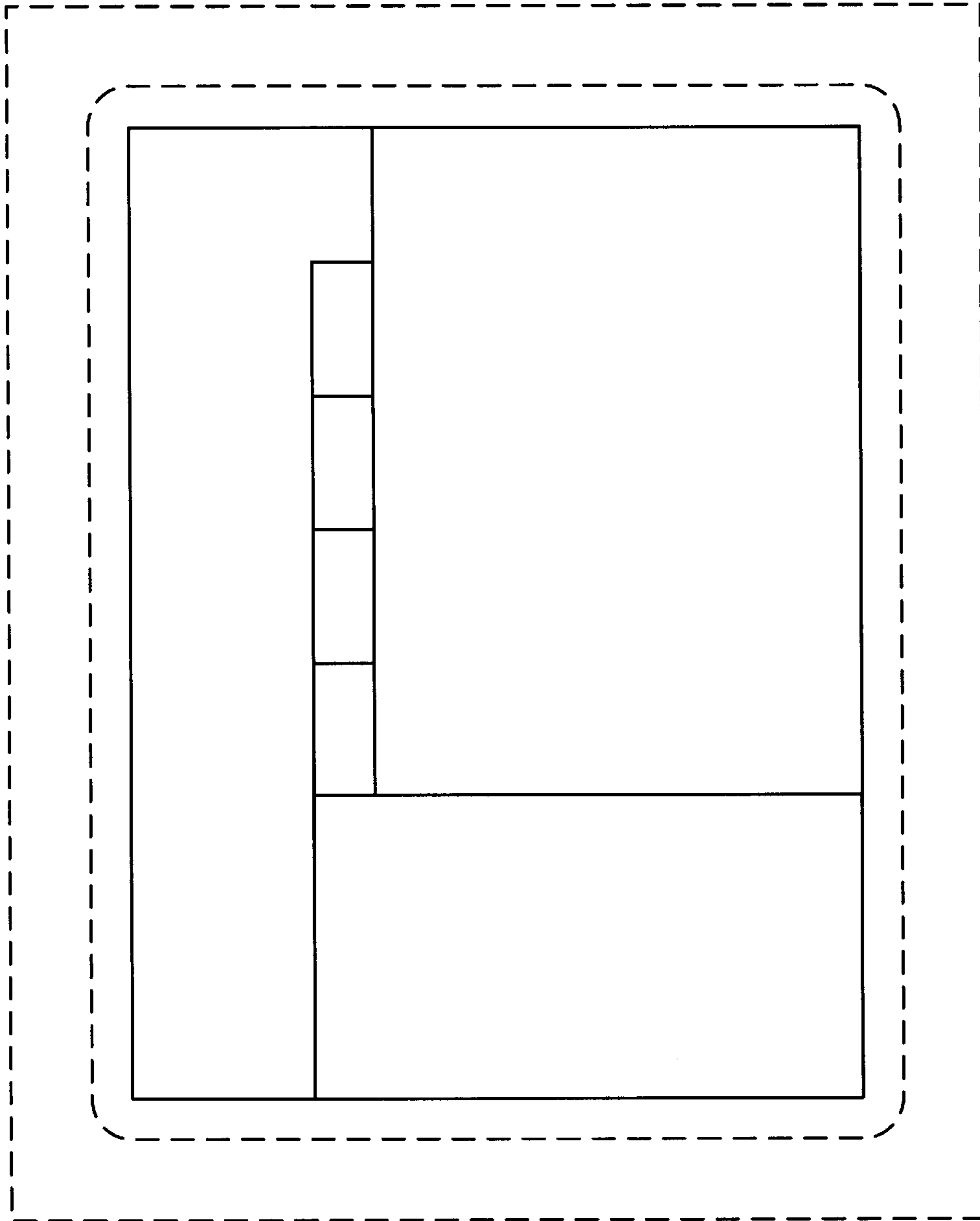

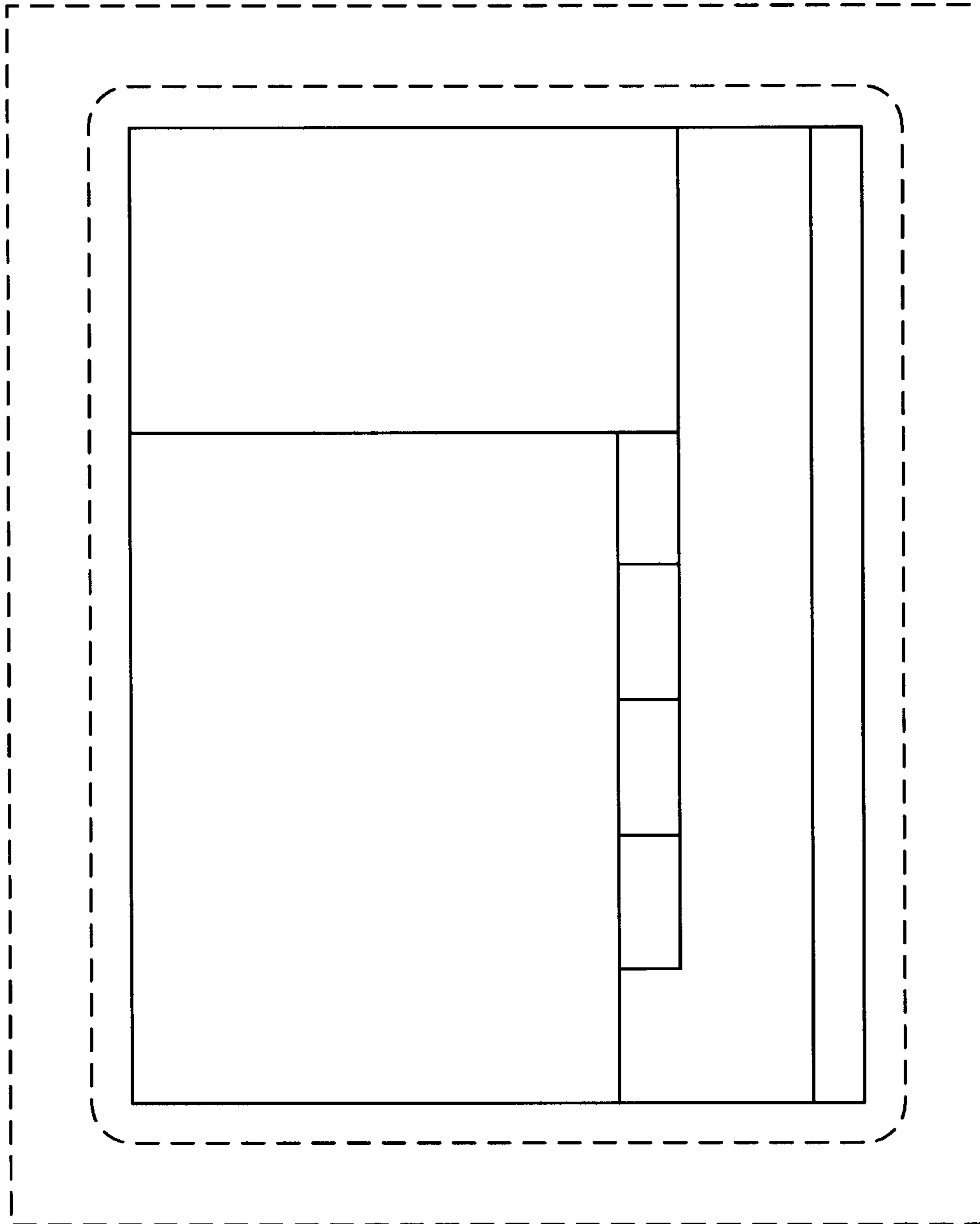
