(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a top, left, and front perspective view of an ornamental design for a shoe;

FIG. 2 is a left side elevational view of the shoe of FIG. 1; and,

FIG. 3 is a top, left, and rear perspective view of the shoe of FIG. 1.

The dash-dash-dash broken lines are included for the purpose of illustrating portions of the shoe that form no part of the claimed design. Further, the broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof.




