(57) **CLAIM**

The ornamental design for a bouncy seat, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a bouncy seat made in accordance with my new design;

FIG. 2 is a front view of the embodiment of FIG. 1;

FIG. 3 is a back view of the embodiment of FIG. 1;

FIG. 4 is a left side view of the embodiment of FIG. 1;

FIG. 5 is a right side view of the embodiment of FIG. 1;

FIG. 7 is a bottom view of the embodiment of FIG. 1.

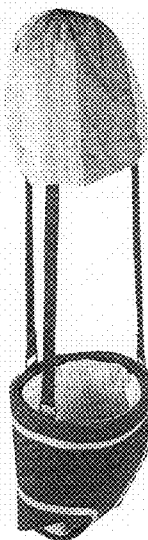

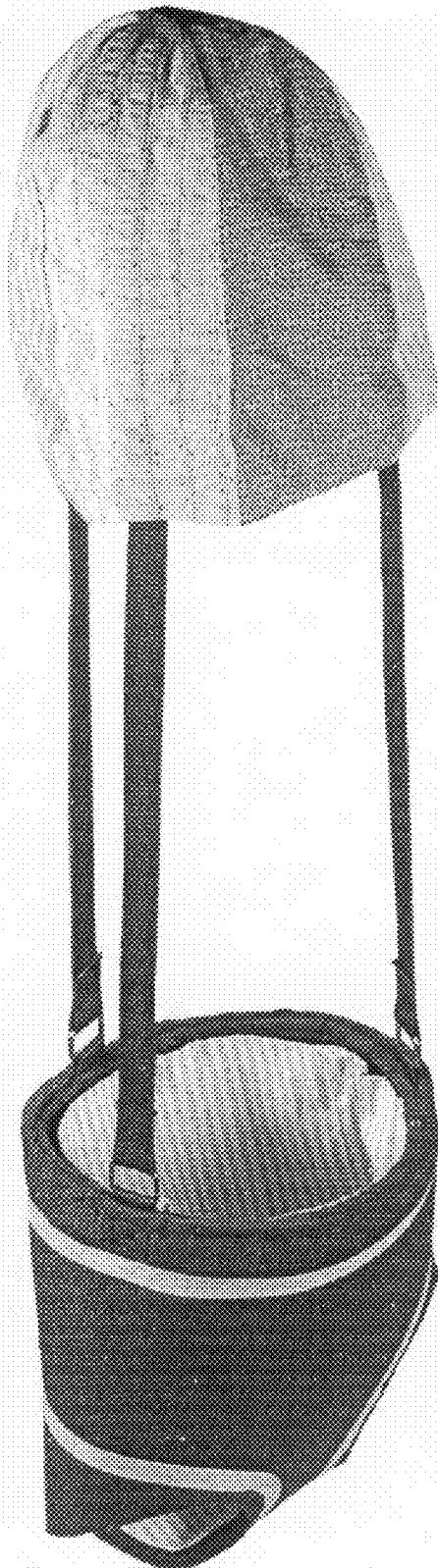

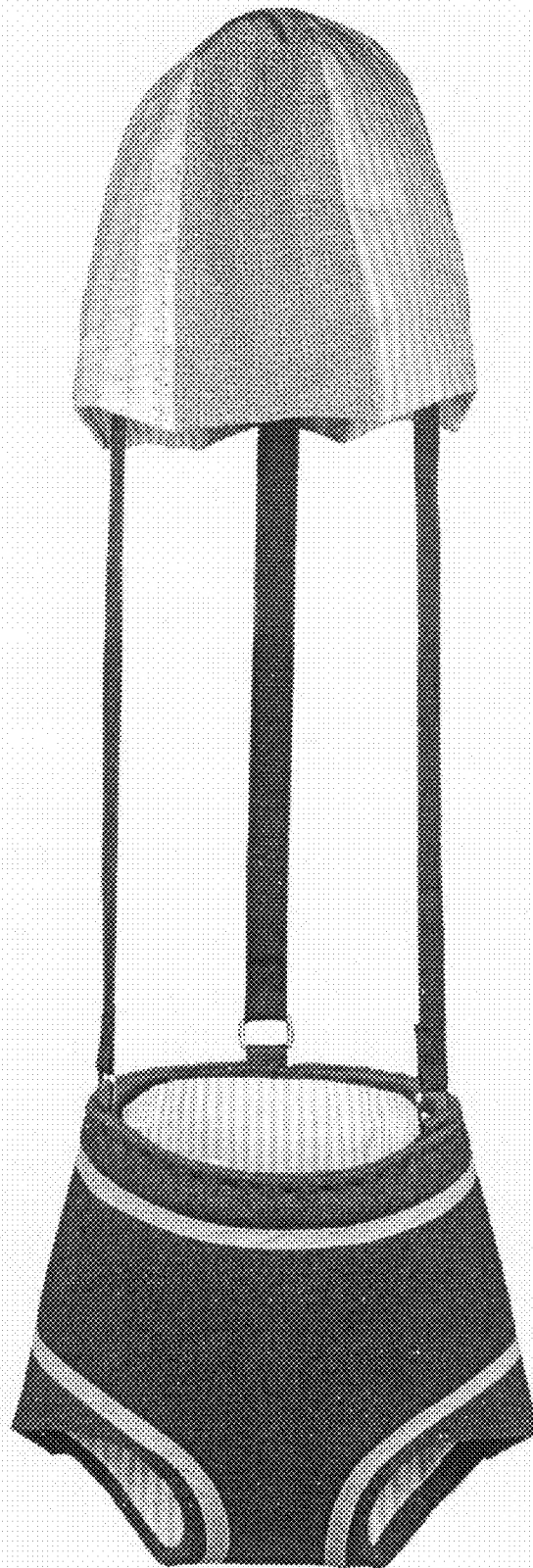

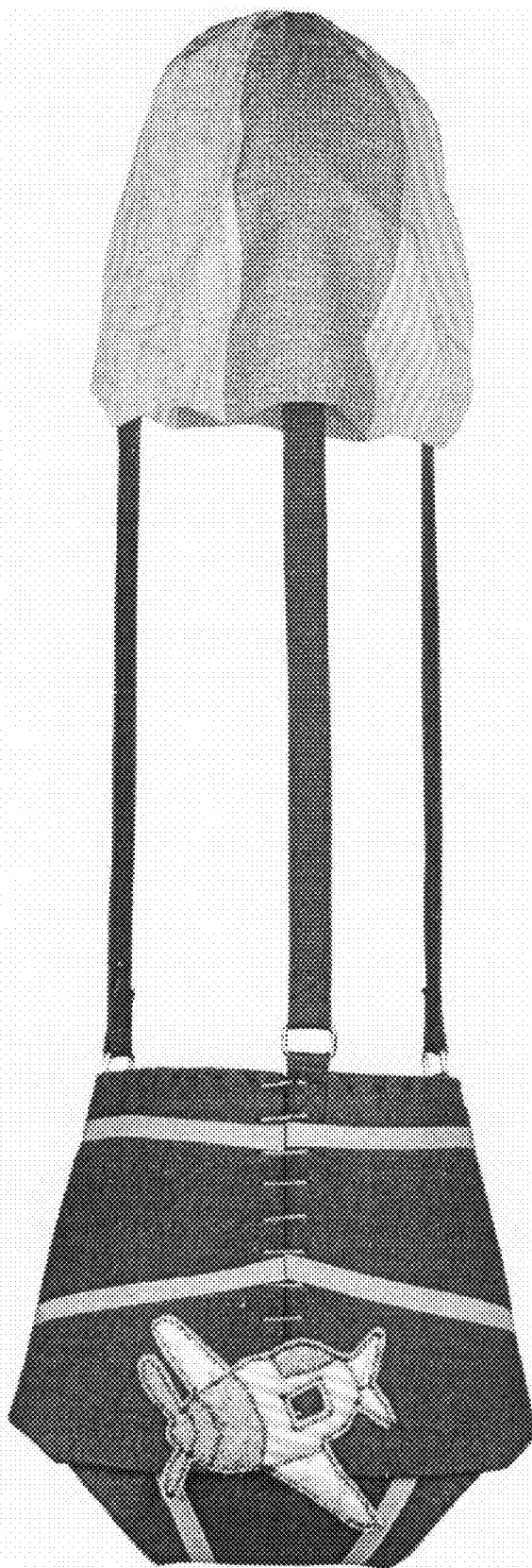

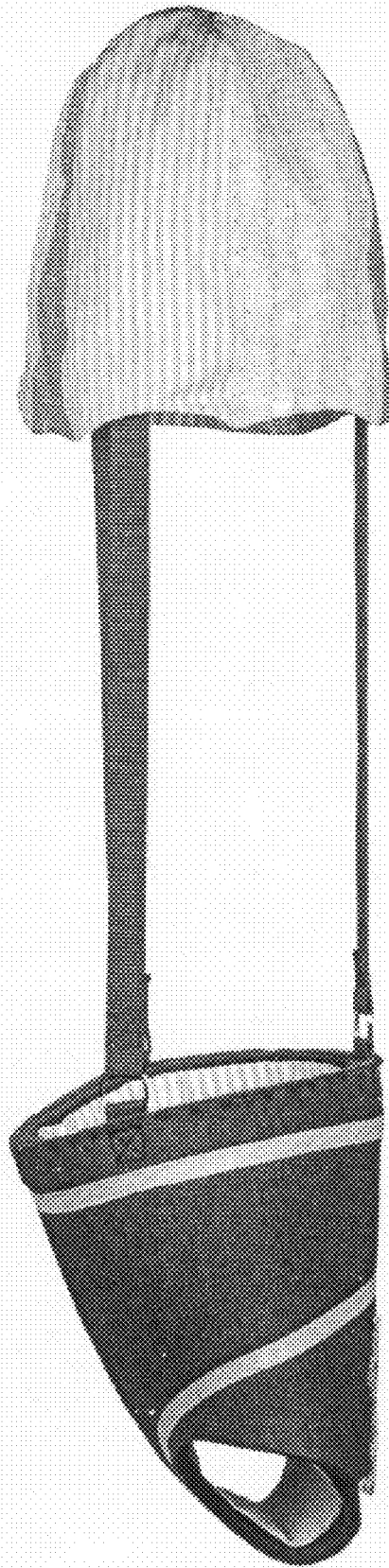

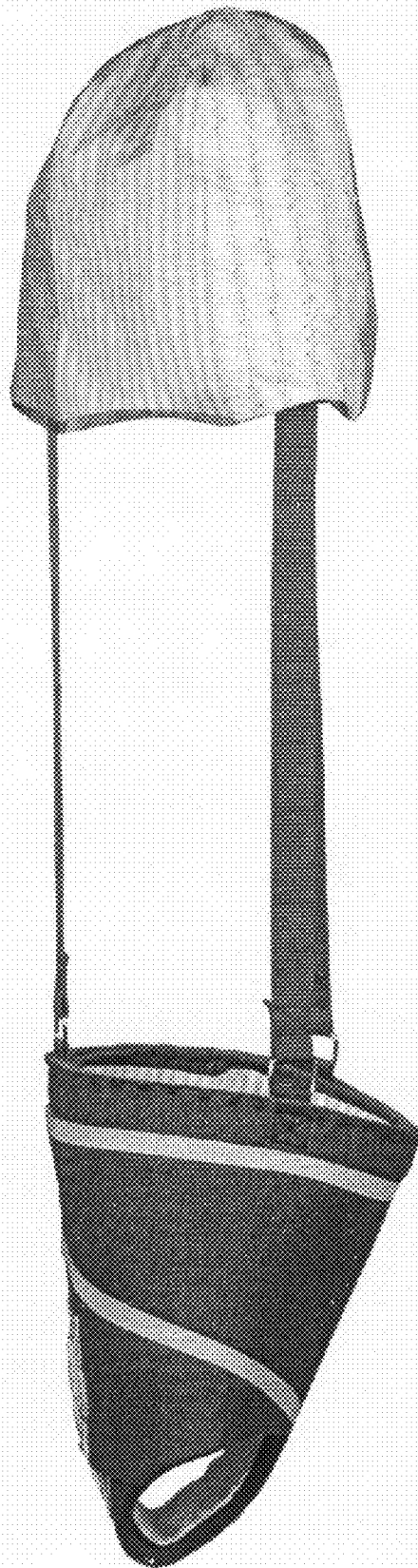

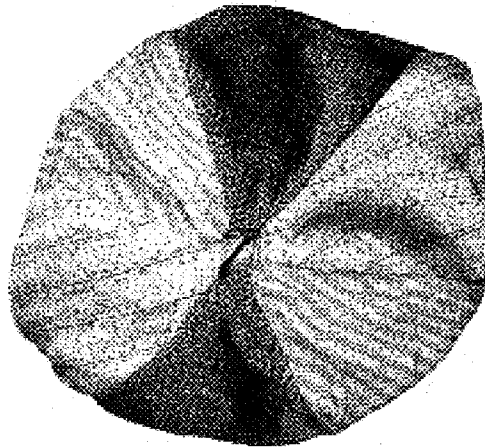
