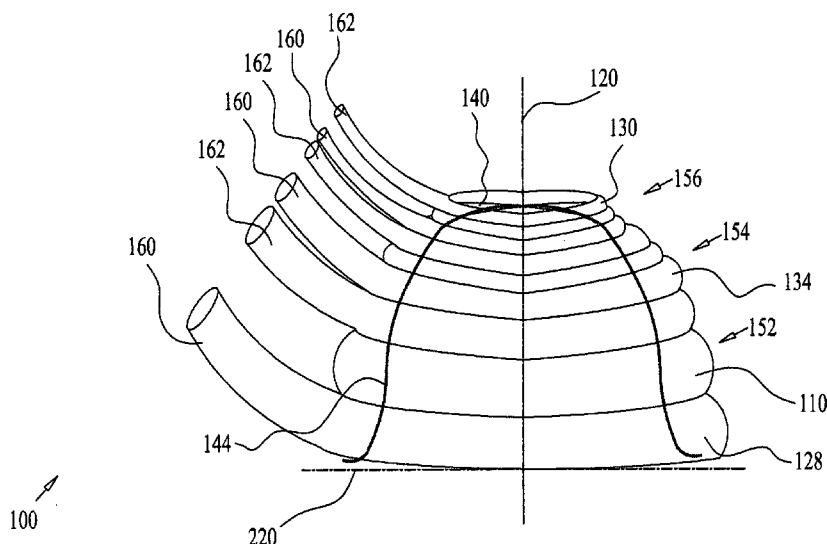

(57) Abstract: A solar receiver including at least more than one tubular array, each tubular array including a tube operative to be heated by solar radiation impinging thereon, an inlet for allowing a working fluid to flow into the tube so as to be heated therein, and an outlet for allowing the heated working fluid to flow out of the tube, each tubular array being in fluid communication with a thermal energy consumption system so as to provide the working fluid to the thermal energy consumption system.
