

(57) **CLAIM**

The ornamental design for DVD/CD player and sound generator, as shown and described.

DESCRIPTION

FIG. 1 is a front closed perspective view of a DVD/CD player and sound generator showing my new design; FIG. 2 is a front closed view thereof; FIG. 3 is a rear closed view thereof; FIG. 4 is a top closed view thereof; FIG. 5 is a bottom closed view thereof; FIG. 6 is a right closed side view thereof; The left closed side view is a mirror image and not shown. FIG. 7 is a front open perspective view thereof; FIG. 8 is a front open view thereof; FIG. 9 is a rear open view thereof; FIG. 10 is a top open view thereof; FIG. 11 is a bottom open view thereof; and, FIG. 12 is a right open side view thereof; The left open side view is a mirror image and not shown. FIGS. 1 and 7 are on a reduced scale. The broken line showing on FIGS. 1-12 is for illustrative purposes only and forms no part of the claimed design.
























