The ornamental design for a mobile phone, as shown and described.


DESCRIPTION

FIG. 1 is a front perspective view of a mobile phone showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a rear perspective view thereof.

The dash-dot broken lines and evenly spaced broken lines that are immediately adjacent to the claim, encompassing unshaded regions, represent the bounds of the claim, while all other evenly spaced broken lines are directed to environment; the broken lines form no part of the claimed design.






