DESCRIPTION

FIG. 1 is a front perspective view of a water purifier showing our new design;

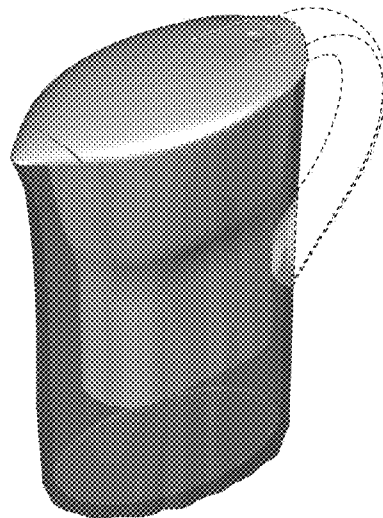

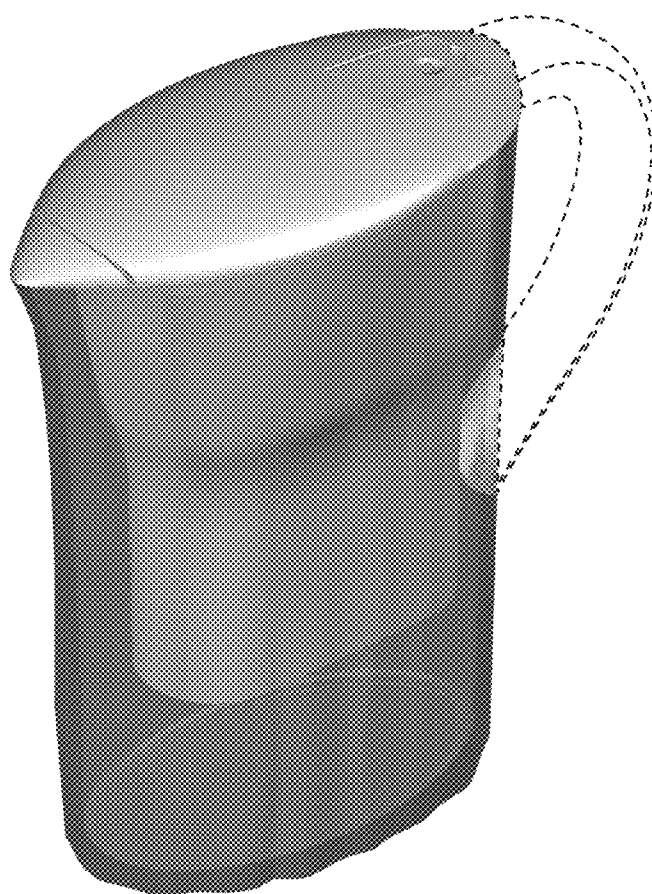

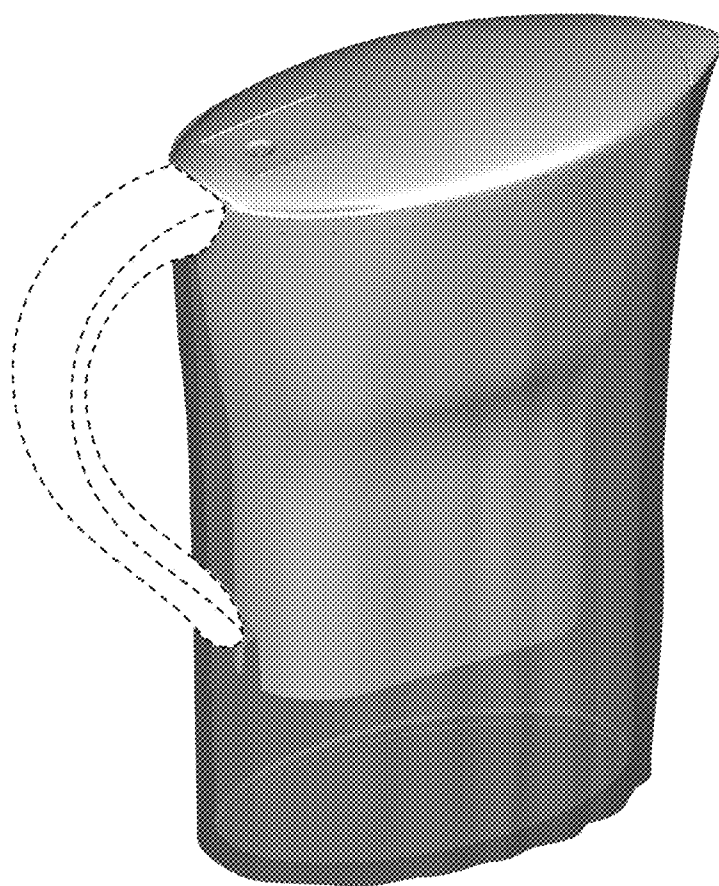

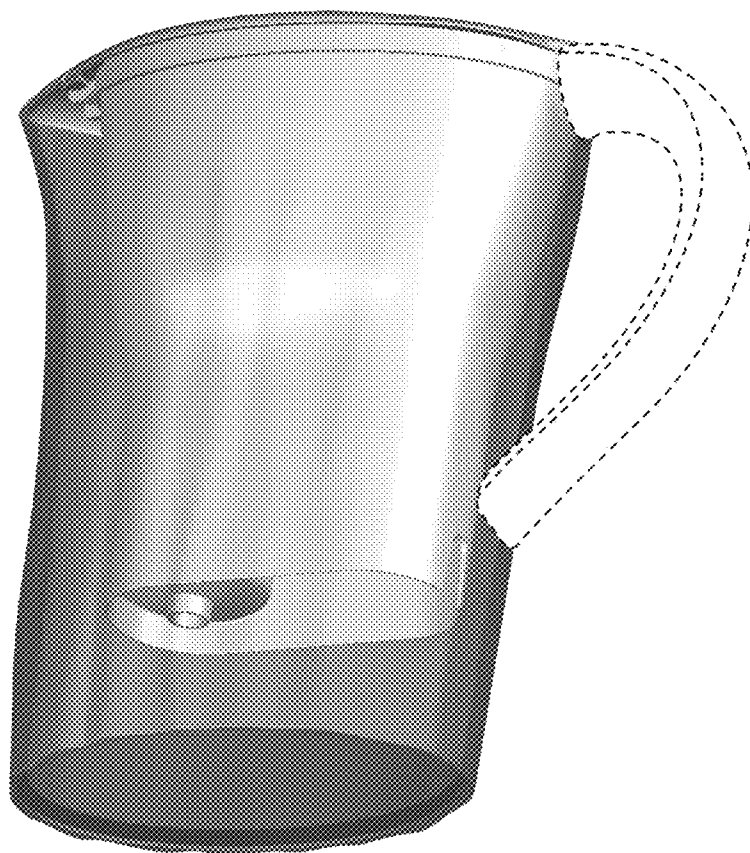

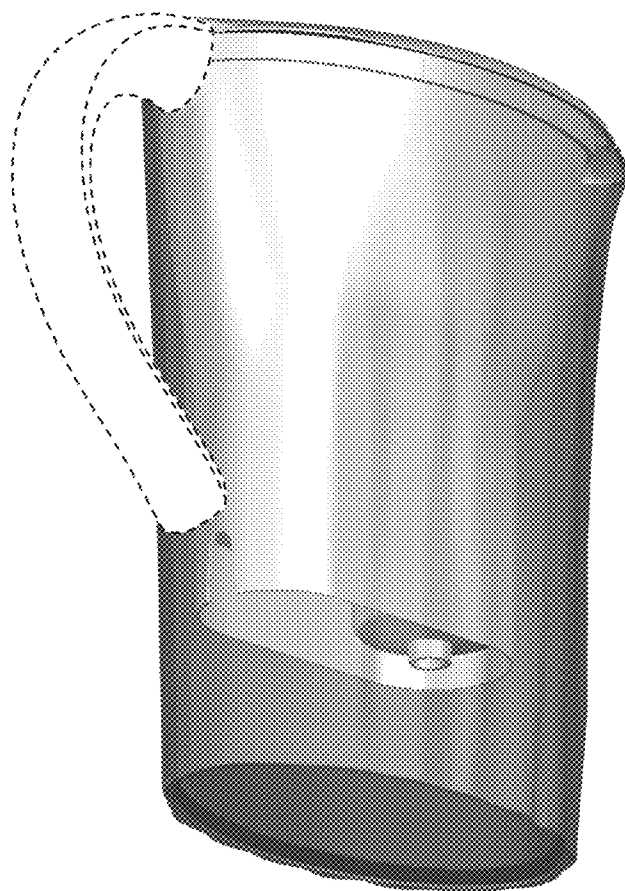

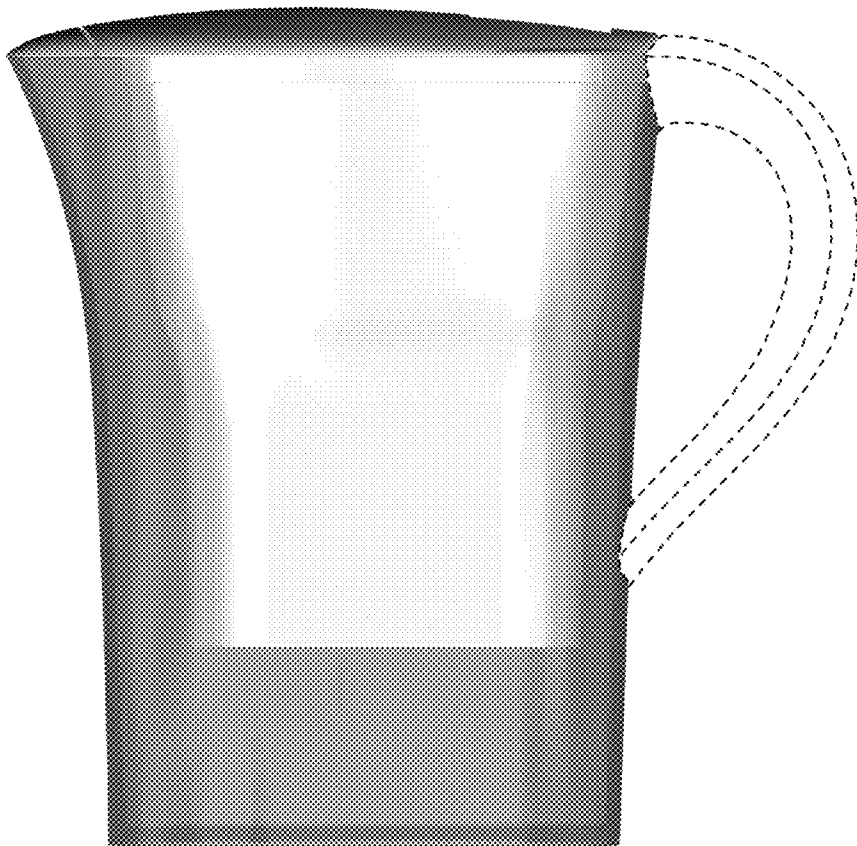

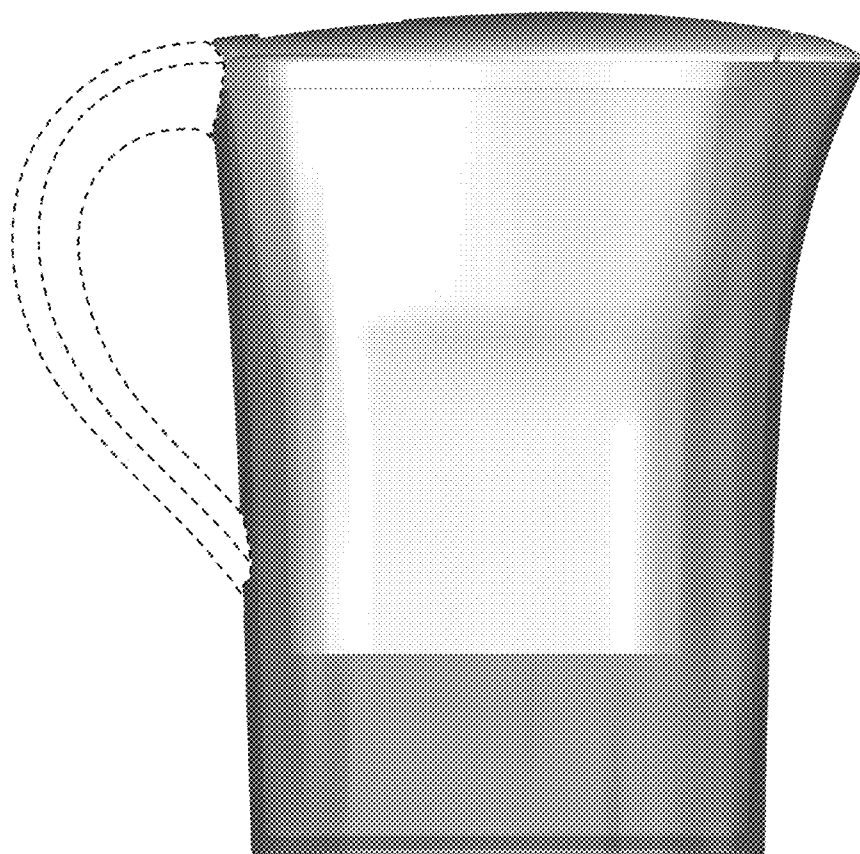

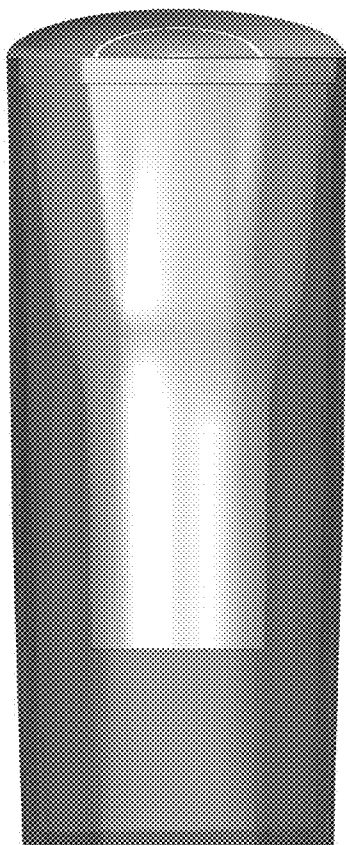

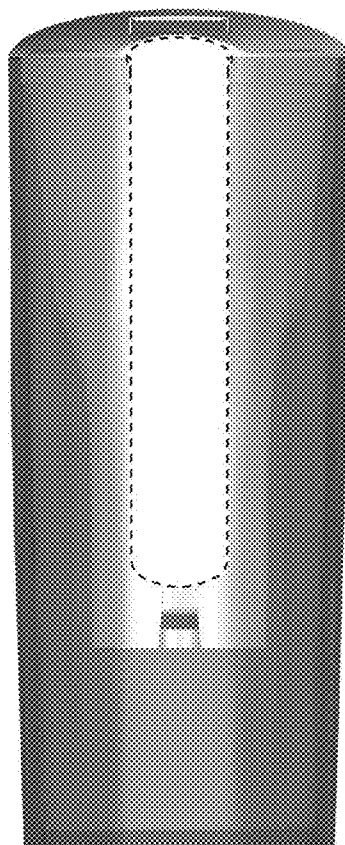

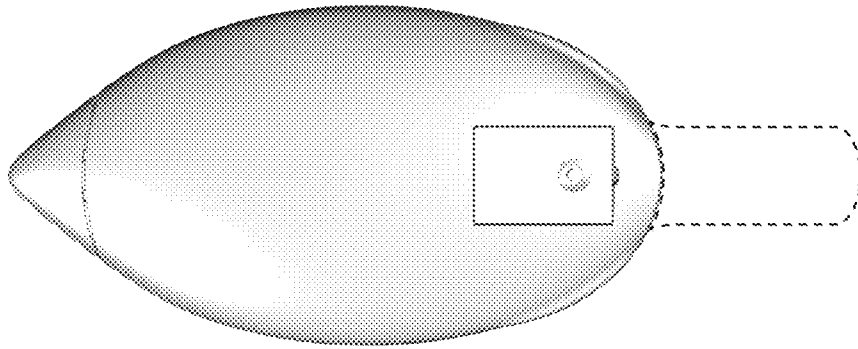
