FIG. 4 is an inner side view thereof;

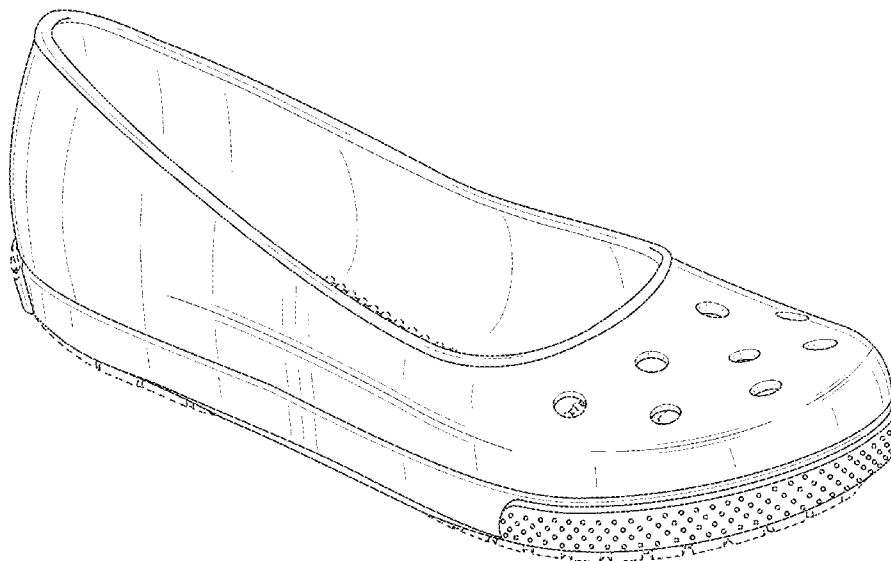
FIG. 5 is an outer side view thereof;

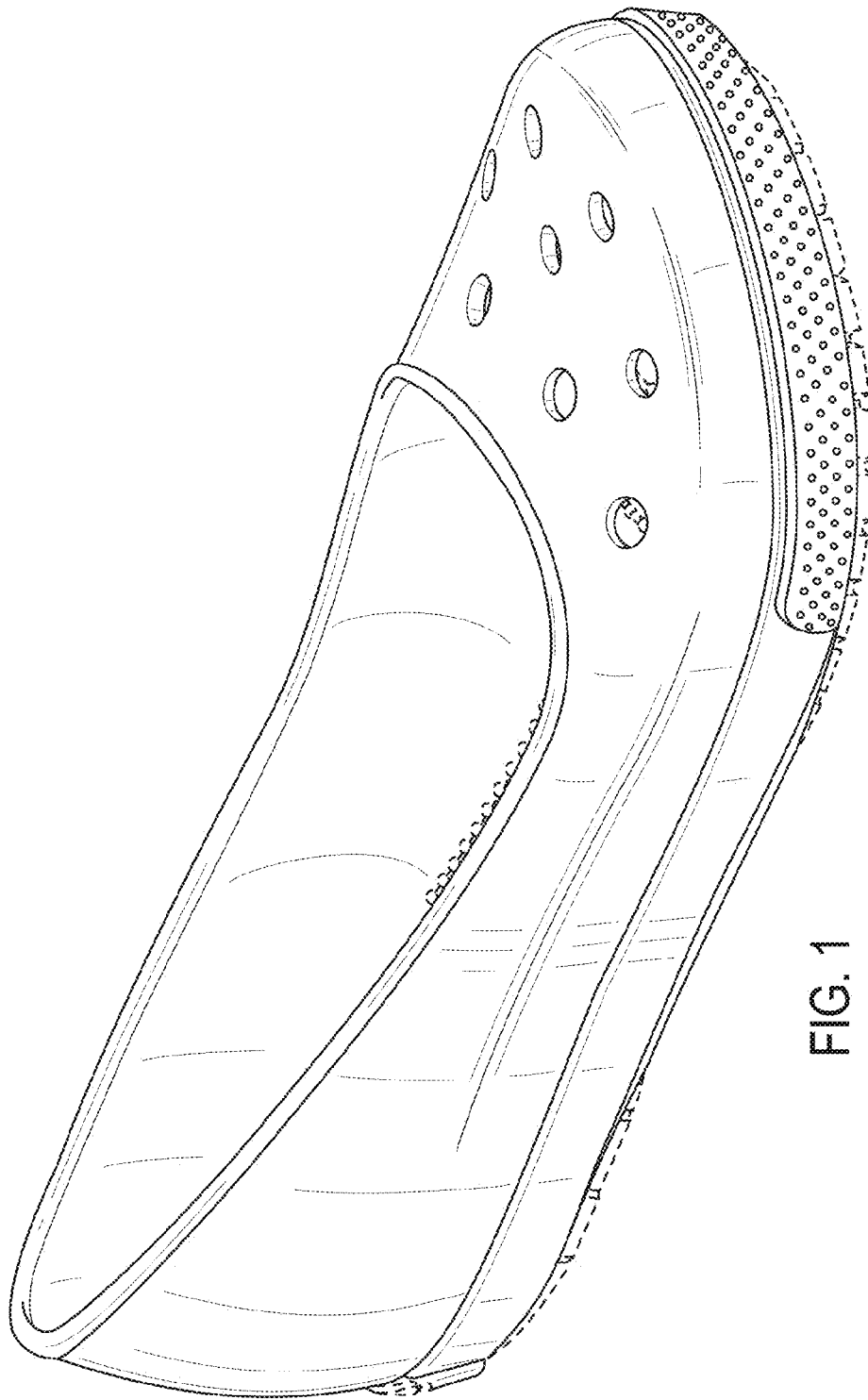

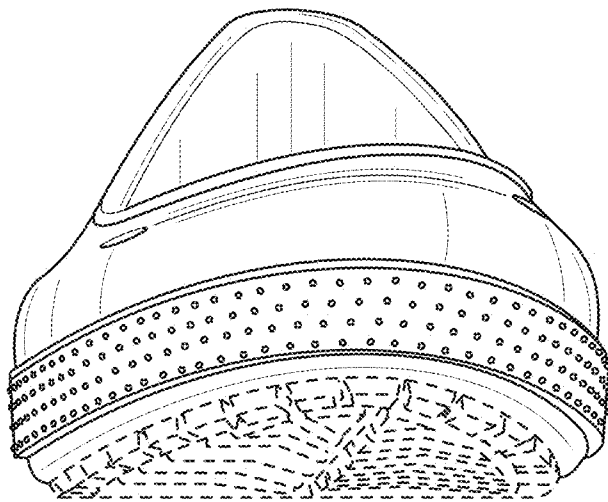

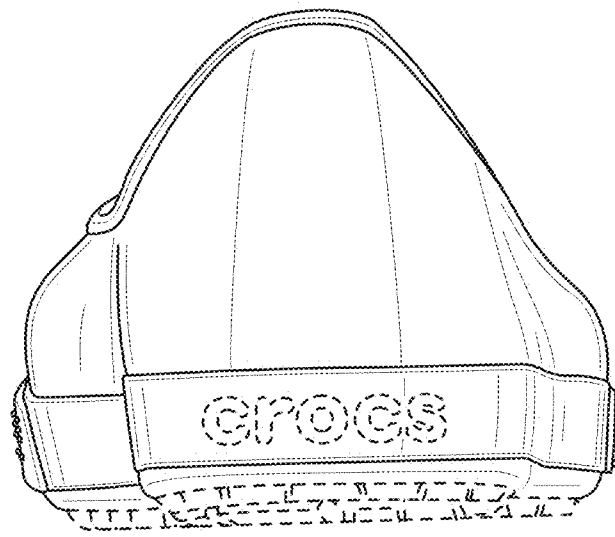

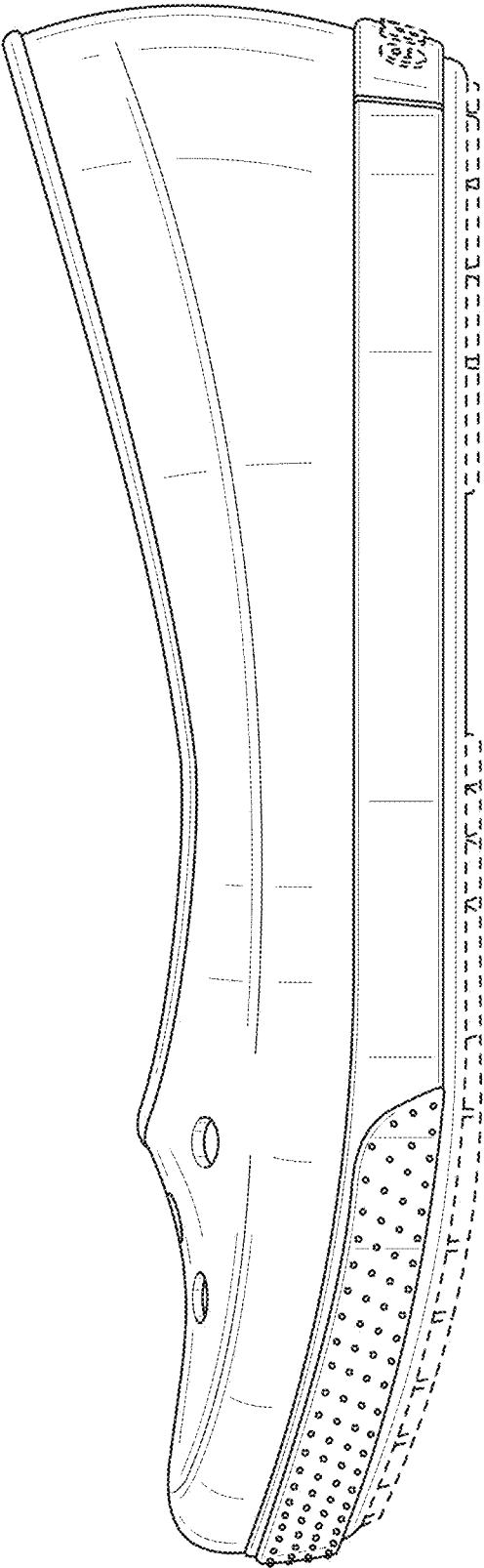

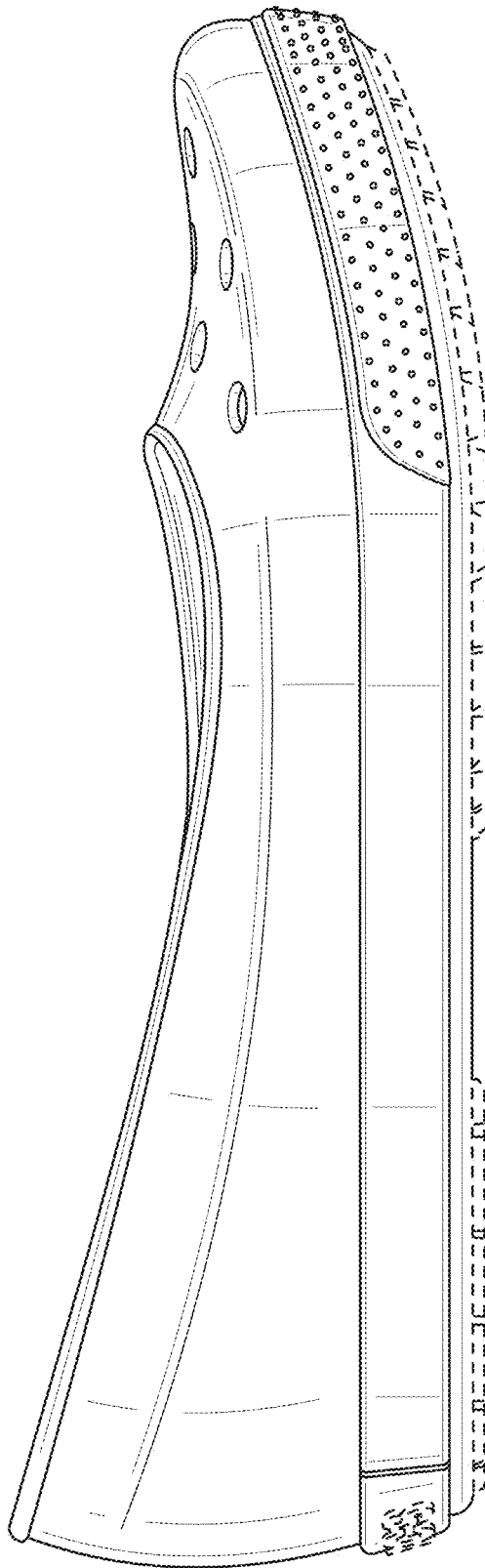

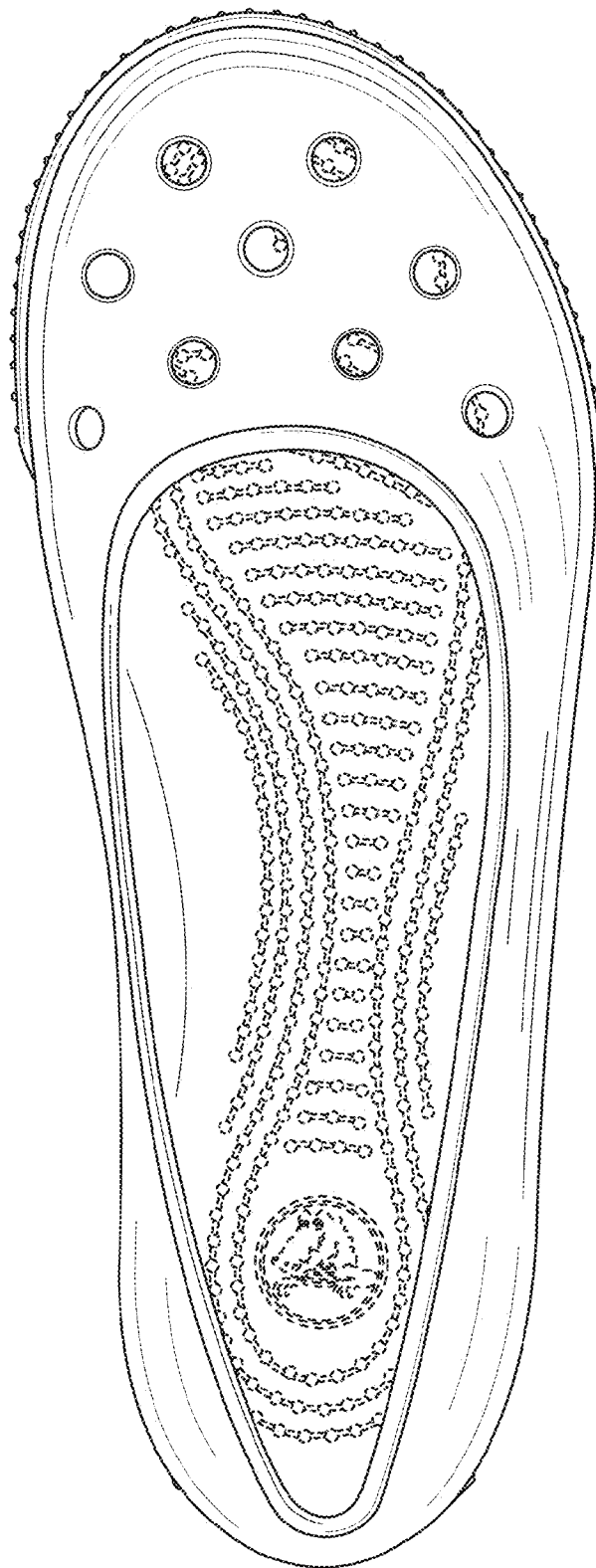

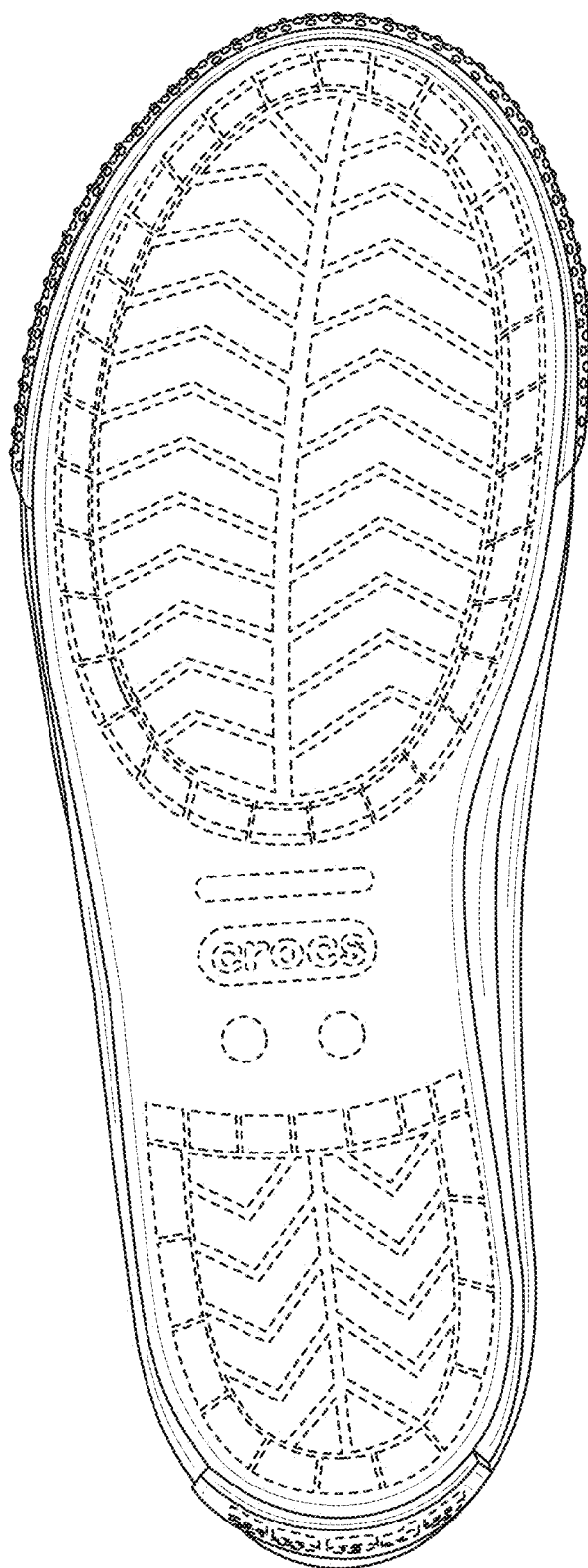
