(57) **CLAIM**

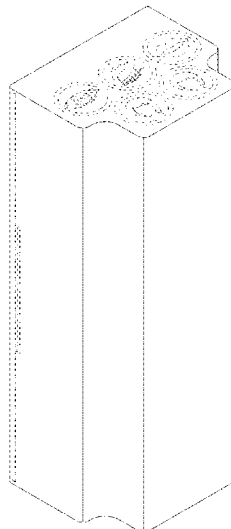
The ornamental design for a combined cosmetic case and dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a combined cosmetic case and dispenser in accordance with the present invention; FIG. 2 is a left side elevational view thereof; FIG. 3 is a rear side view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a perspective view thereof; and, FIG. 7 is a right side elevational view thereof.

The broken lines shown in the drawings depict portions of the combined cosmetic case and dispenser which form no part of the claimed design. The broken lines include component section joints, a hinge, and cosmetic indicators.

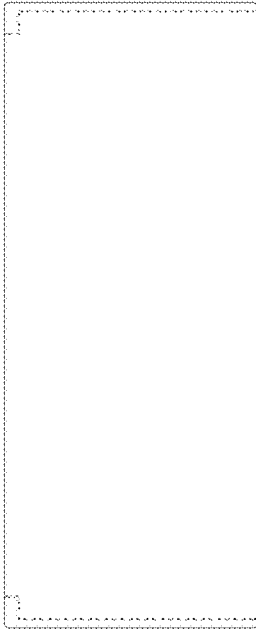

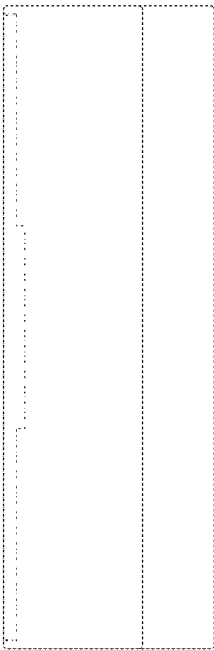

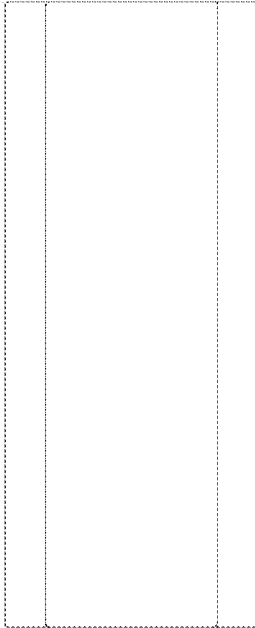

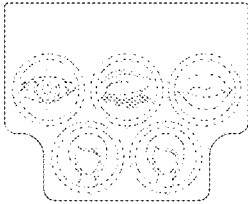

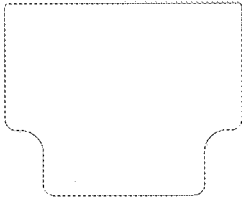

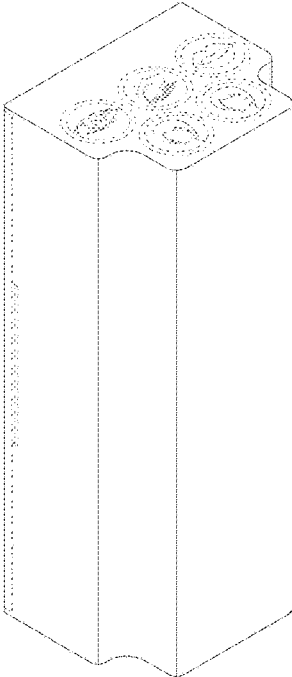

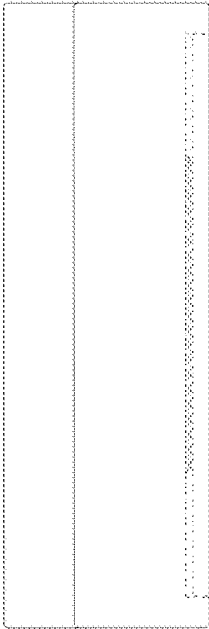
