

(57) **CLAIM**
The ornamental design for a display-coupled financial transaction card, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of our financial transaction card coupled to our display; and, FIG. 2 is a front view of our display-coupled financial transaction card shown in FIG. 1. The dashed line in FIGS. 1 and 2 near the upper portion of the display forms no part of the claimed design. All other surface(s) or portion(s) of the financial transaction card and display not shown in the figures or otherwise described in the specification form no part of the claimed design. The broken lines in the drawings illustrate perforations and form a part of the claimed design.




